I have lived in this valley for the past 10 years and moved out here to escape "city life." This is an overreach of urban sprawl and highlights the problem with annexation. There is not one single constituent you are representing besides the developer themselves. You're changing the way of life for 10's of thousands of COUNTY constituents when you represent none of us. Building a 930+ acres of more box warehouses does not fit with the community. At the last planning meeting you pushed through a large box warehouse district to be built along White Lake Parkway with the "throw you a bone" 30,000 sq ft of commercial. Residents out here don't want box warehouses. The vast majority of the jobs these warehouses will create will not be residents of Cold Springs. This is not USA Parkway or Stead. Cold Springs never has been and hopefully never will be a "industrial hub" as you stated in the last meeting. Your plan drastically changes the landscape of this valley. I am aware that the zoning of this land was previously industrial and was switched to residential. Speaking on emergency services the closest ladder truck (needed quickly in the event of a fire in one of these places) is in downtown Reno 35 minutes away. Engine 9 will be the next closest resource at 15 minutes away without asking for mutual aid from the county. You can't effectively service the land out here. I'm asking that Heinz be held to keeping this land residential to avoid ruining the landscape of the valley.

The Cold Springs annex and development of former agriculture land. Please deny any industrial complexes that are similar to what is in the rest of the North Valleys.

Cold springs was to maintain its rural charm and it was agreed to that the "Gateway to Cold Springs" would be kept with this rural feel.

This agricultural land is stated to have been zoned industrial, but I could not find that. Only various ag codes. There is need for some business , but the City of Reno and the developers have clearly taken care of that need by placing this in the center of the current Cold Springs business area. 7-11, family dollar, Truss, fire station. If that is to happen, then that is enough for the Cold Springs Valley on the east side of the Freeway 395.

Besides there not being appropriate water, there is need to widen the roads for this increased truck traffic already. The City of Reno had declared that these needs are sufficient as they currently stand, so no modifications are apparently needed per the April 18? meeting on the Cold Springs annexed property.

NO WAREHOUSE DUMPING IN COLD SPRINGS. More than what the valley can handle in terms to noise, water, recourses, roads and safety has already be locked in.

No NOISE POLLUTION. I live one mile behind the 711 area. I can CLEARLY HEAR THE TRAFFIC ON THE FREEWAY ON A REGUAL BASIS. Cold Springs is unique and the high wills surrounding the valley cause sound to be heard for long distances. It is over 3 or 4 miles to where i hear the traffic. Why should we be subjected to an additional noise producing industry?: Why is it appropriate to bring industry to cold springs when you have already destroyed access to the views and the peace that brought us out.

Every person that uses the White Lake access will be subject now to increased truck and consumer traffic and the roads are not wide enough. The White lake exit 80 was to be straightened, realigned, (proper wording), as the developer built out.

To avoid this, all new traffic for Woodland Village was to be directed to the Village Parkway Exit. This is a more open , flatter, straighter section of entrance to the lake side of Cold Springs.

We will demand

WATER used not be discharged into the lake. It raised the ground water, and floods the skeptics and water wells.

City, you should bring your own WATER IN AND PUMP IT BACK OUT to the City wastewater in Stead./

This is what is happening for development at the back of the valley, you need to keep your approvals consistent.

ROADS:

There is only the highway access. There is no way to get around this nightmare unless we use the dirt roads.

Animal control noise nuisance process means I am supposed to make at least 3 complaints and keep a diary of when there is noise(for a rooster?). Then after a year I get to take my neighbor to court and present my diary. All I am asking is can we amend the chicken ordinance to specifically outlaw roosters in the city limits. The Life Church is more than a church. It's turned into a 7-day business. The church traffic on any given Sunday overwhelms both Rio Wrangler and Yee Haw. The high school traffic overwhelms Rio Wrangler at Yee Haw and Steamboat for two hours each day. It's nearly impossible to enter onto Rio Wrangler from Yee Haw during those periods. Both of these intersections are at a point of failure during the peak periods of these facilities. The City has allowed, and put faith, into reports generated by the developer. I don't agree with the developer indicating that additional traffic from another school at that location won't affect traffic. Traffic already comes to a complete stop on Rio Wrangler and backs up at least a half mile. Congestion is expected during peak periods, but not to the point that the residences cannot get into or out of their neighborhoods.
