Good morning, members of the City of Reno. My name is Ana Barrera, and I am a student at Procter R. Hug High School.

Today, I want to address an important issue concerning the roads in Reno, specifically Freeway 395. One major concern is the rough and uneven condition of the freeway, particularly starting at the McCarran entrance heading southbound in the far-right lane. The road remains bumpy and shaky until passing the Sacramento Freeway 80 exit.

This poor road condition affects drivers significantly. At freeway speeds, the uneven surface causes vehicles to shake, making it difficult to drive smoothly. I've heard from several people who have similar complaints, not just about the freeway but also about main roads that have potholes. I am very opposed to this. Our shelters are full. There is nowhere for our unhoused siblings to go. What supports are in place for them? What public assistance is truly available for people who don't have family, don't have jobs, don't have guaranteed housing i.e. owning a house or living with family? I personally have been unemployed for over 2 months and the only reason I'm able to survive is because of my mother's generosity. If it wasn't for her, I would be unhoused. 59% of Americans are one missed paycheck away from homelessness, and yet there are no supports for when that happens. They have nowhere to go. We need to create more resources and places for people to go when they run into trouble instead of policing behavior that has no alternatives. Please help build more shelters

and provide more public assistance in the face of hardship instead of causing more trauma and harm to people that just need help and empathy. I've spent the majority of my working life working in housing, and most of it in homeless shelters. Shelters are overrun, shelter workers are overworked, and there's no supports from the city or state for the work, only backlash and further policy promoting that harms the community. The unhoused people of our city deserve respect and empathy and help.

I am emailing in regard to agenda items E.1-E.4 to be discussed during the Wednesday, December 11th, 2024, Reno city council meeting. As a 18 year resident of reno/sparks citizen, I am in extreme opposition of these agenda items. Defining sitting, lying, sleeping, or camping in public spaces as "Offenses against public peace" and therefore illegal is appalling. This is a direct attack on human rights, and all people regardless of their situation deserve humanity. Enacting these ordinances ensures that a large population of houseless reno citizens are left with nowhere to sleep, and absolutely nowhere to go. All of our shelters are full, and nearly all of our low income housing units are filled to capacity, and incredibly difficult to access in the first place. These unnecessary agenda items will have a negative impact on already strained resources. Using our city's facilities to imprison our citizens trapped in unfortunate circumstances is counterproductive and causes unnecessary strain on our law enforcement and we do not have the resources to manage this. Homelessness is not a choice, and is most often a result of unforeseen and incredibly unfortunate circumstances in peoples lives. For example, at the end of October of this year, the Lake Mill Lodge was condemned due to bio-hazardous conditions, leaving 123 households displaced. The city of reno has been unable to help a majority of these people, leaving them sleeping on the streets. Criminalizing homelessness is not the answer, and we as a community must do better for our citizens. I request that the Reno City Council please take these things into consideration before moving forward.

Along with the Nevada Housing Justice Alliance and Faith in Action Nevada, I write to support a reconsideration, and overturn, of the City of Reno laws criminalizing homelessness.

December 10 was Human Rights Day, marking the United Nations' passage of the Universal Declaration of Human Rights in 1948. I quote a clear statement from those principles that applies directly to our unhoused community members:



*"[All members of the human family have] the right to a standard of living adequate for . . . health and well-being . . . , including food, clothing, housing and medical care, and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond [one's] control."*

Joined with many Reno clergy, I uphold this principle as an interfaith minister, grounded in the work of compassion. I know you uphold it as well, as Human Rights Commissioners. Let us live up to our calling to promote actions that support the basic human rights of the most vulnerable among us-- rather than take them away.

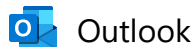

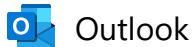

As a lifelong reno/sparks citizen, I am in extreme opposition of these agenda items. Defining sitting, lying, sleeping, or camping in public spaces as "Offenses against public peace" and therefore illegal is appalling. This is a direct attack on human rights, and all people regardless of their situation deserve humanity. Enacting these ordinances ensures that a large population of houseless reno citizens are left with nowhere to sleep, and absolutely nowhere to go. All of our shelters are full, and nearly all of our low income housing units are filled to capacity, and incredibly difficult to access in the first place. These unnecessary agenda items will have a negative impact on already strained resources. Using our city's facilities to imprison our citizens trapped in unfortunate circumstances is counterproductive and causes unnecessary strain on our law enforcement and we do not have the resources to manage this. Homelessness is not a choice, and is most often a result of unforeseen and incredibly unfortunate circumstances in peoples lives. For example, at the end of October of this year, the Lake Mill Lodge was condemned due to bio-hazardous conditions, leaving 123 households displaced. The city of reno has been unable to help a majority of these people, leaving them sleeping on the streets. Criminalizing homelessness is not the answer, and we as a community must do better for our citizens. I request that the Reno City Council please take these things into consideration before moving forward.

I am emailing in regard to agenda items E.1-E.4 to be discussed during the Wednesday, December 11th, 2024, Reno City Council meeting.

As a Reno / Sparks citizen, I am in extreme opposition of these agenda items. Defining sitting, lying, sleeping, or camping in public spaces as "Offenses against public peace" and therefore illegal is appalling. This is a direct attack on human rights, and all people regardless of their situation deserve humanity. Enacting these ordinances ensures that a large population of houseless Reno citizens are left with nowhere to sleep, and absolutely nowhere to go.

All of our shelters are full, and nearly all of our low income housing units are filled to capacity, and incredibly difficult to access in the first place. These unnecessary agenda items will have a negative impact on already strained resources. Using our city's facilities to imprison our citizens trapped in unfortunate circumstances is counterproductive and causes unnecessary strain on our law enforcement and we do not have the resources to manage this.

Homelessness is not a choice, and is most often a result of unforeseen and incredibly unfortunate circumstances in peoples lives. For example, at the end of October 2024 - the Lake Mill Lodge was condemned due to bio-hazardous conditions, leaving 123 households displaced. The City of Reno has been unable to help a majority of these people, leaving them sleeping on the streets. Criminalizing homelessness is not the answer, and we as a community must do better for our citizens.

I request that the Reno City Council please take these things into consideration before moving forward.
