Experienced Resident Engineer on many projects both conventional design/bid/build to design/build and involving a wide variety of new construction, rehabilitation, bridge construction and bridge widening, asphalt and concrete paving on both urban and rural facilities. Responsible for administering a \$300 million construction program and \$45 million maintenance program for Nevada DOT and a \$350 million transportation program for Guam Department of Public Works. David Titzel is also experienced in claims resolution and defense from the owner's perspective.
