Planning Commissioners,

I have several concerns about the proposed Nevada Energy transmission line on Peavine.

There are two possible routes for the power line on the north side of Peavine Mountain. Evidently the power line route has been tentatively relocated to avoid the Stone Gate development area. Upon reading the massive amount of material regarding this proposed transmission line, I do not see any approval from the Forest Service to relocate the power line. The relocation will result in the removal of trees, and it is my perception the Forest Service wants to limit the number of trees removed to construct the power lines. If there is no documented approval of the Forest Service for the relocation of the power line, then it does not make sense to approve the plan with the option of relocating the power line.

There is no letter in the supplied materials signed by Stan Lucas indicating his intentions to grant an easement for the power lines to cross his property. If the power line project is approved by the City of Reno, it possibly gives Stan Lucas an opportunity to ask for more money for the easement on his property. This project should not be approved until the Planning Commission has looked at the letter from Stan Lucas, and if his letter might be an obstacle in Nevada Energy being able to construct the power line.

The undergrounding of the power line is a good idea, although very expensive. Nevada Energy could apply for a grant to help pay for some, or all, of the cost to underground the power line. If this is possible, please consider placing in the conditions of approval for Nevada Energy to apply for a grant to pay for part, or all, of the cost of undergrounding the power line.

I would like the following public comment entered into the record at the City of Reno Planning Commission Meeting on June 6, 2024 at 6:00pm, opposing LDC24-00015 (NV Energy Utility Corridor) for proposed action at this meeting:

"I am a life-long resident of Washoe County, and I volunteer and recreate in the Humboldt-Toiyabe National Forest located in Nevada on the western slope of Peavine between Verdi and Cold Springs. This specific area contains a tiny and unique alpine forest landscape that is rare for Nevada, and Reno residents and visitors get to enjoy its beauty and recreational resources. Within this forest area is a trail system commonly known as the "Peavine Maze" containing many special motorized multiple-use trails that is enjoyed by thousands of motorized, non-motorized, equestrian and pedestrian recreators every year. Multiple volunteer organizations have also invested several hundred-thousand dollars in public and private funding, as well as thousands of volunteer hours, in maintaining and expanding this trail network utilized by so many.

The placement location of the utility corridor proposed by LDC24-00015 will run right through the middle of and destroy many natural and recreational resources beloved by the public. This proposed deforestation to install a power line here will cause significant negative visual impact to this rare Nevada forest area, destroying many beautiful pine trees, aspen groves and wildlife habitat. It will also destroy several trails that that Reno residents and visitors have been enjoying for decades which many volunteer organizations work on and fund to maintain.

Please do not scar this precious area, and consider other alternative placement for this utility corridor that will not destroy recreational resources that are heavily invested in by the Reno community.

Planning Commissioners,

This is a very complicated project, as I'm sure you are aware. From my perspective, though, it seems like it is not complete - or the phrase that is used, "It's not quite baked."

1) In the staff report, under Analysis: Easements: on page 3, it is stated that "Stan Lucas, provided an owner affidavit to allow pursuit of this request while the details of the easement are negotiated."

How can the project be approved prior to the easement being granted? Nor is there an affidavit that I could see in the packet. That's a grandiose gesture that he is allowing the request to proceed; however, how does that give the City of Reno the power to approve a project with no easement agreed upon?

2) On May 30, 2024 this link shows that property was purchased by NV Energy - interesting that they can pay \$12.5 million when this is not yet approved by the Planning Commission nor even presented to the final approving body, Regional Planning Governing Board.

3) Is there a report from Reno Fire Department? (I may have missed it among the hundreds of pages.)

4) The FEIS approved one route - but Stonegate didn't like it. So now other property owners don't like this new proposed route. Why does Stonegate get to prevail?

5) This has been an extremely long ongoing project - so long that undergrounding was not the major impact 15+ years ago. The word is not even in the dictionary. Undergrounding is expensive - well, so is the danger to property, wildlife, as well as human lives. Can't we learn from the Maui and Paradise, not to mention the Caughlin Ranch fires? We need to be aware that undergrounding is the way to keep safety at the forefront. Since the costs will be paid for by rate payers, perhaps rate payers need to split the costs with NV Energy to keep themselves safe. It is too expensive NOT to go this one extra step. This project has been in the works for so many years, what is a little more time to make sure the analysis is complete and correct?

Here is an excerpt from my letter to Washoe County Planning Commission:

"Perhaps we should consider being proactive and adopt undergrounding on this transmission line, instead of being reactive when responding to a fire. Let's foster a more sustainable and resilient community for future generations.

Aside from safety concerns, there are also economic benefits, contrary to the statements that this is 7-10 times more expensive than above ground and the costs will be passed on to consumers. The cost of maintenance and repairs to damaged overhead lines can be excessive and staggering and are also passed on to consumers by NV Energy. A recent Federal report estimated the annual cost

of weather- related power outages to be approximately \$18-33 billion. By reducing outages by undergrounding, communities can save billions of dollars in lost economic activity, stimulating local economies and growth."

I am hopeful that you, as Planning Commissioners, could ask for this line to be better and more completely planned.

Comments:

I would like to address those in this meeting that have the ability to change the outcome of this proposed NV Energy project. My name is Brandon Kersey. I am a lifelong resident who grew up in Lemmon Valley and have lived in the Reno area my entire life. I would like to express my disapproval for the proposed routing of these utility lines through the last forested offroad recreational area in Reno that is not barren desert. This area provides recreational opportunities not available anywhere else to Reno residents. What makes this area so special? The thick forested area provides recreational users shade and a one-of-a-kind beauty for our area. The tight trails that flow between the thick forest trees are simply amazing. This area and marked trail systems are the only place in Reno that can be ridden in the heat of the summer months. Desert trails become too hot and without shade are unusable in the summer. By installing these utilities right through the managed trail system, it will forever ruin the recreational aspect of the area. We get tourism from folks that come here specifically to ride these trails, I met a rode the trail system with a gentleman visiting from Alaska just last Sunday. Beyond this it will forever destroy the pristine esthetic of the area. When you go to a national park do you like to have a picnic while staring at the overhead powerlines and a 100' clear cut area? The powerlines will need to have a clear-cut access area forever preserved around them and destroy the use that us single track riders use and enjoy. The large area surrounding them will require removal of a large path of old growth pine trees. These overhead lines also require a road for maintenance. The hard work of many organizations and the donated money would be all for not as the trail system they fought so hard to maintain will be gone. Being a born and raised resident I have been slowly stripped of the activities I have grown up enjoying in the area. I used to go duck hunting with my father in south meadows and watched as they brought in large amounts of backfill and ruined the natural swamp lands and wildlife to build track homes. I used to be able to ride my dirt bike from my backyard in Lemmon Valley all the way to pyramid lake, now the Indian colony has blocked all access to the area, and I can no longer even get to the moon rocks. I know there are plans to build a road through that area as well further making it impossible to use it for recreational activities. Just recently access to BLM land from rattle snake mountain has become blocked off from development in the east part of town. I remember growing up being able to go to Tahoe during the summer and swimming in sand harbor, now the population is so crowded it has removed any joy from visiting the area. You must be rich to enjoy anything around Tahoe now. When in my early 20's we would recreate in the Truckee river from Verdi and go rafting to downtown take a swim under the bridge at Keystone. Now the entire river system is

inundated with homeless and filth and is unsafe to visit. Speaking of Verdi, the natural beauty of the area will also decline with the proposed power lines. Bringing in these lines will only worsen the view of this area. This trail system is one of the last great recreational areas I frequent, isn't that what you are promoting this city for, outdoor recreational opportunities? There are becoming fewer and fewer of these. Can we not leave some pieces of the natural habitat untouched. I am barely able to even see the beautiful snow-covered peaks as I drive around town now that there are tall warehouses blocking the views. Is there not another means to serve the desired power line routing? Can you not go around our established trail system that I donate my own hard-earned money to stay maintained? Is NV Energy unable to install underground electrical lines around the forested area used. This would for one stop the issue of the overhead lines causing any forest

The NV Energy power line project will have a negative visual and community impact to the residents of Verdi. As a longtime resident of Verdi, and a Program Manager for the Sierra Buttes Trail Stewardship, I am currently managing two different state-funded grants in the Peavine Maze motorized network of single track trails. The proposed Peavine/Poeville alignment will run straight through the middle of this rare, alpine forested corner of Nevada that's extremely popular for motorized recreation, negatively impacting multiple trails in the system. Considering there's very few legal motorized single track networks in the entire state, on top of the fact that there are very few alpine forest settings in Nevada where legal single track exists for multi-use recreation, the Peavine Maze is a very special place, and cutting a 100-foot wide swath through aspen groves and alpine forest for a power line will ruin the visual aesthetic of this entire area. People move to the Verdi area for its incredible recreational access to National Forest lands. In the May 7 Washoe County Staff Report, it stated that this project will have a "less than significant impact to aesthetics and the community character of Verdi". As a longtime resident of Verdi and a regular visitor to the Peavine Maze area, I couldn't disagree more. The trails may not be in visual sight from Old Highway 40 in Verdi, but they are an essential component of the Verdi community. In a time where development is swallowing up Verdi on all sides, this power line project is just the latest in a long line of community altering developments. I oppose the Peavine/Poeville alignment of this power line. Thank you for your time. - Kurt Gensheimer




