3/12/2024 13:47:35	3/13/2024	Michael Gawthrop-Hutchins	Ward 5	D.2	No position stated - Concerned or Neutral	<p>I do not know if it is possible, but if it is, I would greatly appreciate as part of the FY 2025 Interlocal Cooperative Agreement with RTC, the city could push for RTC to reconsider the routes included in the Downtown Reno Micromobility project. In particular, moving improvements from Vine St to Washington St. Vine St is quite possibly the worst possible route to use, crossing the freeway involves a very narrow bridge with, while not exactly steep approaches, approaches that are steep enough to discourage many cyclists, involves the intersection of Vine and 4th, which is a very dangerous intersection for reasons that can't entirely be fixed by this project, and will require both sharrows and unprotected bike lanes for extended stretches.</p> <p>Washington St on the other hand has a short, level, and wide bridge across the freeway (which additionally connects directly to 7th St, which is a very popular street for cycling), a very wide right of way that allows for more protected bike lanes and less unprotected bike lanes or sharrows, and already has a modal filter at the intersection of 4th and Washington (which is a safer location for people on bikes to be crossing 4th St anyway due to the improved visibility over the intersection of Vine and 4th). The only real drawback is that Washington does not extend the entire length to the river, but could easily be connected via a very short block on Jones St.</p> <p>While I hope that this isn't a once in a generation project, that this is something that will continue to spread across the city, we have to recognize that this may be a once in a generation project, and need to make sure that we are using the routes that will get the most use. Washington is the route that cyclists already prefer to use and is the much safer bet for success. And, if this isn't a once a generation project, using Washington opens up the opportunity to extend further north on Washington, all the way to Rancho San Rafael Park in the future, and will offer better connections to any future improvements on 7th in the future. Vine St has no real obvious future expansions past University Terrace and, let's all be honest with each other, most cyclists that are using 7th aren't going to want to detour to University Terrace to access the downtown micromobility network. They will continue to take 7th to Washington anyway and new riders who are in the "curious but concerned" category will continue to avoid riding due to that gap in the network. Aside from that concern, and general skepticism of benefit of road widening in general (regarding the Moya Boulevard Widening Project), I'm completely in favor of the city entering into this agreement. Even as it stands now, these projects will all be a good benefit to our region.
