In my prior city I founded and served as the Channel Islands Neighborhood Council, representing 2,500 homes on the 5th largest harbor in CA. I understand policy issues and how to communicate with residents in public meetings.

My prior home city was the same population size as Reno. I dealt regularly with the City Manager and the County Board of Supervisors on matters that were important to the residents. I think I can bring my public-serving experience to the Reno NAB, which will in turn support our City Council members more knowledgeable in their roles.

Our City, Oxnard has a different way of getting communications out to the 250,000 residents. They use a neighborhood council made up of 35 different neighborhoods in the city. They have one master neighborhood organization. When something important impacts a specific neighborhood, it is addressed on a smaller level than the Reno NAB. Outreach to 40,000+ in one NAB is challenging. The last NAB meeting I attended had only 3 members in the community attending in person and not many more online. I hope to address outreach as part of my volunteerism for Reno.
