To the Members of the Reno City Council and the Washoe County Commission, Reno Police Chief Kathryn Vance, Sheriff Darin Balaam, Sparks Police Chief Chris Crawforth, Nevada DMV Director Tonya Laney, Nevada DMV Compliance Enforcement Chief JD Decker, and Other State and Local Officials:

In my daily travels through the City of Reno, I continue to observe an inordinate number of motor vehicles operating on public roads without visible license plates or with expired or fraudulently displayed temporary placards. These violations are not anecdotal—they are a daily, well-documented occurrence and reflect a pattern of disregard for Nevada's registration and insurance laws. Many of the vehicles appear to be older models that likely cannot pass emissions testing and may be uninsured. Other seem to be too lazy to make an appointment with DMV to register their vehicles. The cumulative effect of this behavior is a persistent erosion of public safety, elevated insurance premiums for law-abiding drivers, a breakdown in confidence in regulatory enforcement, an adverse environmental impact due to unchecked smog emissions and most of all—loss of much needed revenue for the state.

As part of my ongoing documentation efforts, I am submitting photographic and geolocation evidence of several vehicles recorded between April 15 and April 28, 2025. These images were captured using metadata-enabled photography that verifies time, date, location, elevation, speed, and direction of travel.

Despite the return to normal DMV operations following pandemic-era disruptions, this pattern of flagrant noncompliance persists. These are not technical lapses or rare oversights. They are repeated violations of Nevada Revised Statutes concerning vehicle registration and financial responsibility.

Today, May 5, 2025, marks the official launch of the *Joining Forces* Click It or Ticket campaign by the Washoe County Sheriff's Office and participating agencies. While the focus on seatbelt usage and driver safety is vital, this initiative represents a prime opportunity to address another high-impact public safety issue—unregistered, uninsured, and untraceable vehicles. Unfortunately, enforcement against expired or fraudulent placards remains absent from current messaging or operations, despite its comparable risk. The Sparks Police Department recently advertised a focused enforcement effort to combat unregistered vehicles. If the Sparks Police Department can do it, so can the Reno Police Department, the Washoe County Sheriff's Office and the Nevada Highway Patrol. Enforcement of unregistered vehicle laws must be continuous and a concerted effort involving Nevada DMV Compliance Enforcement to effectively combat the problem.

I respectfully urge the following:

- **Targeted Enforcement:** Proactively include unregistered and uninsured vehicle enforcement in current *Joining Forces* patrols.
- **Public Awareness:** Launch a parallel public information campaign warning of penalties for expired or fraudulent placards.
- **Interagency Coordination:** Collaborate with DMV Compliance Enforcement and vehicle dealerships to crack down on unregistered vehicles, improper use of temporary tags and in transit permits.

I will continue to document and report this issue. I remain available for further consultation.

Dear Mayor Schieve and Members of the City Council,

We are writing to formally object to the proposed special assessment levy for properties within the Downtown Reno Improvement District (BID), specially as it applies to our property at 255 N. Sierra, Unit 401.

The assessment is being justified on the basis of "special benefits" provided by the BID including trash removal, graffiti removal, shopping cart removal, and power washing. BID also focuses on a safer downtown area and special marketing effort to promote the downtown area. However, all these services are not "special" - they are basic municipal services that should be included in the standard scope of what our property taxes already cover. Placing the extra financial responsibility for these core services on a select group of property owners though a special assessment is both inequitable and unjustified.

Furthermore, the assertion that these services provide a unique or enhanced benefit to my property is unsubstantiated. In my experience there has been no demonstrable improvement in the cleanliness, safety, or value of my property as a result of the BID's involvement. This assessment creates an undue burden without providing measurable return or benefit.

We respectfully request that the City Council reconsider the funding structure of the BID, and ensure that essential, core public services remain the responsibility of the City through the general fund, not through additional levies on the downtown property owners.

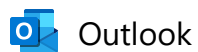

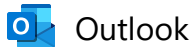
