Good morning City of Reno City Council,

There needs to be more than one option for recycling pick-up services in Reno.

We've had quite a few issues with Waste Management picking up recycling in Somerset. Our neighbors have experienced these issues as well. We've seen the recycling trucks simply pass by our recycling bins on sunny, perfect weather days. This happening once is fine, however, this has happened multiple times since January 2023, with the most recent occurrence taking place Monday, February 12, 2024. We auto-pay for WM's service, yet when the trucks drive right by our recycle bins, they refuse to return to pick it up for another two weeks. This means our recycling will go beyond overflow or we have to trash our recycled materials. We contact WM multiple times via email and phone at each occurrence to no avail.

When is the City of Reno going to offer another vendor service for recycling pick-up?




