I witnessed a city Parks & t ec employee removing a campaign sign from the wide, full-of-weeds, median on t obb Dr. She told me to put the signs in my yard and I replied that I don't have a yard because I live at Manzanita Apartments. She told me to put the signs at Manzanita and I told her that Manzanita doesn't allow campaign signs. She replied, "Well, don't bother me about it!" I've called the city to find out where they allow campaign signs and they don't answer and don't return my calls after I leave a polite message. This is the tenth sign that has been removed. The city should return the signs to the Washoe GOP immediately and inform us where they allow our signs. Some of the signs have been thrown in the bushes and the metal racks destroyed. I found another one in the trash at the park. This behavior from city employees doesn't impress the people who pay their salaries with their tax money. Furthermore, I believe it is election interference when an apartment complex owner seems to collude with the City to prevent renters from campaigning in an election. Manzanita Gate Apartments don't allow signs on their property, even though they have many rock-filled areas where a sign couldn't possibly interfere with vegetation, and the City of t eno doesn't allow signs on the street

adjacent to Manzanita apartments. On top of that, the City won't inform us where it is legal to place signs. Some might say this is either fascism or incompetence on the part of the City of Reno.

Hello Mayor Schieve and Reno City council. My name is Samantha Strasser, I'm a Reno resident living in Ward 4 in golden valley. I'm coming to you today with a concern about traffic in the north valleys. In the last week US 395 southbound has been shut down twice due to accidents near Golden valley. When this happens an incredible surge of traffic hits our side streets in the valleys, and I'm extremely concerned about this. Heavy traffic poses an increased safety risk for our kids going to and from school, especially kids that walk and wait for buses (of which we have a large number here in the valleys). First responders attempting to get to emergencies anywhere in the valleys not related to the accident are snarled in traffic. And with the recent Davis Fire, the speed and ferocity with which it spread initially, I can't help but feel that we are completely screwed if, really when, a fire like that were to break out up here. This isn't just because of construction pains, 395 has been shut down many times before, and it seems to be increasing in frequency due to weather and accidents. And widening the highway will only serve to make this problem worse. The Induced Demand effect means that more lanes encourages more cars, so a wider highway being shut down means even more traffic will divert

to side streets. The infrastructure in the north valleys has not kept pace with the rate of housing being built up here, so residents are increasingly forced to drive into the city proper for access to various services and employment. And our routes to do so are being choked off more and more frequently. Better non-highway through routes are critical for accessibility in the north valleys not only in the coming years and decades, but also right now. Construction may be temporary, although when projects have multiple phases and go on for years at a time, it certainly isn't temporary for the hundreds of thousands of people who live with it daily during those years. Climate change means our winters will get harder and we've already seen an expansion in fire season, with some of my neighbors this year reporting that they've been dropped from their home insurance policies due to wildfire risk. This problem isn't going away and some serious planning for the future needs to be happening now. I'll confess I don't know if this is the "proper" channel for this concern, but as a city resident I thought city council seemed an appropriate place to start. Within the first year of living in this city it already began to feel like home to me. Now 6 years in, my family and I have really put down roots and it's hard to imagine living anywhere else. I want to have faith that my elected leaders love this city as much as I do, and upon learning that one region is being impacted in this way that they would know where to direct that concern.

My name is Maria and I live in the North Valleys. Um, I live off of Stead Boulevard. I'm calling to comment on the housing and the infrastructure of the North Valleys area as everybody is, well aware. Um, the City of Reno continues to Annex for more housing out here. However, we have limited space in and out of the North Valleys, for example, today, I on my way into work, which I work downtown and I take old 395 all the way down to the downtown area. It should take about 15 to 20 minutes. I was in traffic for 3 hours. Just this morning in turn my daughter. Who lives, less than 5 miles away from her High School North Valleys was in traffic for the same amount of time trying to get to school because there was an accident on 395. The problem is that there's no other way. Around it. The only way to get into town is to try to wait the highway or old 395. There is no alternative route that cars can be taken while there's construction or if there's an accident or in the weather conditions, I speak for a lot of people. Not just myself, who've lived out here for some time and can tell you that the City of Reno needs to pay attention to what's going on in the North Valleys. God forbid, the whole entire North Valleys has to evacuate at 1 point. We would all be stuck in traffic. There is not enough ways in and out of the North Valleys and when the City of Reno continues to Annex for homes out here, being built in apartment complexes that are just adding more population to the area without looking at any infrastructure or taking any note of the commute times that we have. From here to our jobs, it's getting completely ridiculous. I think the City of Reno needs to think about either a not putting any more homes out here and not letting any more Builders build in this area. In turn and with also preparing and making sure that there is an alternative route. Not just the highway and not just old 395 in. And out of the North, Valleys not just around Sun Valley because if you come from said and you try to go to Sun Valley, that's the place that's all clogged up. Silver Lake Boulevard instead Boulevard the old 395 395 itself. Um, all of these areas are clogged up, and we cannot get through and we're in gridlocks bumper, to bumper traffic for hours, on end, trying to make it into work. Um, and when the winter time comes, it's even more horrendous top time. During the time I've been on the road trying to get to work. And I've left early, And I want to drive safe is 4 and a half, almost 5 there just needs to be alternative routes in and out of the North Valley's area. There does not need to continue to be more housing built without infrastructure in mind.
