Good morning/evening Council members,

I have lived in this valley for the past 10 years and moved out here to escape "city life." This is an overreach of urban sprawl and highlights the problem with annexation by the city. The only constituent the council represents in Cold Springs are the developers. This would change the way of life for over 10,000 county constituents. Re-Zoning 930+ acres of more box warehouses does not fit with the community. There are large amount of box warehouses in the Truckee meadows that a currently sitting vacant already so I don't understand how this is even being considered. At a recent planning meeting a million + sqft box warehouse district was approved to be built along White Lake Parkway with the "throw you a bone" 30,000 sq ft of commercial. Residents out here don't want box warehouses. The vast majority of the jobs these warehouses will create will not be residents of Cold Springs. This is not USA Parkway or Stead. Cold Springs never has been and hopefully never will be a "industrial hub" as the planning commission stated. Your plan drastically changes the landscape of this valley. There is not enough infrastructure to support such a plan which is why Stonegate was required to provide all the infrastructure improvements with their original plan. One semi spinout will cause all of the residents of Cold Springs to be trapped with one two lane freeway in and out. It is already a problem without the traffic increase this will cause. I am aware that the zoning of this land was previously industrial and was switched to residential but I believe it should not be allowed to be switched back.

Speaking on emergency services the closest ladder truck (needed quickly in the event of a fire in one of these places) is in downtown Reno 35 minutes away.

I'm asking that Heinz be held to keeping this land residential to avoid ruining the landscape of the valley. If they can't afford to build homes they should sell the land and not ruin the quality of life of the residents of Cold Springs. Thank you for your time.





I'm Leah Sanders Reno Resident and Member of Scenic Nevada

Re: School Sign Ordinance Item D.3

I concur with the May 18 letter Lori Wray, Director of Scenic Nevada wrote to the council.

Yes, Digital signs may be easier to use for communication to parents, but are not needed as billboard for a school.

Research? I questioned parents whose children attend WCSD schools and parents who live elsewhere. Here's what I learned from my small sample:

- **Many parents like the reminders signs provide when they have children at different schools.**
- **None liked the idea of fast flipping or signs lit outside of school hours.**
- **Some questioned the need for signs...Cost...And pointed out that presently many schools do not post current notices (using email, phone, text). Please note the photo I took on May 14 starts with the February announcement and ends with Spring Break. That's 3 months out of date.**
- **Some communities like Truckee do not have digital signs or any formal structured signs even though the elementary school faces a major roadway.**

So...


- **If the signs are for school information, they should be restricted to being active during school hours and unlit and static when school is not in session**
- **A 15-minute rotation allows time for the message to be read. And is driving safe. Schools should have a special sign for emergencies.**
- **A thank you for donations by businesses should not become advertisements.**
- **A school needs only one modest sign.**
- **Schools exist to be part of a neighborhood, not an exceptional stand-out annoyance or traffic hazard.**
- **Schools should be a model for little pollution and responsible energy consumption.**
- **No one would propose putting a neon pink school in a Reno neighborhood to call attention to the school; why are bright signs OK?**

And...

- **Reasonable regulations are possible.**
- **Number of signs and placement should be limited (See Scenic Nevada proposal)**
- **Negotiation started and then was rejected by the school district representative.**
- **Present proposal regarding signs needs better rationale/research.**

RE: Opposition to the StoneGate Development Project and Proposed Zoning Change

Dear Mayor Schieve and Members of the Reno City Council,

I am writing to express my strong opposition to the proposed StoneGate development project in northern Reno, particularly the associated zoning change that would allow permissive industrial uses in this ecologically sensitive and water-scarce area.

One of the most urgent concerns is the potential destruction of the largest remaining critical habitat for **Webber's ivesia**, a rare and endangered rose species that grows **nowhere else on Earth** but in this specific high desert region. The StoneGate site overlaps directly with this fragile habitat, designated as critical habitat by the U.S. Fish and Wildlife Service¹. Approving this development would represent a profound failure to protect one of Nevada's most unique native species at a time when biodiversity loss is accelerating globally.



In addition to the ecological threat, the **lack of adequate water resources and water infrastructure** in the StoneGate area remains a major and unresolved issue. Northern Nevada is already grappling with growing competition for water. Adding thousands of new industrial users in this area with limited water infrastructure would only worsen the crisis, without a clear, sustainable plan for how to support this increased demand.

The proposed industrial zoning also raises serious concerns about **traffic congestion and economic benefit**. If the area is developed for general industrial use, it could bring a significant increase in truck and commuter traffic to a part of Reno that lacks the road infrastructure to support it. On the other hand, if the area is developed for **data centers**, which appears likely and which proponents have been stating is possible, these facilities require **very few workers**, meaning they will create almost **no new jobs** and limited tax returns while still consuming potentially enormous amounts of energy and water. This raises an essential question: **Why are we fast-tracking a zoning change that either clogs our roads or provides no meaningful benefit to the community?**

Of further concern is the potential introduction of data centers under the proposed industrial zoning. These facilities are extremely water- and energy-intensive, and the Reno City Council has yet to develop clear regulations or public guidance around their siting, environmental impacts, or community protections. Approving a broad zoning change without these safeguards in place could open the door to unchecked industrialization that is inconsistent with Reno's climate, land use, and public health goals.

This project, in its current form, is not aligned with the values or long-term sustainability of the Reno community. I urge the City Council to reject the zoning change and pause approval of the StoneGate project until:

1. A full environmental impact review is completed, including a detailed analysis of the impacts on Webber's ivesia and other sensitive species, consulting with U.S. Fish and Wildlife Service and the Nevada Division of Forestry to learn what conditions were placed on the "take" permit for Webber's ivesia.
2. A comprehensive water availability and infrastructure plan is developed and made public.
3. Guidelines and regulations for data centers and other high-impact industrial uses are adopted and enforced.

Please prioritize the health of our ecosystems, the resilience of our water systems, and the voices of concerned citizens who believe that thoughtful planning must come before speculative development.

Thank you for your attention to this critical matter.
