

**RESOLUTION DONATING COUNCIL DISCRETIONARY FUNDS TO TRUCKEE MEADOWS COMMUNITY HIGH SCHOOL TO SUPPORT THE RICH EDUCATIONAL EXPERIENCE THROUGH RIGOROUS HIGH SCHOOL AND DUAL-CREDIT COLLEGE COURSES, SO NORTHERN NEVADA STUDENTS WILL GRADUATE COLLEGE AND CAREER READY IN THE AMOUNT OF \$500. (GENERAL FUND)**

**WHEREAS**, the City of Reno may donate funds in accordance with NRS 268.028(01), entitled “Expenditure of public money; grant of public money and donation of certain property to certain nonprofit organizations or governmental entities” when such expenditure provides a substantial benefit to the inhabitants of the City; and,

**WHEREAS**, Truckee Meadows Community College High School, is a middle college high school for mature, motivated 10<sup>th</sup>- 12<sup>th</sup> grade students interested in adding value to a high school diploma by simultaneously working toward a certificate of achievement or an associate degree; and,

**WHEREAS**, Truckee Meadows Community College High School, offers multiple options for students who are focused on their future such as degree seeking students that enjoy the academic focus of college classes as they work toward an associate degree or career-focused students who enjoy the flexibility and focus of the applied science college courses as they work toward a technical certificate; and,

**WHEREAS**, Truckee Meadows Community College High School, has various advantages for students from tuition-free college credits, small class sizes and flexible scheduling, college resources, labs, learning centers, tutors and other activities; and,

**NOW, THEREFORE BE IT RESOLVED** that the City of Reno approves the Council donation from Councilmember Ebert in the sum of Five Hundred Dollars (\$500) to Truckee Meadows Community College High School; and,

**BE IT FURTHER RESOLVED**, that should the above donation or any portion thereof not be used for the purpose as set forth in this Resolution, any unused funds shall be returned to the City of Reno.
