Dear City of Reno Staff:

Northern Nevada Public Health (NNPH), Environmental Health Services Division (EHS) has reviewed the above-mentioned project.

1. EHS has reviewed the above referenced application and notes the parcel where the storage yard is proposed is served by a private community water system.
2. EHS has concerns that the proposed storage yard may adversely affect the onsite water well. EHS would request a vulnerability study be completed prior to the approval of this application.
3. The parcel is also a permitted mobile home park with EHS, as such the storage area would have to meet all the requirements of the mobile home park and have paved access and storage areas. Including but not limited to signage and contact information and garbage/trash storage.
4. Emergency response plans and response kits would be required for this are to be utilized for any storage of equipment or vehicles which contain hazardous materials.
5. If the application is approved all subsequent building plans and permits must be routed to EHS for review and approval.



The Environmental Control Section (EC) under the Utility Services Department has reviewed the Development Projects memorandum dated April 18, 2025. We offer the following comments or conditions:

#### **Shafer Equipment- SPR25-00010**

Any proposed gravity interceptors associated with the project must be sized and installed in accordance with Reno Municipal Code 12.16.555. An Environmental Control Permit will be required when the facility begins operating. Environmental Control will contact the applicant when the business applies for a business license. Applicants can call 775-334-4230 for more information about required permitting.

#### **California Building Remodel- COA25-00001**

Environmental Control has no comment on the proposed Certificate of Appropriateness.

#### **High Desert Paving Storage Yard - LDC25-00055**

Environmental Control has no comment on the proposed Conditional Use Permit to allow for outdoor storage of paving equipment and vehicles. If future anticipated uses include maintenance and repair of equipment and vehicles, an Environmental Control Permit will be required.
