To the Reno City Council Members,

As residents of 3rd Street Flats, directly across from the building the club would like to occupy, we'd like to say we are strongly against this club reopening.

Noise from crowds hanging out on the street from possibly as early as 10:00pm until closing sometime before dawn, will definitely interrupt people's sleep. Also, the proposed security lights and any lights from signage will affect their quality of life.

Reno seems to want people to live in and visit downtown, but all-night clubs like this don't seem to be working well, as there's already been trouble at the recently reopened 219 club. Events such as the Light Festival, and all of the different and diverse ethnic festivals seem to be a better fit for a neighborhood like this.

If the goal is to transition downtown into a desirable living area, then zoning needs to be readdressed. Encouraging residents to move into this area and then allowing all-night clubs and outdoor venues that are disruptive late into the night and early morning isn't conducive with that goal. Bars and restaurants should absolutely be part of the mix as it brings a vibrance to an area, but the 1UP club is a completely unsuitable addition. What people living in this area could use and the city benefit more from are grocery store options within walking distance of residences. A true downtown offers convenience for residents and is a lure for visitors, but in the end, the residents are the ones who should be able to expect that the energy subsides at a decent hour.
