Carter Williams, City of Reno Development Services Associate Planner, presented the staff report.

Brooklyn Oswald, Applicant Representative, gave a presentation on the project and the requested amendment.

Mr. Williams answered questions from Council regarding the development constraints map.

Mike Mischel, City of Reno Development Services Engineering Manager, answered questions from Council regarding traffic concerns raised in public comments. He confirmed he is comfortable with the traffic studies that have been done and their recommendations.

Mr. Oswald answered questions from Council regarding wildlife in the area.

Council Member Ebert expressed concern regarding the liability to the City of Reno when it comes to the horses trying to get through fences to get to water.

Mr. Williams answered questions from Council regarding the review processes in place that are still to come.

Vice Mayor Duerr stated she is supportive if they can add conditions related to her previous request that the applicant remove development from a specific area, and conditions related to wildlife in the area including eagles and horses.

Mr. Williams answered questions from Council regarding sustainability efforts and confirmed the applicant is comfortable with what staff has proposed.

Council Member Taylor referenced a letter from the Nevada Department of Agriculture (NDA) that says they have significant concern over watering horses and establishing a horse trail. She wants to respect what the NDA said and is uncomfortable with the suggestions regarding wild horses because it is not their purview.

Angela Fuss, City of Reno Development Services Assistant Director, confirmed for Council Member Taylor that they definitely should not be managing horses. What they can do is manage how horses are kept out of private property.

Vice Mayor Duerr stated the three conditions she is requesting be added. 1) Remove the development right at the canyon's mouth. 2) Add specificity that the eagles will be addressed with the Fish and Wildlife Service at the appropriate time. 3) Set up a wild horse mitigation contribution, ensure they allow passage for the horses between where their houses end and where the cliff begins, and update the existing agreement to delete the watering and expand the width between the canyon and the development by thirty feet instead of six.

Mayor Schieve asked what the applicant is comfortable with.

Mr. Oswald stated they went from \$500 to \$1,000 per home to go toward affordable housing. They are also contributing \$500 per home to regional trails and \$250 per home to the HOA to help with habitat maintenance. He stated they are not opposed to those contributions but struggle when it comes to a direct charity contribution. The NDA is continuing to find money for that and they do not want to sacrifice part of their affordable housing contribution to set up a wild horse mitigation contribution to a charity.

Vice Mayor Duerr discussed the requirements in the master plan related to wildlife mitigation.

Mr. Oswald clarified that these horses are considered feral or stray livestock, not wildlife. According to the Director of Agriculture, they move from food to

water and do not have migration corridors. Also, there could be some question to the legality of the agreement document as a whole. The State may be saying that the two parties of the agreement never had the authority to enter into the agreement about something they don't manage in the first place. Watering the horses could put them in violation of State law.

Tracy Wilson stated there are multiple interpretations of the State law. The water law quoted in the NDA letter is not applicable as it is being referred to because it is referring to lands different than what this is. It refers to public range which is defined as U.S. or State owned land, not private land. Also, in that letter the NDA states they do not have authority over water.

Mr. Oswald explained that feral or stray livestock is currently not an approved use for allocation of water rights by the State Engineer.

There was discussion regarding potential conditions to be included in a motion. Mr. Oswald stated they will not be able to do anything in the agreement that comes in conflict with State law, and they will work with the State to determine the correct method for dealing with how the horses get around the property.

- I.1 ***SUPPLEMENTAL SUPPORTING MATERIALS*** - Staff Report (For Possible Action): Case No. LDC24-00015 (NV Energy Utility Corridor) Appeal of the Planning Commission's decision to include Condition of Approval No. 9 in their approval of a conditional use permit to: a) establish a major utility to allow for the construction of a new overhead 120kV electrical power line, and b) allow for hillside development. Condition No. 9 requires matching of the general alignment as presented in the Final Environmental Impact Statement. The corridor alignment for the utility is generally located between the Bordertown substation (Cold Springs area) to the north and the California substation (Verdi area) to the south. Approximately 4.1 miles of the overall ±10.9 mile Nevada portion of the power line are within the City of Reno with the remainder in unincorporated Washoe County. The request is a Project of Regional Significance (PRS) and requires an amendment to the Truckee Meadows Regional Plan to establish a new regional utility corridor. Appeals were filed by the applicant, NV Energy, and Heinz Ranch Land Company LLC. City Council may affirm, modify, or reverse the decision of the Planning Commission. [Ward 4, 5]
