**RESOLUTION OF THE RENO CITY COUNCIL RELATED
TO PROVISIONS UNDER DOCKET NO. 24-02026 BEFORE
THE PUBLIC UTILITIES COMMISSION OF NEVADA
(PUCN), AND OTHER MATTERS PROPERLY RELATING
THERE TO.**

A. **WHEREAS**, Sierra Pacific Power Company d/b/a NV Energy filed its application addressing its annual review requirement for general rates charged to all classes of electric customers on February 23, 2024; and,

B. **WHEREAS**, the Public Utilities Commission of Nevada (“PUCN”) held consumer sessions in June, 2024 to solicit feedback on the matter; and,

C. **WHEREAS**, the City of Reno has received public comment pertaining to NV Energy’s application.

NOW THEREFORE be it hereby resolved by the City of Reno Council as follows:

Section 1. The City Council hereby finds that the foregoing recitals are true and correct, and are incorporated by reference.

Section 2. The City Council formally encourages the PUCN to consider the public comment it has received as it issues its decision in Docket No. 24-02026.

Section 3. The City Council believes that the PUCN should prioritize adopting solutions that promote fairness to all customers, and to pursue policies that ensure that low rates are in place for low-income residents and seniors.

Section 4. The City Council believes that the PUCN should prioritize promoting clean energy policies including increased solar energy in all forms. The City further encourages the PUCN to increase the expanded solar access program, and to leverage all federal funding including the Solar For All funds, to provide more solar opportunities for low-income residents and seniors.

Section 5. The City Council encourages the PUCN to adopt solutions in the application that fully support rate design that expands conservation and energy efficiency programs.

Section 6. The City Council hereby re-affirms its longstanding partnership with NV Energy to work collaboratively to find solutions that further the clean energy future and support policies that are beneficial to low-income residents and seniors.

Section 7. The Mayor, City Manager, members, officers, employees, and agents of the City are hereby authorized and directed, jointly and severally, to do any and all things, and to execute, deliver and record all documents as may be required and otherwise to give effect to, carry out and comply with the terms and intent of this Resolution, and to take all necessary and appropriate actions to effectuate the intent of this Resolution.

Section 8. This resolution shall take effect immediately upon its passage.
