I am writing on behalf of the Latin Chamber of Commerce of Nevada to express our concern and opposition to **Item D.6** on the Council's July 31 agenda.

The Latin Chamber of Commerce has been proudly representing and serving the interests of small businesses in Nevada for almost 50 years. Today, we proudly connect over 1,500 members of Nevada's business community. As an organization we feel that this resolution opposing NV Energy's pending general rate case with the Public Utilities Commission does not fully consider the benefits that this restructuring of NV Energy rates could bring to our members and their families. Moreover, we trust that the Public Utilities Commission will effectively navigate the matter currently pending before the Commission in a manner that protects our members interests.

Small businesses are the backbone of the communities that the City of Reno relies on. They are run by your constituents, NV Energy customers, and employ hardworking people who would benefit from lower energy bills and more stability and predictability month-to-month. This proposal will lower average energy bills by the end of the year AND will stop forcing our members to pay more than their fair share for the cost of NV Energy infrastructure. Small business owners and employees should not be forced to carry the extra financial burden for customers who can afford to install private rooftop solar systems. The Nevada Latin Chamber of Commerce supports NV Energy's proposal and the equitable distribution of costs for all NV Energy customers and not just a select few.

We ask that you please keep the small business community in mind when making your decision and **vote no on item D.6**. NV Energy's proposal will benefit our members, and we ask that the City not interfere with this ongoing process.

Here are some solutions to NV Energy's (NVE's) recent increase in their Basic Service Charge (BSC). Some of these can also be combined:

- 1) Do away with the BSC altogether. It has always been regressive, whatever the amount. NVE can find a way to meld the BSC into the variable rate (the kW usage rate).
- 2) Have tiers of rates, along the lines of how water use is charged in Reno. Someone using up to X kW per month would pay the basic rate. Usage beyond X would be billed at a higher level (Y) and beyond Y, higher still (Z). These increasing rates will definitely get customers focused on conserving use or investing in their own solar, etc.
- 3) NVE charges residents a higher kW than commercial and industrial companies. Industrial also pays less than commercial, as I recall. Residential customers are subsidizing the energy use of commercial and industrial companies. This is not equitable and it disincentivizes commercial and industry to conserve or evolve their operations to require less energy. If anything, commercial and industrial companies should pay more than residents.
- 4) Recent alarming articles warn that energy use is skyrocketing due to the proliferation of crypto and Artificial Intelligence (AI), both of which require massive amounts of computing (and, therefore, energy). I personally think crypto is a fraud or at least not needed in our culture. But regardless of my belief, crypto and AI coming into Nevada should be responsible for providing their own energy. Many AI firms have already installed huge solar arrays in Nevada to provide them with green energy (many involve agreements with NVE). This should be a requirement for crypto and any future AI firms moving into Nevada. Otherwise, residential customers will once again be on the hook for all that additional energy use.
