**Summary:**

There are seven (7) vacancies for a Ward 3 Neighborhood Advisory Board (NAB) member and two (2) vacancies for Alternate Members on the Ward 3 NAB.

The Clerk's Office received applications from: Anthony Dispenziere, Juergen Hoehne, Sarah Horsman, Gabriel Maya (Reappointment), and Valerie Tilson.

Gabriel Maya's term expired on November 30, 2024. Mr. Maya is eligible for and interested in reappointment.

The term of appointment/reappointment for all positions will be from January 1, 2025, through December 31, 2027.

**Background:**

As indicated in City of Reno Resolution No. 9317, adopted on September 19, 2024, city residency is not required to be a NAB member. Membership terms are two years in duration and members shall not serve more than two terms.

Section 10 states Council may waive term limits in specific instances where membership qualifications are desired or no qualified person has applied for appointment.
