I am in opposition to LDC23-00020 1. The city of Reno does not represent or provide services for the residents of Cold Springs and should not be profiting from projects in Cold Springs Valley. 2. A zoning change to Specific Plan District is vague and does not allow for an informed decision to be made on what is being built in our area. 3. As an 18 year resident of CSV, I have seen the lake fill all the way to White Lake Parkway. One would assume that in order to prevent these parcels from flooding, the ground will need to be elevated, thus making the overall height of the buildings even higher in elevation. 4. Our roads are not built for added commercial traffic, and these commercial vehicles are not welcome near our neighborhoods. 5. The city of Reno has not made adequate preparations to provide emergency services to these parcels. They will have to rely on mutual aid from Washoe County emergency services, or provide unacceptable response times. 6. The only thing that is 'needed' in Cold Springs at this time is a High School. We should be planning for our future generations instead of adding more warehouses and strip malls.
