**Summary:**

There are currently two vacancies on the Civil Service Commission.

Staff has received applications from Tray Abney (Reappointment), Adam Grosz, Brad Johnson, Dominique Labonte, and/or Escenthio Marigny Jr.

Tray Abney's appointment expired on July 1, 2023, he is interested in and eligible for reappointment.

The term for reappointment and/or appointment for the vacancies is for the period November 1, 2023 through June 30, 2028.

**Previous Council Action:**

There is no recent Council action relevant to this item.

**Background:**

Charter Section 9.030 requires a seven-member board appointed by the Mayor and approved by the Council.

Members must:

- (1) be residents of the City,
- (2) have no other connection with City government,
- (3) hold no elective office,
- (4) serve for terms of five years, and
- (5) receive compensation as provided by City ordinance.

One term of office shall begin on the second Monday in July in each successive year. A member shall serve until his successor is appointed and qualified.

A vacancy occurring during a term must be filled by the Mayor with the approval of the Council for the remainder of that term.

**Financial Implications:**

None at this time.

**Legal Implications:**

Legal review completed for compliance with City procedures and Nevada law.

**Recommendation:**

Staff recommends that the Mayor make the necessary appointment with the approval of the Council as noted in the staff report.
