**Re: Locker Room Design Flaw at new Moana Springs Pool**

Dear Reno City Council, City Manager and Parks and Recreation Director

I &/or my family are members of a local swimming user group who expect to use the new Moana pool.

I am aware of the current design of the locker rooms at the new Moana pool, and I request that you significantly increase the floor area, lockers, and bench seating space in the private changing area of this facility. This could be done by installing a wall to make the current design of an open public viewable locker area part of the private locker room area.

I understand Sierra Nevada Community Aquatics has attempted to initiate such an improvement with City personnel by voicing user groups' concerns regarding the insufficient private changing areas of both locker rooms. Based on expected usage, these features at Moana are much worse than any other aquatic facility in the region, especially when compared to Carson Aquatic Facility (which is more than five times better than Moana in this regard).

I request that you authorize significant improvements to these locker rooms now, before the project is completed. I/we understand this may delay completion of the facility and come at a higher cost. The future legacy of this facility is more important to us, as it should be to you, than a quick and flawed finish (in swimming terms that would be a DQ). **Make Moana Better!**

TITLE: Jinxed Jacobs Juice Job Joylessly Junked

The Reno City Council got religion last week when some sainted soul scuttled (or at least postponed) the assassination attempt against Bethel African Methodist Episcopal Church.

The brahmins of city hall were ready to give carpetbagger Jacobs Entertainment a chunk of city land for purposes unknown.

Rev. Dr. Debra A. Whitlock-Lax, Pastor of Bethel AME Church in Sparks, sent up warning flares and sank the Jacobs juice job. With a little help from her friends.

Her Sparks church also owns its 119 year-old, National Registry of Historic Places progenitor. Alas, it stands near JacobsWorld downtown. One Jeff Jacobs (who changed the name of the Sands Regency Hotel to his first initial -- T-Rumpian, eh wot?), has bulldozed much of Reno's West 4th Street into vacant lots.

Jacobs is doing a deal with the Reno Housing Authority which manages low income housing government programs. The waiting list is usually two to three years, when applications are even open for additional names.

"As part of the deal, rents for units in the new affordable housing project will not exceed 80 percent of market rate rents," the Reno Gazette-Journal reported on Feb. 29.

"The proposed new apartments are not considered low income," the RGJ added. So "affordable" is just PR spin.

In order to acquire a 60-unit downtown apartment complex from RHA, Jacobs has promised spend \$20 million on a 65-unit "affordable" (?)



housing project in the same area starting construction no later than 2028.

Taxpayers should expect a lot more than five additional apartments for \$20 million. I'm sure it will provide nicer accommodations, but the cost for each additional dwelling comes in at \$4 million. Economists might say the marginal benefit is a bit expensive.

I've lived here since 1971 and I've seen developers come and go. They always make big promises. If something doesn't happen as planned, chalk it up to unforeseen circumstances.

A year or two from now, Mr. Jacobs may get a monster offer from Wall Street megabillionaire speculators and retire to a private island. Empty Lots R Us.

Reno and Sparks have seen the future and it looks like apartments designed like minimum security prisons, emulating the fashion sensibility of Cold War Communist East Berlin. (Barbwire 11-15-2023)

Based on so many other big announcements that underwhelmed and underperformed, if they performed at all, city hall and the housing gods better hire some damn good lawyers to make sure that J doesn't stand for jinx. Or "just kidding."

WHITED SEPULCHER DEPT. As I reported last week, Jacobs lawyer Gordon Garrett sent me an e-mail asserting that my bulletin containing the rallying cry from Rev. Dr. Whitlock-Lax was "Completely false. I would appreciate the opportunity to provide you with correct information."

I thanked him for his response and asked for the material. I'm still waiting. At Reno City Hall last Wednesday with news cameras rolling, Mr. Garrett was all sweetness and light. He even shook hands with the good reverend. Nary was heard a discouraging word. Alleluia.

HOPE FOR THE POSTAL SERVICE. President Biden has nominated former Boston mayor and secretary of labor Marty Walsh to serve on the U.S. Postal Service Board of Governors. He is currently executive director of the National Hockey League Players Association, the athletes' union.

Only a majority of the board can remove the postmaster general. The post has been held since 2020 by MAGA Postmaster Generalissimo Louis the Clueless DeJoy. ## Inadequate Snow plowing impacting public safety

My name is Ralph Whitten, residing at 1165 Dutch Hollow TRL, Reno 89523, part of Sierra Canyon (Del Webb) and Somerset. I am writing to make sure that the council and the mayor are aware of the inadequate and unsafe snow removal in my area. Today, as is common several times most winters, we have over 2 feet of snow on our street. The street has not been cleared since the storm started in earnest 36 hours ago. The streets in this area slope up from Del Webb Parkway making it difficult or impossible for even 4-wheel drive equipment with chains to travel uphill to reach this area. In fact, several high clearance, 4-wheel drive vehicles became stuck on the street over the last 24 hours.

This represents a significant loss of public services for the elderly residents of this area. Emergency responses such as Medical, Police, and Fire response would be unnecessarily difficult or impossible under the current conditions – responses would be significantly delayed or obstructed by the lack of basic snow removal services. Imagine Fire, Police or EMT vehicles having to be abandoned ½ mile from the incident after becoming stuck in the snow or stuck behind other stranded vehicles. In addition, the first responders face unnecessary personal safety hazards if a response were required.

I recognize that the western part of the city is a bit different than the portions further to the east, but it is time for the City of Reno to recognize the differences and take steps to ensure that the basic public services funded by our tax dollars are available to my family and my neighbors when it snows. I further recognize that equipment for snow removal is expensive, and if it has been deprioritized as a budget control effort, I applaud such fiscal responsibility. If this is the case, perhaps private contractors could augment city equipment for snow removal as is common in cities across the country.

I believe it would be a reasonable service to the many taxpayers in Somerset and Del Webb to open the roads at least minimally every 12 hours. Even 1 or 1 1/2 plowed lanes would allow emergency access.

Good morning ~~Mayor Schieve~~, council members, staff, and fellow citizens. I'm Bill Miller, Climateer and resident, here once again representing the climate of our fair city.

First up, as always, is to acknowledge this council for taking climate change seriously and to thank you for the many actions you have taken. And second, to encourage you to do what you are likely to do when item D-2 comes up for discussion, which will be to accept the recommendations of the RTC for their 2025 plan. This is all good, but as you are aware, nowhere near enough.

The global heating crisis is here, now, sitting right on top of us, right here in Reno. We are experiencing a weirdly warm, record setting winter, warmer than last winter, which was warmer than the one before. So warm, in fact, I've left the hose attached to my backyard faucet all winter and have been able to refill my birdbath almost every morning. That should be terrifying. Yet we mostly go about our lives worrying about other things.

Intellectually, we are caught in a paradox of our own making. With the internet, we have access to virtually all the facts that have been accumulated over millennia, yet millions are choosing instead to believe absurd, fact-free conspiracy theories;

essentially choosing superstition over reality. One recent superstition that lingers in spite of mountains of evidence to the contrary is that all climate science is fraudulent. Even our own governor has withdrawn Nevada from the Paris Climate Accords, citing no actual evidence.

In truth, climate doesn't care what we believe any more than gravity. If I jump off the top of this building, I can believe I am flying, but will crash into the sidewalk and die a very messy death. Same if I am pushed—and although my experience of falling will be different, the end will be the same. But if instead, by using my rational brain, I walk away from the edge and slowly come down the stairs, I will survive and be able to prosper.

But how to get billions of people to do that simultaneously is the trick. Climateers is offering an idea: make it uplifting; make it fun. We are hosting a Confab in April you will be hearing more about to bring the climate-concerned community together and shift into a higher level of engagement.

Meanwhile, Council, keep up the good work. Our lives depend on it. Thanks for your time.
