Two letters distributed to Council from Valerie Truce and Sophie A. Karadanis, Esp.

Jeff Foster, City of Reno Development Services Associate Planner, gave the staff presentation. The presentation included new recommended conditions of approval to address concerns in the appeal from the Washoe County School District. Mr. Foster answered questions from Council regarding the proposed additional conditions.

Mike Mischel, City of Reno Development Services Engineering Manager, answered questions from Council regarding traffic concerns. He stated that in this area he would expect, based on the Regional Transportation Plan (RTP), that there would be a roundabout constructed at Rio Wrangler Parkway and McCauley Ranch Blvd., and one at Rio Wrangler Parkway and Steamboat Parkway within the near term or five years. There are other improvements in the area that will also benefit the overall traffic. One of them is the extension of Rio Wrangler to South Meadows. Also planned but not in the near future is an extension of Western Sky Drive to Geiger Grade that would also help traffic in the area. He confirmed that the two roundabouts are mitigation measures that would address the traffic in the area. This applicant has done the best job they can as far as mitigating impacts. The one hour staggered start and stop times for the school has a dramatic impact on the level of service at these intersections. He confirmed that for this project the traffic impacts will be mitigated.

Kyle Chisolm, Appellant, Washoe County School District School Planner, stated the School District has worked with the applicant and city staff and came up with what they believe is a good and fair resolution to their concerns which were primarily related to the pedestrian safety in the area, primarily on McCauley Ranch in front of the high school. Their concerns have largely been addressed

with the two additional conditions proposed in the city staff presentation.

Mary Harger, Appellant, presented their appeal. The presentation included a summary of the relief or action they are seeking for mitigation of impacts.

Council Member Reese suggested taking a break to allow time for Ms. Harger to talk with the applicant regarding her suggested requests.

Andy Durling, Applicant, Wood Roger on behalf of the Applicant (Life Church), appreciated Council's recommendation to have a conversation during the recess and stated he does not know that they have resolution on that. The proposals from the Damonte Ridge HOA are not things they feel have a direct nexus from their development. He gave the applicant presentation and answered questions from Council.

Paul Patocka, Reno Fire Department Battalion Chief, answered questions from Council. He stated this area has enough egress to be able to get residents out of the area in a timely fashion and the road can handle all of their emergency response equipment. He also stated that during heavy traffic conditions in any area there will be a response delay.

Loren Chilson, Headway Transportation, answered questions from Council regarding the traffic study. The school project is on the order of 25 or 30 percent of the current traffic, but there is so much more going on than this school. The school is not the majority of the problem on this roadway.

Mr. Durling answered questions from Council and stated this request is an administrative review and they don't normally go to the NABs, but they did host a neighborhood meeting using the same notification requirements the City uses and only two people came.

Mr. Foster answered questions from Council and stated that staff analyzed all of the applicable code requirements based on the proposed use and surrounding land uses and staff was able to make the determination that this project, as conditioned with the additional conditions presented, meets the standards and no additional mitigation would be required.

Angela Fuss, City of Reno Assistant Development Services Director, answered questions from Council regarding the suggestion for a 15 mph speed limit on Rio Wrangler. That is something they can work on but she would defer to the Public Works Department to work out the details. Rio Wrangler is an arterial roadway and it would only apply to the school zone during school hours and where there is a park with a playground.

Ms. Fuss also answered questions from Council regarding the process for evaluating requests for minor conditional use permits and how they consider compatibility along with addressing traffic impacts. This is an area where schools exist today and the capacity of the road can handle the added trips from that will come from this school. Staff will work with the Regional Transportation Commission to try and get the roundabouts installed in a faster timeframe.

Dale Keller, Regional Transportation Commission Deputy Director, answered questions from Council and explained the process and background information for determining the need for the two roundabouts. He stated they are not in the five year window for their Regional Transportation Plan (RTP), however this project would be considered as they move forward on the RTP update. Working with city staff and understanding that this is a priority, how projects are prioritized regionally is we evaluate what the needs are for the region. He stated that he can't commit tonight that this would be in the five year window but it would be under that consideration if it is a priority by the City of Reno to move forward.

Mr. Durling answered questions from Council regarding the proposals from the Damonte Ridge HOA appeal. He reviewed each of the requested proposals and explained how they are all outside of their control.

Ms. Harger answered questions from Council regarding the result of the discussion with the applicant during the recess. She stated that the applicant refuted the data that was presented as not being accurate when it came from their traffic study. They admitted to their 30% current contribution to traffic but are not acknowledging their total contribution to the traffic being 48% with the addition of this project and are not willing to do any concession at this point.

Council Member Duerr expressed concern that traffic impacts would not be mitigated until some later time. She would like to see the traffic mitigation

projects included in the RTC's five year plan. She can not make a motion to support the administrative decision because she cannot make the findings without a commitment to address the issues. She would prefer to make a motion to have the parties collaborate, including city staff and RTC, to actually come up with a plan so we can move forward with confidence and not to approve it as it is today.

Discussion on the motion:

Mayor Schieve agreed that there is still a lot of work to do but it is on our end. The traffic mitigation projects are warranted to be in the RTC Plan. She discussed the difficulty of this decision and can see how hard this is on both sides. She also stated that Council Member Reese and she will be very dedicated to this project over at the RTC.

Motion failed.

Council Member Taylor made a motion to modify the administrative decision with the two additional conditions requested by the school district.

Discussion on the motion:

Council Member Duerr stated she does not think this is at the level that it needs to be to move forward. It is not a good example of planning that is very incremental.
