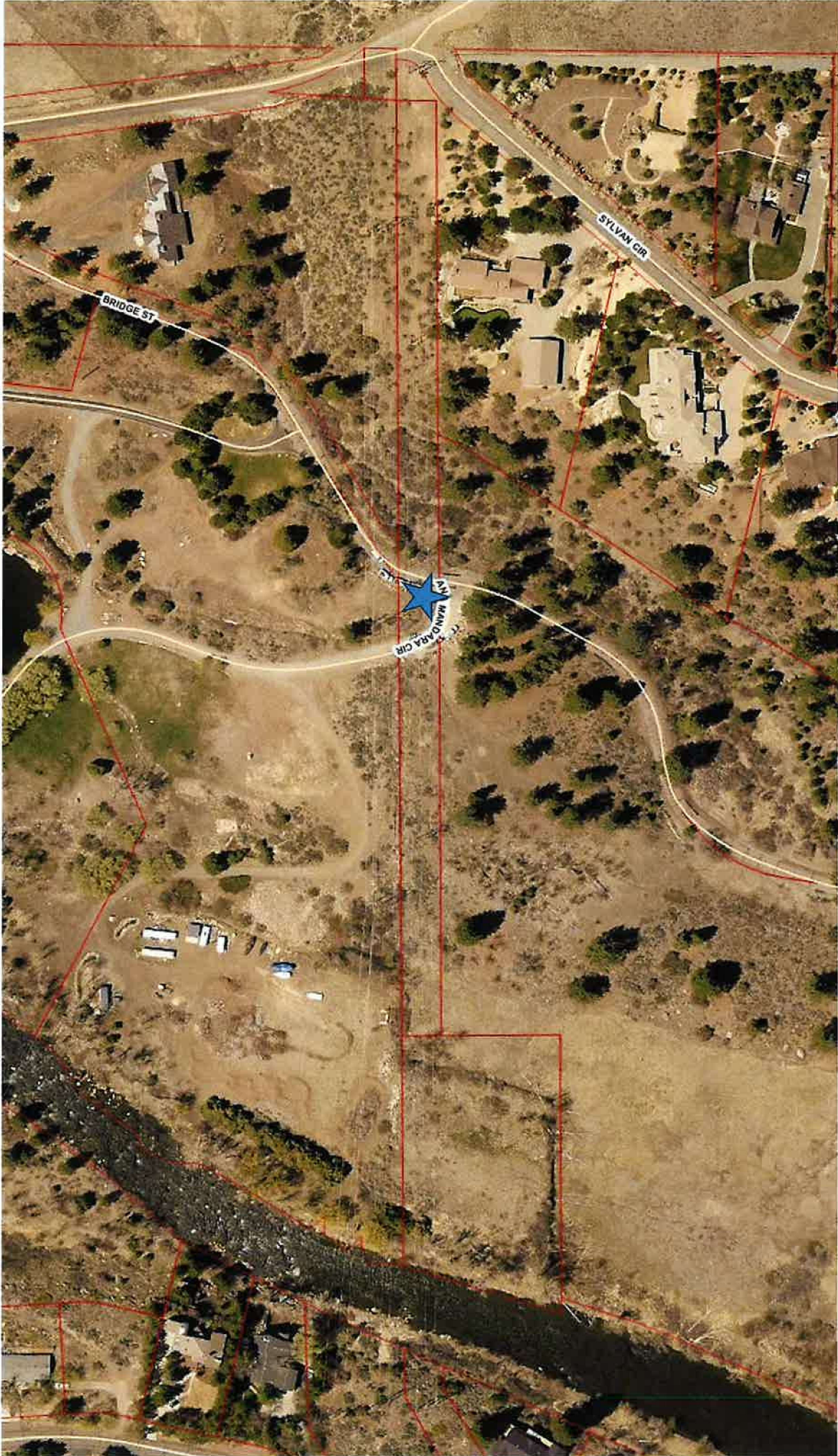


# Sign Posting Locations LDC24-00015 (NV Energy Utility Corridor)



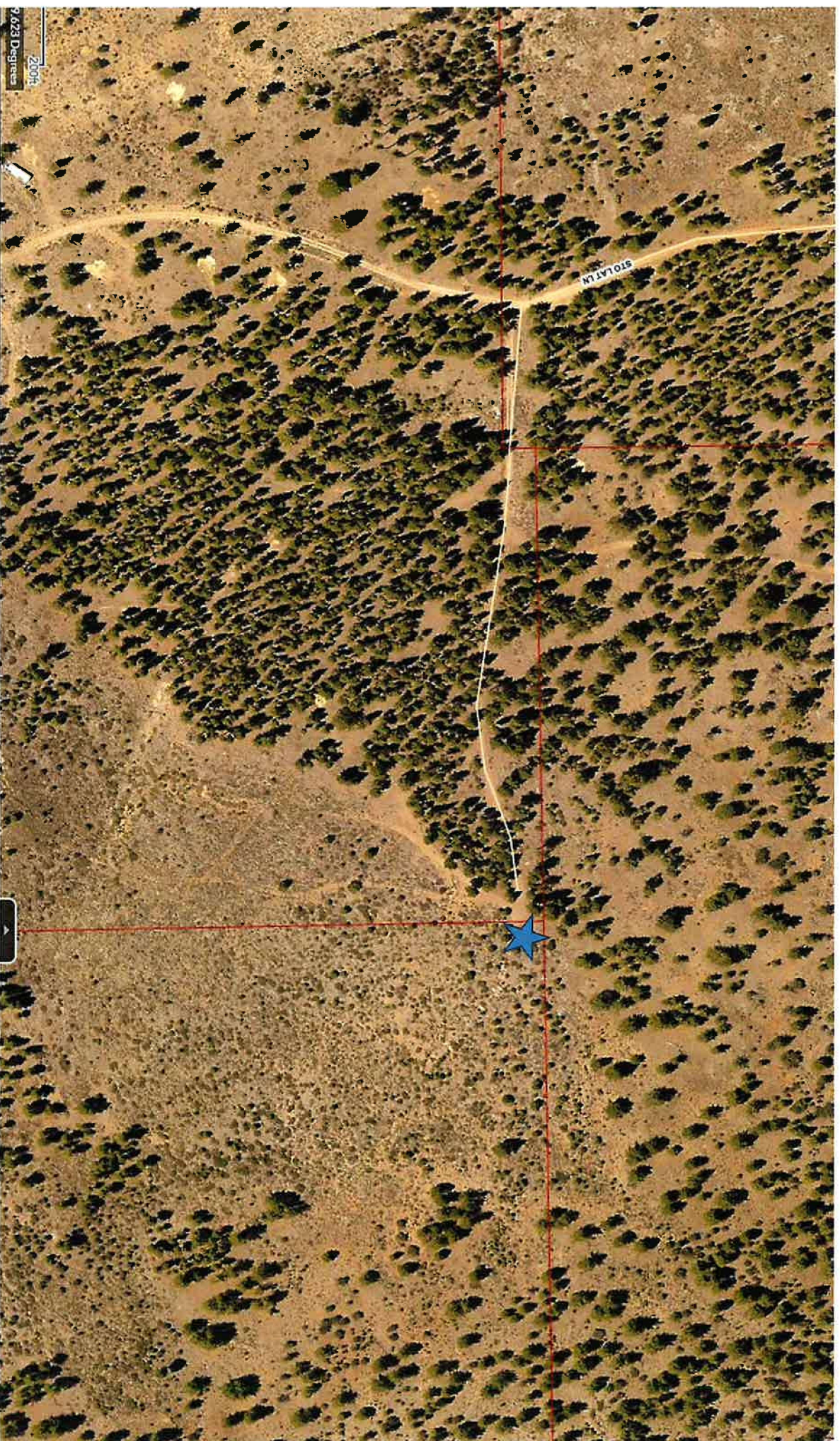


**Sign Posting Locations LDC24-00015 (NV Energy Utility Corridor)**



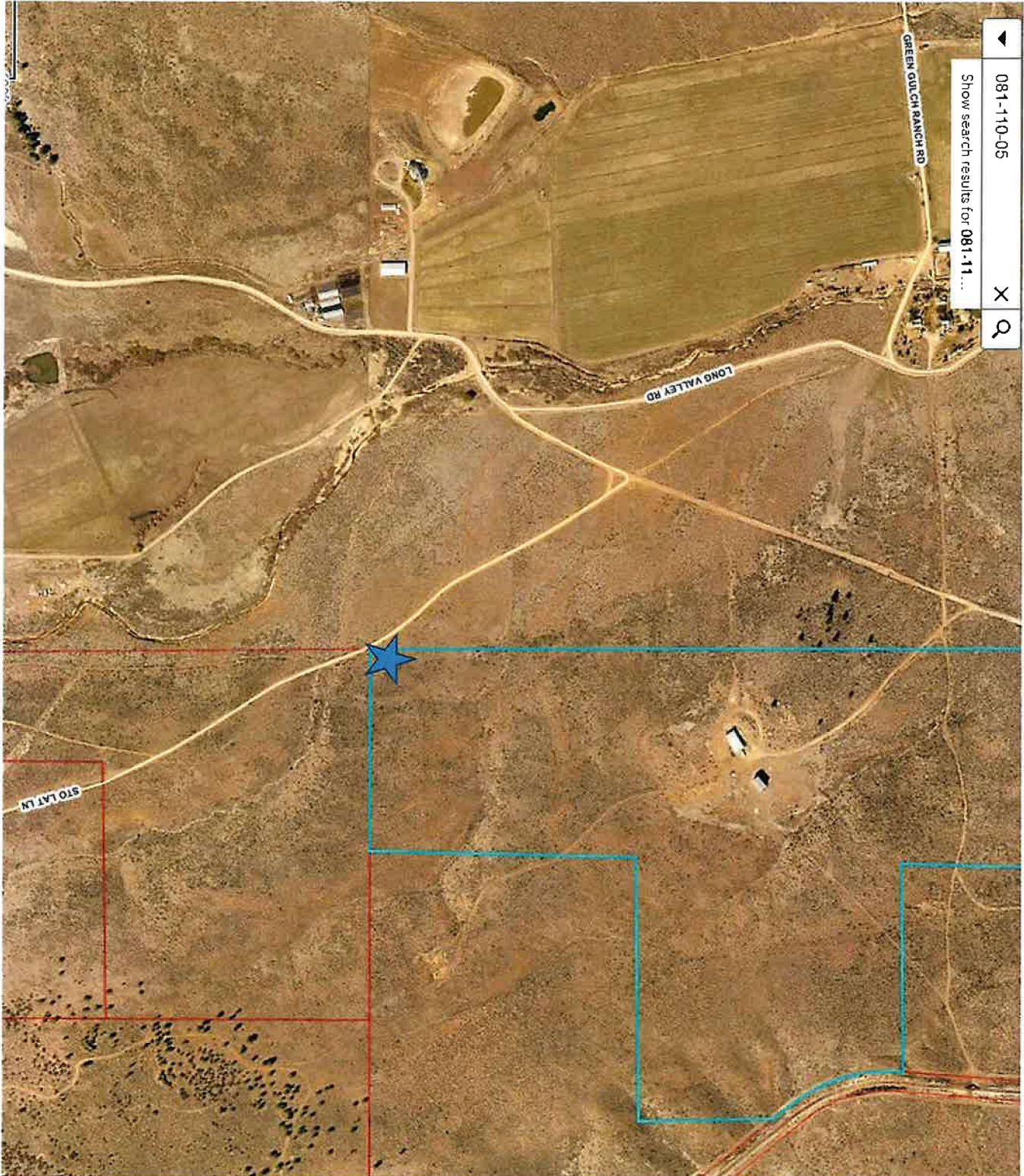
