During the last code changes the City grouped together all the temporary signs into one group. The 95 calendar day limit on temporary signs doesn't work for real estate and development signs. Both residential and commercial real estate listings are typically 6 months minimum with commercial often 1 year plus.

The real estate industry and our sign industry would request that real estate and development signs be separated from the rest of the general temporary signs.

Hi Lauren,

On behalf of the Board of Scenic Nevada, thanks to you and staff for providing the stakeholder meetings and setting up a meeting for us and the school district representative. In addition to the issues we've discussed at those meetings, we have further concerns that we hope you take into consideration before you and staff complete an internal review on the school sign draft regulations.

Digital signs now are prohibited in all residentially zoned neighborhoods and in neighborhood commercial zones and therefore schools rely on static message boards that aren't usually even lit at night. In fact, today, no business within 750 feet of a residentially zoned property can have a digital sign without a public hearing and a conditional use permit. The proposed regulations represent a sudden, radical and transformative change to residential neighborhoods, where most schools are located.

The proposed regulations we object to include hours of operation, which now are set at 6 a.m. to 10 p.m., whether anyone is there or not, messages constantly flipping every eight-seconds until 10 at night, 365 days a year. The proposed regulations would allow up to two digital signs per school and both would be operating when the school is not in session and there are no events (holidays, weekends, school breaks).

Scenic Nevada's suggestions would limit digital sign operations to 6 a.m. to 6 p.m., unless there is an event, and then the sign must be turned off 30 minutes after the event ends. We want to limit message changes to once every hour but are willing to accept every 15 minutes. The digital sign should be static (no flipping) or turned off during school breaks, holidays, weekends or whenever schools are closed. And we are requesting only one digital sign be allowed per school no matter how many street frontages there are. Typically, each school has only one static message sign that can't be viewed at night because they aren't lit. Allowing not one but two digital signs to operate until 10 p.m. is a sea change that would be detrimental to the neighborhoods.

Another concern is the constant, unrelenting advertising going on at schools all over Washoe County and probably the state. Schools allow large plastic banners advertising local businesses which are attached to the chain link fences fronting the streets (see photos attached). Mt. Rose Elementary School has 21 of these banners and only one is a Washoe County School District sign. How soon after the schools start putting up digital signs, will the principals allow businesses to advertise for a fee. Schools are doing it now with the banners.

These electronic signs could become mini digital billboards on our residential streets. We see an eight-second flip time as a temptation to alternate school messages with

advertising. Something, homeowners would have to live with once a permit is granted because of first amendment rights issues. And, of course, the requirement for a public hearing and a conditional use permit is being removed under the new regulations so residents can't even object to this nuisance. If schools were required to limit the flip time to every hour or even 15 minutes, perhaps, that temptation would evaporate. The sign would be used for its stated purpose to allow schools to communicate its messages not earn advertising fees.

Under the weak regulations proposed, the danger becomes the larger issue of private and public schools serving as a beachhead for sign companies to open the doors to digital signage for professional offices and businesses inside residential neighborhoods leading to an onslaught of digital signs in places where they never were allowed before. This issue is not just about digital signs helping public schools communicate with their school community, it's about how this allowance based on digital billboard standards normalizes the commercialization of residential neighborhoods.

The draft that is eventually approved will affect many neighborhoods. According to the Washoe County School District map (attached) there are 117 schools collectively in Reno, Sparks and unincorporated Washoe County. That represents a lot of digital signs, especially if some schools are allowed two. We need to consider the neighborhoods and draft reasonable regulations that protect residential property values and preserve neighborhood streets from the negative impacts of digital signs.

I am opposed to allowing all businesses in the downtown Mixed-Use – Entertainment District (MD-ED) the same, almost unlimited, signage as casinos.

City staff has prepared changes to the sign code to allow any business – from pawn shops to liquor stores – in the downtown district in addition to casinos to have 100-foot-tall signs with no limit on number, size or types of lighting.

This is an invitation for more digital displays as big as those put up by casinos. It's also a license to expand sign clutter and further degrade the aesthetics of our city. And having unlimited signage in the "entertainment district" will encourage applications for zone changes by nearby businesses who happen to be outside the entertainment district, so that they can have unlimited signs flashing day and night, too.

Downtown has a reputation as a tired looking honky-tonk of a place. There is no reason to allow more tacky digital signs and unnecessary sign clutter to make it worse. Please protect our downtown from further degradation by scrapping this proposal to allow non-casino businesses practically unlimited signage regulations that have always been reserved for casinos.

Hi Lauren,

The Scenic Nevada Board has some suggestions for school digital sign regulations, and I hope we can discuss these during next week's stakeholder meetings. Some of the following suggestions are incorporated in the current draft but some are not. This is what we are hoping for:

- No animated sign shall exceed 3,000 nits between sunrise and sunset – The messages can be viewed at 3,000 nits; 5,000 daytime nits are a waste of energy compared to static signs which use no energy at all.
- Signs shall automatically adjust/dim due to changes in ambient light, such as inclement weather.
- The display brightness does not exceed 150 nits between sunset and closing.
- Displays do not appear to be in motion, flashing, or have video.
- Messages change no more than once an hour, unless there's an emergency, and must be instantaneous – Each sign can display several messages at once just like static signs do; more than once an hour is a visual nuisance; this is a very big change, property owners in residential neighborhoods have never been subjected to digital signs on their streets before. It may cause less concern and be more compatible to limit the flip times to once an hour.
- Sign size is 32 square feet.
- Maximum sign height is six feet – digital signs are more intrusive, especially after dark, six feet is tall enough to be viewed from the street.
- Monument style signs only – they are more attractive than pole signs which are more common on commercial streets and would be more compatible with a residential neighborhood.
- One Digital sign facing the street per campus – There should be a limit on number to limit the possible nuisance to neighbors.
- Sign operates from 6 a.m. to 6 p.m., unless there is an evening event and must be turned off 30 minutes after the event ends; even neighborhood commercial businesses are not allowed digital signs; unless the operation of school signs are kept to a minimum to closely resemble or emulate a static sign, other businesses may ask for them too; schools are not a commercial business that keeps commercial business hours; having a sign operate until 10 p.m. doesn't fit in with a residential neighborhood.
- Signs should be turned off or at least remain static when school is not in session or there are no evening events - Operating the sign 365 days a year until 10 p.m. doesn't fit in with a residential neighborhood and is unnecessary when there are no children or parents coming to the school.
- All digital signs should follow ADA guidelines

We think the school district should be allowed to take advantage of the computer technology to change the messages on their reader boards, instead of doing it manually every day. But we don't think the draft regulations presented so far strike a balance between the school district's desire for digital signs and protecting residential

neighborhoods from the visual distraction and nuisance that these digital signs create. We hope you will consider our suggestions.

Hi Lauren,

I have been thinking about the banked receipts program for a while now. As it is written the program has failed, as evidenced by the fact nearly all banked receipts have expired unused. The program has also entrenched the very small number of players, predominantly publicly traded mega-corporations, who hold those receipts as nearly the only players in Reno's outdoor advertising landscape, excluding all others who might potentially be interested to develop and operate the displays allowable under the program, and thereby stifling competition. Finally, the program has failed to meet its prima facie goal of seeing a specifically limited number of new off-premises signs constructed, subject to the strict criteria outlined in the City's other off-premises sign regulations.

Stakeholders who are negatively impacted by the failure of the banked receipts program include:

All outdoor advertising companies who do not hold banked receipts;

Businesses who would like to employ outdoor advertising but either can't find displays on which to advertise due to the lack of new construction, or can't afford the existing displays due to the competition-protected position enjoyed by current outdoor advertising operators, and the insufficient supply of off-premises signs the current banked receipts framework perpetuates;

Consumers, who are less able to be informed of useful information than they would be in the presence of a more balanced program, whether such useful information is of a business advertisement nature, a public service announcement nature, a community event nature, a charity/non-profit messaging nature, an emergency nature, or otherwise;

The City of Reno, who 1) would earn more tax revenue as a result of increased sales generated by businesses located within the City who would utilize off-premises advertising if better afforded the opportunity, and 2) could potentially enjoy a platform for the communication of city-centric and/or emergency messages to city residents via off-premises displays.

I propose an amendment to the code with regard to banked receipts. Namely, to allow a one year period during which, for each expired banked receipt any qualified applicant may apply to the City for an off-premises sign permit, subject to the City's off-premises sign regulations. After said one year period, the open window would close.

Such an amendment would allow for a very limited number of already authorized off-premises signs to potentially be constructed, as was the vision at the outset of the banked receipts program. In addition, the amendment would help fulfill the City's duty to provide a robust



environment within which its businesses are provided the best possible opportunity to succeed.

The City's population has grown and continues to grow quickly since the banked receipts program was implemented. Off-premises advertising opportunities have not kept pace with the city's growth, and this change to better fulfill the program's vision of a limited number of new off-premises signs is one way in which the City can support its business community and its residents.

The anti-competitive environment inadvertently perpetuated by the current banked receipts program is unaligned with the core values and principles of the City of Reno, the State of Nevada, and the United States of America. At this juncture, while Title 18 is being rewritten, the time is opportune to rectify the program's inadequacy in this regard, as well as its overall failure to achieve its vision.

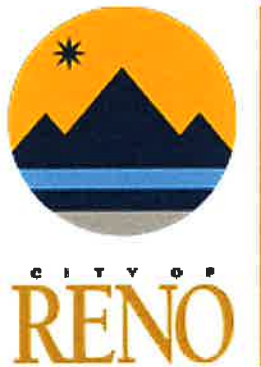

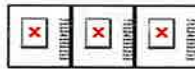

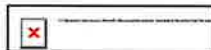

Thank you for being concerned enough to read this. Im sure there are manybpressingvmatters.

As an avid aviator and matter astronomer I strongly oppose digital signage. Creating a darker sky will increase tourism and the jobs they bring.

The city staff is moving forward with proposed changes to Reno's sign code to allow all public and private schools to replace their signs with digital versions.

City staff intends to submit a set of digital sign regulations for approval to the Reno Planning Commission on May 8. While the staff's final draft won't be released until at least April 25, the current draft shows regulations, that if approved, I believe would forever change the character of our residential neighborhoods.

The most egregious includes rotating messages every eight seconds and operating digital signs until 10 p.m., long after schools close for the day; 365 days a year whether schools are in session or not.

I urge you to consider implementing Scenic Nevada's suggestions below instead to protect the quality of life for neighborhood residents, like me.

1. The city is proposing an eight-second sign rotation. Scenic Nevada opposes this and supports a fifteen-minute sign rotation.
2. The city is proposing operating hours from 6 a.m. to 10 p.m., 365 days a year. Scenic Nevada opposes this and supports operating hours from 6 a.m. to 6 p.m., or until the last school event ends; active only during school sessions (sign inactive on weekends, holidays, and school breaks)
3. The city is proposing that schools with two street frontages can have two digital signs in some areas. Scenic Nevada opposes this and suggests one digital sign per school.
4. The city is proposing height, sign style, and square footage based on zoning district; digital portion limited to 32 square feet. Scenic Nevada opposes this and suggests monument style signs only, 6-foot maximum height, 32 square feet total sign area.

The reasons I object to digital signs are:

Good afternoon, Lauren:

In the spirit of giving a fair hearing to all Downtown stakeholders, I attended the Zoom meeting at noon on November 18. I was truly interested to hear comments from the business community, so I am disappointed none of them spoke.

My comments are informed by recent comments presented to the Council on November 13 by the City Revitalization Manager, Bryan McCardle, in the Monthly Downtown Report. I will highlight some excerpts of his written and oral presentations relating to Downtown Residents' important role in what he calls "Strengthening Economic Conditions". In short, my case is that the current signage code that allows by right excessively large and bright signs for all non-gaming businesses is outdated and contrary to Bryan's comments regarding the current and planned growth of Downtown residency.

Under the heading of "Strengthening Economic Conditions", Bryan emphasized several actions and desired outcomes related directly to the importance of increasing the number of Downtown residents, as well as some relevant current data. For example:

- The City is actively creating initiatives aimed at increasing Downtown housing.
- The City wishes to increase Downtown residential density. Also, historically, CM Duerr expressed an opinion that there is no more "easy" land to develop; CM Reese also expressed the goal that housing be built "up" rather than "out". I therefore interpret Bryan's statement to mean that the City wants new housing Downtown to be both infill and in multiple-storied buildings. Increasing density means that, per square mile, there is a much higher number of residents that will live in very close adjacency to casinos and businesses.
- In September 2024 alone, 574 residential units were completed Downtown.
- At this time, there are 2,528 residential units in the pipeline Downtown.
- In the last month, the residential unit growth rate Downtown was double that of the last 10 years.

The Montage has 387 units; the Riverwalk approximately 200 units; the Palladio approximately 80 units; Arlington Towers approximately 300 units; the Belvedere approximately 150 units; plus, Park Tower, the 3rd Street Flats, the Mod 1, the Mod 2, Eden Tower, etc. Adding Bryan's numbers to these existing residences, I would estimate that this equates to 5,000 units and at least 7,000 residents.

This growing and significant number of Downtown residents are absolutely critical to Bryan's statement that the City must "increase street level activity by attracting thriving businesses". Rather than depend upon seasonal tourists or special events patronage alone, 7,000 permanent Downtown residents are essentially a semi-captive day-to-day customer base with a high-income level. One might say: "Catnip to new businesses"! Our purchasing power is what will drive economic growth Downtown.

All this said, I therefore contend that the wide-open signage code for our MD-ED zone, which allows all non-casino businesses to erect excessively large and bright signs equivalent to those allowed for casinos is in need of change. The protections offered to mixed use district residents outside of Downtown from excessively large and bright signs (and, incidentally, from excessive noise) should also be offered to Downtown residents in the MD-ED district.

The casinos are still a significant stakeholder in Downtown, as are the existing businesses. However, this is a new era when residents deserve more consideration from the City to make life livable Downtown. I respectfully propose that Downtown's mixed use district should be treated the same as all other mixed use districts in Reno, where residents are protected from the negative effects of excessive signage (and noise).

Thank you for your time meeting with WCSD staff regarding the potential Sign Code Update anticipated to go to the Planning Commission and City Council for feedback in November and December of 2024, respectively. We appreciate the opportunity to provide input on the matter.

As you well know, many WCSD school Administrators are desiring to have animated (digital) freestanding signs installed in order to help effectively communicate with the communities, neighborhoods, parents, and students. Most schools in Reno currently have freestanding signs that require manual labor in order to change the content and messaging of these signs. Being that these signs function as a type of official government sign that communicate important public messaging to our communities, we feel that including changes to the sign code in order to allow animated signs for schools should be considered. Also, animated signs are the way of the future as they are easier to read, provide enhanced engagement, and can be easily modified to provide real-time updates. Perhaps most importantly, animated signs would allow for schools to convey important safety and security messages to the community in a more timely, effective, and efficient manner. Safety of our schools and student must be a priority and these signs would help with any such communication.

Currently many or all WCSD schools are located in zoning districts that do not allow animated signage at all (they are prohibited). This is not consistent with other local jurisdictions and is not consistent with certain State laws that require zoning consistency for schools.

We understand that animated signs may be concerning for certain members of the public and that perceptions of these signs differ. However, we also understand that many of these concerns may also be mitigated with thoughtful and collaborative code updates and processes. We look forward to continuing this collaboration and believe that there are solutions available that will best serve the City, the community, and our schools.

I am Peter Chase Neumann, residing at 1 Elm Court, Reno, Nevada which is adjacent the south bank of the Truckee River and 250 west of the Promenade Center for Independent Living near the west end of Court Street. My home was built by Senator Frances Newlands, in the year 1890, the same year he built his residence, which is 200 feet west of my home.

I respectfully oppose the proposal to expand the city code (as it applies to casino sign regulations) to allow any other downtown Reno business owners or operators to construct, permit, or display additional billboards or signs on their owned or leased properties in the downtown Reno district.

I believe that to do so would be in violation of existing law, and the court-approved stipulation that was entered into and ratified by the Reno City Council and Scenic Nevada organization, in settlement of the long-standing litigation between those two parties.

I also believe that to expand the venerable negotiated settlement giving additional businesses such as bars, pawn shops, tattoo parlors, or any other business properties the right to construct large billboard sized outdoor "signs" would have an additional adverse effect upon Reno's downtown area, which is already affected by many adversities.

Thanks very much for your email. My questions were what are the boundaries of the downtown entertainment district and how many parcels would get the casino signs, under your proposed draft. The map of the "Entertainment District" below, which is about as big as my thumbnail, doesn't really help. But looking at your second red-lined draft version (attached), the Gaming Overlay District on the sign chart was replaced with the MD-ED (Mixed-Use Downtown Entertainment District). The attached map of the MD-ED is from the GIS maps on the city's website. My understanding from your email is that every parcel in the MD-ED will be able to have 100-foot-tall signs by right that can be gigantic digital jumbotrons, because there are no limits on number, size and lighting.

I don't understand your reference to Section 18.08.405. As far as I can tell, it does not exist today in municipal code. I tried to find it in the Zoning Code on the city's website. It jumps from 18.08.403 to 18.18.501. The same is true for 18.16.207 and the table at 18.16-1. It doesn't exist in current code as far as I can tell.

What I think you may be trying to explain is that in an old code somewhere there was a reference to allowing the old DRRC designation to have large signs. That designation was removed and replaced with Gaming Overlay. You say, "When the new zoning code was adopted in 2021, the DRRC designation was deleted, and the new signage language was changed to reference the "Gaming Overlay District".

And, apparently, when that happened someone "inadvertently" forgot to append Footnote 11 to the Gaming Overlay section of the chart. I'm attaching the first red-lined version you presented



to the planning commission in March and April. You told the commissioners that the change was meant to **correct errors** in 18.05.113, the sign chart. Footnote 11 limiting large signage to casinos was already appended to mixed-use districts, which includes MD-ED, but not to the Gaming Overlay district and you wanted to fix that and did. Look at your first red-lined version of Gaming Overlays in the chart. **My point is that the MD-ED district is not allowed the use of casino signs today.** And the sign code chart says so. Removing the Gaming Overlay designation from the sign code chart and replacing it with MD-ED with casino large sign regulations is not reducing signage as you claim but increasing them in the MD-ED.

The Gaming Overlay Districts may be 1,971 acres but adding Footnote 11 on the sign chart corrected the error you discussed with the planning commission. Giving unlimited signage in the Gaming Overlay to that many properties is ludicrous and was never intended, as you know. Look at your footnote 28 (attached) in 18.02 explaining your reasoning for changing this part of the code to match the sign code chart. It says, "28. This was unintentionally left out. Should only apply to gaming facilities within gaming overlays."

Referring to 18.02, you told commissioners, "The intent was just for the casinos, the licensed casinos to be able to have the bigger signs so we added a clarification. We knew what the intent was. We just missed it in specifying within this specific section of code." You append Footnote 2, the same language as Footnote 11, to the gaming overlay section to correct the error.

Reaching back into past code iterations to justify the proposed change now allowing more signage in the MD-ED makes no sense and will have a detrimental impact, adding more tacky signs to a tired looking downtown. Calling your proposal a reduction in signage is disingenuous at best when you know that large signs in the Gaming Overlay were never, ever intended in the first place. Have any tall signs been approved on non-casino properties in recent years in any of the Gaming Overlay districts you show on your map? I can think of two really awful signs, the green Dollar sign (photo attached) and the old Motel 6 sign, both on South Virginia. I don't know if they are in a Gaming Overlay or not. But both look to be at least 60 feet tall and are two examples of how awful these signs are. Imagine many of these in the MD-ED.

A billboard can only be 35 feet tall. The community voted over 20 years ago to ban these tall signs. The city council also enacted a ban on digital billboards at the urging of Scenic Nevada and the community. Your proposal would open the door to more tall signs with huge digital panels, bigger than a digital billboard, the kind this community has largely rejected as eyesores that ruin property values and the chance of ever improving the aesthetics of downtown. Please reconsider and update the sign code chart to limit the largest signs to casino properties only.

Hi Lori,

Below is a breakdown of answers to your questions on allowed signage:

**Where did the old zoning Code (prior to 2021) allow signage for 100-foot-tall signs with no limit on area, lighting or animation?**

Since 2005, the Reno Zoning Code has allowed all property (regardless of it being a casino) within the Downtown Reno Regional Center Entertainment District and Hotel Casino (HC) zoning district to have 100-foot-tall signs with no limit on area, lighting or animation. This accounts for approximately 146 acres of property.

**Where does the current zoning code allow for signage for 100-foot-tall signs with no limit on area, lighting or animation?**

The existing zoning code allows for signage for 100-foot-tall signs with no limit on area, lighting or animation for all parcels located within the Gaming Overlay Boundary. This includes approximately 1,971 acres. When the new zoning code was adopted in 2021, the DRRC designation was deleted, and the new signage language was changed to reference the "Gaming Overlay District".

Here is a map of where all business are allowed to have signage for 100-foot-tall signs with no limit on area, lighting or animation.

**Staff's recommendation with the Sign Code Text Amendment Language:**

Staff's recommendation is to remove the allowance for all business in the Gaming Overlay District to have signage for 100-foot-tall signs with no limit on area, lighting or animation. Staff recommends that the Code revert back to the language that had been similar to code since 2005 that allowed signage for 100-foot-tall signs with no limit on area, lighting or animation for all businesses within the Entertainment District AND for all legally established nonrestricted gaming facilities. This area is closer to 136 acres.

**This proposed change to the sign code would actually remove signage allowances from the Gaming Overlay Boundary and revert back to just the Entertainment District and Nonrestricted Gaming locations. This has been part of the zoning code for close to 20 years. The Entertainment District is approximately 136 acres, as opposed to the much bigger Gaming Overlay Boundary, which is closer to 1,971 acres. Staffs language proposes to reduce signage requirements in approximately 1,835 acres. Please note that we are seeking community and business input on this change and want to make sure that all parties are aware of the changes.**

Angela,

The sign code was never interpreted by you or anyone else at the city to allow just any business within the Gaming Overlay District to erect 100-foot-tall signs as you suggest below. And you said as much during presentations to the Reno Planning Commission last spring. Attached is the earlier, red-lined version circulated to the community and presented to the planning commission this year. See the footnote 11 proposed changes. It was meant to be changed to, "[11] This section only applies to parcels with legally established Nonrestricted Gaming establishments and does not apply to the broader Gaming Overlay District."

Here's your full comment concerning this change to the planning commission on April 17, 2024: "We added verbiage to the gaming related sign regulations to clarify that they only apply to legally established gaming establishments in the overlay."

You also added, "What we inadvertently did in our - gaming overlay also includes some different buildings that are not casinos and so we don't want the average pawn shop owner or Burger King to have a 10-foot-tall sign. So again inadvertently, we didn't mean to do that, so we just

provided some clarification that if you are in the gaming overlay and you want to use those sign allowances you also have to be a legally established gaming facility. Pretty simple."

At an earlier presentation to the Planning Commission on March 20, you said basically the same thing referring to a change of Title 18.02 having to do with overlay districts.

You said: "The intent was just for the casinos, the licensed casinos, to be able to have the bigger signs so we added a clarification. Again, we knew what the intent was, we just missed it in specifying within this specific section of code. So again, just a clean-up to make more sense and frankly match what was in our sign code. So, a quick cleanup relating to gaming overlay."

Contrary to your statements above and in the email below, you are expanding gaming overlay regulations to others who want to use the gaming overlay regulations and do not have a casino property. Apparently, now you are allowing this flexibility for casino's **"and for parcels zoned within Downtown Entertainment zoning district."**

Can you clarify whether the new redlined version to be discussed next week is just part of code clean up or is this new red-lined version and round of stakeholder meetings the actual sign code update that is supposed to take place?

In my opinion, this is a major change and intensification of the sign code to allow anyone within the MD-ED 100-foot-tall signs with no limit on area, lighting or animation. As you know animated signs can play videos, flash lights, flip, pop and scroll without any restrictions. Imagine a series of signs like the Glow Plaza sign on west Fourth Street. Do you know how many parcels are affected by this proposed change? And can you send me a map showing the boundaries of the MD-ED zoning district?

For the record, Scenic Nevada is opposed to expanding the use of gaming overlay sign regulations to other businesses which are not licensed casinos.
