**A RESOLUTION DECLARING THE TRUCKEE RIVER
CORRIDOR A CITY PARK AND RECREATION FACILITY
PURSUANT TO RMC SEC. 8.23.010**

WHEREAS, Sec. 8.23.010 of the Reno Municipal Codes authorizes the City Council to designate city parks and recreation facilities, under the jurisdiction of Parks and Recreation department; and,

WHEREAS, the City is the owner of certain real property in the City of Reno, which is more particularly described as and depicted in Exhibit A, attached hereto and incorporated herein by this reference (the “Park Property”); and,

WHEREAS, “Park Property” is described as all City-owned rights of way and parks within the following described boundaries: Beginning at the intersection of the easterly line of Booth street with the southerly line of Riverside Drive and the northerly line of APN 011-132-06; thence northeasterly along the southerly line of Riverside Drive to its intersection with the Keystone Avenue; thence northeasterly continuing along the southerly line of Riverside Drive to its intersection with Ralston Street; thence northeasterly along the southerly line of First Street and the northerly line of Eloise Avenue to its intersection with South Arlington Avenue; thence northeasterly along the northerly line of Truckee River Lane and the northerly line of Island Avenue to its intersection with North Sierra Street; thence northeasterly along the northerly line of Truckee River Lane and the northerly line of Island Avenue ending at its intersection with the westerly line of South Virginia Street.

WHEREAS, the Park Property further includes APN 011-132-06; and,

WHEREAS, the described boundaries do not include Keystone Avenue, Alington Avenue and Sierra Street; and,

WHEREAS, the City Council hereby declares the Park Property a city park and recreation facility (the “Truckee River Corridor”).

**NOW, THEREFORE, BE IT RESOLVED BY THE RENO CITY COUNCIL IN
THE COUNTY OF WASHOE IN THE STATE OF NEVADA:**

Section 1. The City Council hereby finds that the foregoing recitals are true and correct.

Section 2. The City Council hereby declares the Truckee River Corridor a city park and recreation facility pursuant to RMC Sec. 8.23.010.

Section 3. The Reno City Council has determined, and does hereby declare, that this Resolution shall be in effect immediately upon adoption in accordance with law.
