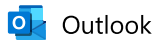

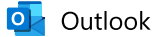

## **Hello my name is Anamarie Flores and the issue I want to talk about is Climate change.**

Climate change is an up-rising issue that's is effecting warming temperatures, change in precipitation and as well as changes in weather events that has made them extremely intense. These impacts threaten our health but affecting the food we eat and the water we drink, as well as the air we breathe. Some temperature related impacts are the warmer days leading to longer and more frequent heat waves, these changes can and will lead to heat related deaths up to at least 1,300 deaths a year but the number is most likely underestimated. Some underlying health conditions include the stress of a hot day leading up to possible heart attack, heat stroke, or other serious health conditions. With climate change it creates conditions that allow mosquitoes to survive year-round spreading disease like dengue, Zika, and chicken gana, Other then that there is also cold weather which isn't as effected but it still is, climate change can impact colder weather by causing disruptions in the polar vortex leading to colder air out breaks in low latitude, but there is still more that climate change effects and that's the air we breath. Warmer temperatures and shifting weather can and been worsening air quality which can lead to asthma attacks and other respiratory and cardiovascular health issues. Some responsibility of bad air quality is the wildfires which are expected to continue and increase in number because of the increase in heat. The increase of temperature can also create unhealthy ground level ozone which is a harmful pollutant. People who are exposed to high levels of ground ozone are at risk of dying prematurely or being admitted to the hospital for respiratory problems, this ground level ozone can damage lung tissues as well as reduce lung function and inflame air walls. This can aggravate asthma or other lung diseases. People with asthma and chronic lung diseases are mostly at risk. More impacts from climate change are extreme weather events, increase of the severity of some extreme weather events such as extreme precipitation, flooding, droughts, and extreme storms, these extreme weather events can effect us in many ways and those effects are reduction of safe available food and drinking water, damaging bridges that block ways to hospitals and pharmacies, interrupting communication utility, and health care services, creating or worsening mental health impacts such as depression and post traumatic stress disorder and many, many more effects.

BUTT! There can be a solution if we all help each other. We can prevent climate change if everyone puts in effort by limiting the use of oil or gas to the diesel that burns with the trucks that use diesel, We can walk or ride a bike or just use public transportation, we can also try switching to led lights and use energy efficient electric appliances maybe try washing laundry in cold water and drying by hanging your clothes!!

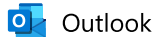

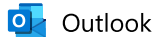

Last year, my little cousin Mia and her family, who have been here in Reno for over a decade who came from Seattle, were forced to leave their rental home after the landlord raised the rent. Despite both my aunt and uncle working full-time jobs, they couldn't find another home within their budget. They had to move into a much smaller apartment outside of Reno which disrupted my cousins schooling and after school programs. Seeing their struggle made me realise how widespread and personal this issue has become.

The lack of affordable housing in Reno affects more than just where people live—it touches every part of our lives. As housing costs rise, families are forced to allocate larger portions of their income to rent or mortgages, leaving less money for essentials like healthcare, education, and savings. For many, the stress of housing insecurity impacts mental health and overall well-being. On a broader level, As workers can't afford to live near their jobs, and this issue undermines basic freedoms, such as the right to a safe and stable home, and raises safety concerns as some individuals are pushed into homelessness or unsafe living conditions.

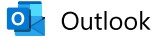

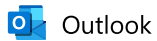

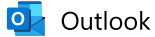

The federal government ignores the treatment needs of Americans with serious mental health conditions. Did you know approximately 10 million Americans live with a serious mental health illness, but only about 68.5% receive any form of treatment. People with mental illnesses deserve safe, effective, evidence-based treatment as well as community resources there is only one agency in charge of helping and addressing the needs of people with serious mental illnesses and they are not doing everything they can to help people suffering with mental illnesses. We need to start prioritizing mental health with the same urgency as physical health. And inflation Over the past few years have affected everyone in Nevada and it's especially tough for those who are in housing I currently live in housing it's just me my little brother and my mom ever since inflation had skyrocketed prices for rent,food,gas, and other accessories it's gotten so bad to the point where my mother, she works as a CNA and shes all around Reno area and everywhere else it's been so hard for her she works two jobs she works from the morning till the afternoon and after she picks me and my little brother up from school she continues off to her second job where she stays over night and it's so tough for her because even with both those things it's still hard for her to pay for her rent and even buy us groceries since she dosnt receive Ebt anymore I try my best to take care of my little brother and the house and I to am also searching for work wanting to help her once again but enough about me it's also for other people who could be in my mothers position. And it's just all affecting our community in a big way. Many of us have felt the pinch, whether we're trying to buy our first home, find a decent rental, or even just keep up with our mortgage payments.

Reno has been growing rapidly, thanks to our thriving job market and the influx of new residents. Companies in tech and manufacturing are setting up shop here, bringing in workers from all over. While this growth is great for our local economy, it's also driving up the demand for housing. More people moving in means more competition for the same number of homes, and that naturally pushes prices up.

But it's not just about more people. We also have some challenges with the supply of housing. Building new homes isn't as easy as it sounds. There are geographic limitations and regulatory hurdles that slow down development. Plus, with the rise of remote work, more people are choosing to live in places like Reno, where the quality of life is high. This trend is putting even more pressure on our housing market.

Today, I would like to talk to you about if there would be a possible way to make the cost of living more easier.

Because of the way life costs, life hasn't been that easy. Sixty-two percent of Americans feel their family's income is falling behind, with 83% of voters experiencing hardship due to inflation and increased prices. This is evident in their spending habits at grocery stores and gas stations, where they often stretch their fuel before a full tank is needed. This highlights the need for increased financial stability and a more balanced approach to spending, as it helps to address the challenges faced by many Americans.

But there's a better way.

We can reimagine how to make life more affordable for everyday Americans. It's possible, if we:

- **Cut the red tape to fix the rising cost of food**

Lower prices on everyday needs such as foods and personal care items like toilet paper, hair wash, feminine products. The Renewable Fuel Standard (RFS) has led to a significant increase in corn prices due to supply-chain issues and excessive government spending. The RFS mandates that transportation fuels contain a certain amount of biofuel, such as ethanol. This has led to a dramatic increase in corn prices, incentivizing farmers to replace other crops with corn and grow corn wherever possible. This has resulted in a scarcity of other foods, which are now scarcer due to less cultivation. The burdensome regulations have not only affected energy markets but also the housing market.

- **Cut reckless government spending and beat inflation through better budgeting**

Congress lacks a comprehensive budget, managing only 30% of spending annually and lacking rules to control overspending and deficits. The federal government has only balanced the budget from 1998 to 2001, but this is the only time it has balanced the budget in the last fifty years. The national debt has exploded from 32% of GDP in 2001 to nearly 100% GDP today, and massive government stimulus spending during the pandemic has not helped. The more money the U.S. government prints and pumps into the economy, the worse the situation becomes. Kurt Couchman, Americans for Prosperity's senior fellow for fiscal policy, has written extensively about how unified budgets can empower congressional members and enable coherent budget management. A unified budget would reveal tradeoffs across fiscal policies, reduce overlap among programs, and control the exploding debt.

- **Fuel the flexible workforce of tomorrow**

One way to address the current economic crisis is to empower people to find fulfilling work that offers freedom and flexibility while helping them achieve personal and financial independence. This is especially important during unstable times. Many Americans are reaching their potential through flexible work.

Over 59 million Americans are freelancers, showing a preference for flexibility in their jobs and greater career satisfaction. Research indicates that 90% of American professionals value workplace flexibility. To support this, we need legislation that facilitates independent and flexible careers and enhances scheduling and work location flexibility.

Four key bills are highlighted: the Employee Rights Act, the Modern Worker Empowerment Act, the Save Local Business Act, and the Working Families Flexibility Act, which together aim to expand work opportunities and flexibility.

We must recognize the true cost of wasteful spending and overregulation. Increased spending and regulations will not solve high costs. We need to empower entrepreneurs and innovators to create affordable solutions, avoiding short-term fixes and instead promoting energy abundance and reducing harmful regulations.

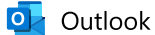

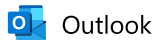

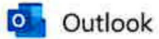
