It has come to our attention that the horses at the Meadow just past Rio Wrangler are fenced out of their water supply. Sunny Hills, the developer of the land, put up a new fence that keeps the horses away from their natural resource for water. Our understanding is that at this time, the developer does not have a permit to build yet, but has chosen to put up a fence that keeps the horses from their water source.

An alternate water source is not available at this time and the horses have no access to water. They are in distress running the fence line and some are even jumping the fence. In this picture, a young foal is too little to jump the fence and so he tries to go through it and gets caught up. Mom is obviously frantic. The foal did make it out after a struggle.


- ***Please advocate to keep the fence open in the Rio Wrangler meadows*** until a new water source is created so the horses can access water and will not get separated, injured, or worse.

Dear Council Members, At the meeting to be held on May 8, 2024, the issue of fencing and wild horses will come up. Currently a fence has been put up by the developers in the Diamonte area that blocks the horses from their water source. The fence has also lead to a foal being caught in the fence. Until another water source can be provided for the horses, and the developers having the proper authorizations, please consider having the developers agree to a temporary access point of entry for horses seeking water.

I realize the developers have to follow certain guidelines but I pray that a comprise can be reached.

I have written to you and other Council Members before of my concerns about horse/car interactions. I believe fully funding the projected horse fencing project that was unveiled at a Ward 2 meeting back in March 2024 mapping out how horses would be safety enclosed on the range and off streets and roads, is the only way to end these interactions. The builders have blocked the wild horses from getting to the water source. Three days ago, photos were shown on Next Door where a mare and foal were attempting to get to the water supply. The foal flipped over the fence, while the mother looked on! This was a horrific event and unacceptable! 

Dear Mayor Schieve and Council Members:

I respectfully submit my comment on the above described agenda item, D.1, as follows:

When the 82<sup>nd</sup> Session of the Nevada Legislature, in 2023 amended Chapter 278 of Nevada Revised Statutes, it obviously intended to require governing bodies of Nevada cities and counties to address the issue of “affordable housing.” (Or perhaps, the *shortage* of it). This is a problem in thousands of communities in our country, and I applaud the Reno City Council’s efforts to comply with this very complex statutory mandate of the Legislature.

Most people agree that the problem of homelessness is extremely serious and urgent. It is heart breaking to witness people of all ages, including many who served their country in military service, sleeping in commercial building doorways, on cold cement, without a roof over their heads. The City of Reno has not escaped this terrible problem, and I am glad to see that its city council is attempting to address it, and making a good faith effort to comply with the mandate of the Nevada Legislature.

Rather than pretend that I have any expertise on this complicated subject, I instead request you to keep in mind the admonition of the Greek Physician, Hippocrates, who is reputed to have said, about 2,400 years ago: “**First, Do No Harm.**” In other words, in attempting to treat your patient, The City of Reno, do not make her worse, by causing her another injury or even death.

My fear is that this Council, in attempting to comply with the mandate, may alter existing land-use laws and regulations in a way that will permit and encourage developers to substantially increase the **density** of land -use, of land which is presently

treated as “single family residential” land. Existing residential neighborhoods which have been used for single family dwellings, should **not** be allowed to be converted into apartment housing or multiple-family neighborhoods.

If you did allow that, real estate developers will build cheap, unattractive structures which will then be sold to commercial interests who will use them for short-term rentals, such as Air B&B’s. And those owners will rent them out **not** to homeless people, because they will not be able to afford them. The owners will convert existing leafy, shady, single-family residential neighborhoods into short-term rentals, and this will not alleviate the problem of homelessness. We have seen that happen in the past and it is not pretty.

It will instead, cause entire sections of Reno to be converted into unsightly, treeless, sad places where the residents will likely have little incentive to improve the property, because (as non-owners) they won’t have any pride of ownership. They will simply be renting space, for short durations, from commercial owners.

So please, **Do No Harm** to your patient, which is the way I hope you think of the body politic – including the taxpayers and permanent residents of the City of Reno – as you deliberate how to comply with the mandate of the Nevada Legislature.

Dear Reno City Council,

I attended the City of Reno Housing and Affordability Initiative Public Workshop #3 via zoom. It should be noted that I did sign up for email newsletters from the City of Reno, but I was not notified via the email of this workshop. It was through a neighborhood email that I was notified. I think that there might be a link broken in your communication process.

I am in agreement that there are Housing and Affordability issues that need to be addressed in the City of Reno. I want to thank the Reno City Council staff that answered my questions. My comments on the workshop presentation are as follows:

- **Specific to Affordable Housing to satisfy SB 213:**

Incentives for Affordable Housing and expedite review of Affordable Housing:

- I am **in** favor with the recommendation to assign a staff liaison to all affordable housing projects during building permit review.
- I am **not** in favor with the Planning Commission recommendation to allow affordable housing projects to be built two stories higher than the zoning allowed. Since duplexes, triplexes and fourplexes are allowed in SF-8 and SF-11, allowing this would drastically alter the nature of the neighborhood.
- I am **not** in favor with the Planning Commission recommendation to remove parking requirements for 5 stories – affordable projects. This clutter and vehicle theft. While on the subject, the City Council should change the code to require apartments to be built with garages in the downtown area. This would be a much-needed proactive step in accommodating the growing population of our city.
- Density Bonus - Affordable Housing. I am **not** in favor of unlimited density bonus if in the city 0-60% AMI range. This seems arbitrary and does not consider the residences who must live in the area.
- I am **not** in favor of allowing for density bonus if you are in 61-120% AMI range. Two weeks ago, the Director of EDAWN informed us of the number of tech jobs that have been brought into the area. The median salary is \$90,000. 120% of this is \$9000/month for rent? This would incentivize Developers to build projects that only tech workers could afford, this doesn't appear equitable.

The changes that the Reno City Council made three years ago to modernize and streamline the code and allow Density Bonus was proactive in addressing the incentive part of SB 213 and adding a staff liaison to help navigate the process would certainly expedite the review process.

I would add that commercial land development should include a percentage of affordable housing be built as part of the project, especially, if they want to attract future employees (i.e. Damonte Downtown). The designated MF areas of the project can be By-Right as well.

Affordable Housing should be incorporated in the development of large apartment units as a percentage of the project. This will not alter the nature of the neighborhood.

- **Specific to Increasing Housing Supply:**

- **Density Bonus - Market Rate** – 12 projects have used Density Bonus in the last 3 years,
  - Staff proposed to increase density bonus to incentivize developers to use it. However, the examples that were given, Motel 6 conversion project and the Wells Ave. project both met their objectives with the current density bonus in place.

I think that the current economy and high interest rates should also be factored in the analysis of whether current Density Bonus has been successful. How many more projects would have come online if the financing and economic climate was more favorable?

- **Allow More Development By-Right**  
All multi-family development with less than 100 units be allowed by-right in MF-14, MF-21, MF-30, NC, GC and PO zoning districts. - Currently these zones require an entitlement review process.  
Public review adds months (2 – 6 months) to the project even though the result is the same at the end of the process.

I am **not** in favor of allowing more Development By-Right. This is where the staff liaison will be beneficial in expediting and streamlining the process, but at the same time get community onboard with the project.

- **Allow More “Missing Middle” Development**  
Council Staff recommends expand where we allow duplex, triplex and fourplex (DTF) units in SF-3 and SF-5 zoning districts with a Conditional Use Permit.
  - Planning Commission recommendations for Missing Middle
    - Allow this all **by-right** in all single-family zoning districts, with no input from the public. Go straight to building permit.

I am **not** in favor of this recommendation. Driving through the SF-3 and SF-5 neighborhoods, it is very obvious that there are many custom and semi-custom homes and custom developments in these zoning areas. These homeowners made the biggest purchase of their life on a 30-year investment and, if they are like my husband and I, they relied on the Reno Master Plan map to make their purchase decision. We actually had a lot come up for sale in Hidden Valley that we were very interested in, but the on Reno Master Plan, it showed what in now Veteran Parkway, planned to be built in back of the lot in the future. It made our decision easy to back out of the purchase.

To make a change to these neighborhoods would be a breach of trust with the homeowners. They most likely purchased during a time before PUDs were the norm and the Reno Planning Map was the PUD.

One of the unintended consequences of allowing DTFs in these zones would be to incentivize Developers to outbid single family homeowners on homes and redevelop the lot into DTF units. This would change the nature of the neighborhood drastically for the worse and prompt some questions:

- Would homeowner insurance in the area increase as a result of the mixing of MF and SF zones?
- Would there be an increase in property tax rates?
- Would neighbors be able to band together and create CCRs for their neighborhood to exempt them from allowing DTFs?

Even though the staff noted that DTFs are currently allowed in SF-8 and SF-11, I don't agree that it should have been a blanket change of all the SF-8 and SF-11. Certainly,

there are areas that may benefit from this change ie neighborhoods that are in close proximity to downtown, but this clearly is not something that is good for all neighborhoods.

Unfortunately, not all of us have the good fortune of Councilman Reese to live in a PUD, but we should be respected for the decisions that we made to invest in an area zoned for single family residences and to have the peace of mind that we will not have the proverbial rug pulled out from under us.

Thank you for your consideration of my comments in your decision.
