# Community Court Funding

2023

- Office of Justice Programs enhancement four-year grant \$899,976

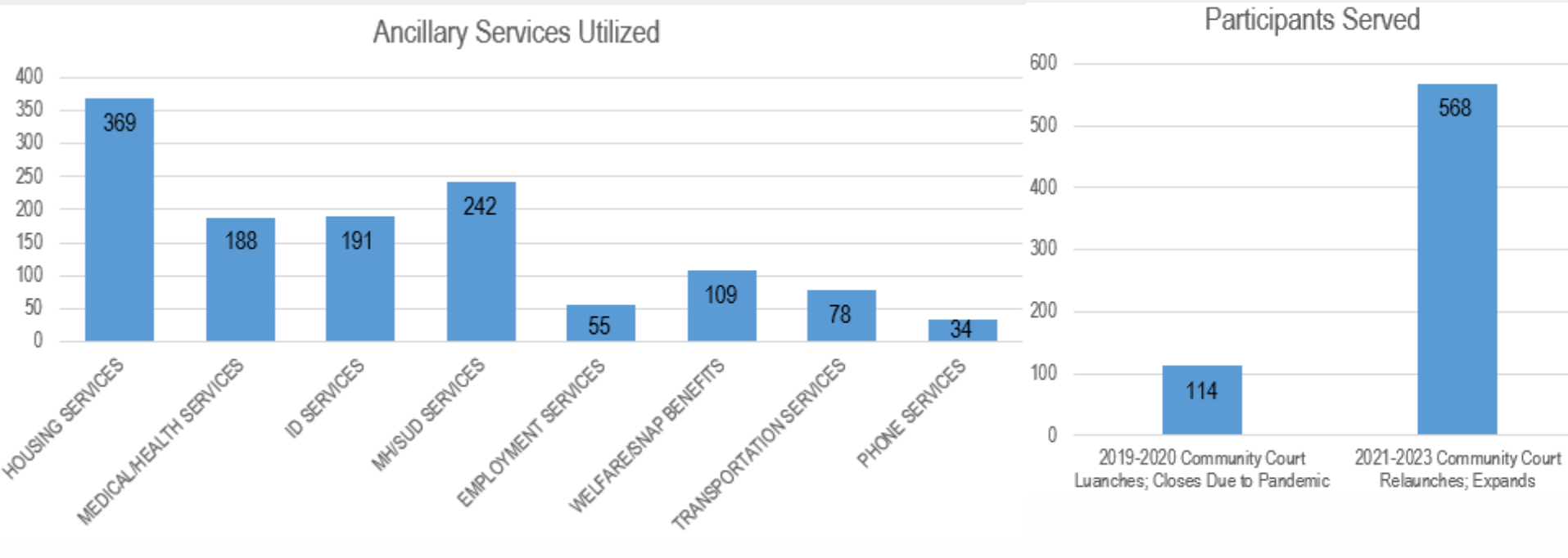
2018-2023

- Bureau of Justice Assistance implementation and enhancement federal grants, totaling \$389,000
- Annual Administrative Office of the Court grants, totaling \$82,500

Savings:

- \$119/day to house one inmate at WCSO
- \$130/hour for RPD Officer to arrest, transport, & book

# Success Stories

## • Participant #1

- 55-year-old male
- Circumstances at start of CC:
  - Homeless for 20 years
  - Excessive alcohol use disorder
  - No familial support
  - Slept in front of Trinity Episcopal Church on Island St.
- Providers utilized
  - Crossroads (Housing & SUD Treatment)
  - Health Plan of Nevada (Case Management, New Phone)
  - Downtown Reno Partnership (Obtained SS Card)
  - Community Health Alliance (Medical Services)
- Circumstances at graduation:
  - Clean/Sober for 1 year
  - Still housed at Crossroads Transitional Living
- Participant #1 continually visits CC long after his case has been closed to let the team know he is still doing well

## • Participant #2

- 42-year-old male
- Circumstances at start of CC:
  - Multiple appearances at CC while drunk
  - Chronically homeless
  - In and out of jail
  - Attended AA meetings under the influence
- Providers utilized
  - Life Changes Transitional Living (Housing & SUD Treatment)
  - Community Services Agency (Transportation Services)
  - Job Connect (Employment Services)
  - DWSS (SNAP Benefits)
  - Well Care CTC (SUD Treatment)
- Circumstances at graduation:
  - Clean/Sober for 1 year
  - Working for Life Changes as a House Manager
  - Is now an AA sponsor
- Participant #2 now serves as CC's mentor and attends Treatment Readiness groups in that capacity
