I live in an apartment on N Virginia St directly across from the UNR campus in Zone 1. Zone 1 and the surrounding neighborhoods have restricted parking to prevent UNR students from parking in residential zones. The City of Reno Parking services do not regularly patrol or ticket vehicles in Zone 1, so all of Zone 1 is filled with unpermitted cars, so I cannot park my car in Zone 1. To park my car, I have to find a neighborhood that does not have parking restrictions because I do not want to get a parking ticket. The closest one is about a 1/2 mile from my apartment, so I have to walk a mile every time I drive and come home and this is frequently in the dark. As a young woman, I do not feel safe walking alone at night. I have called parking services many times and have left many messages about

this and they tell me "they will send someone out", but no one comes, and the parking situation continues to get worse as the semester goes on. On my block alone I can count 15 unpermitted cars filling up spots on a daily basis, and I can assure you this is not an exaggeration. Please implement a permanent route through neighborhoods surrounding UNR so that residents can park safely in front of their homes.

Hi Nicholas- Thanks for reaching out. Dickerson Rd. has been an encampment destination for many of the reasons you state: River, Tracks, and as a dead end. I'll copy Reno Direct so that they can be aware of the situation and raise the concern to the proper city division. Usually in advance of winter preparedness, public works crews go along the riverbank and storm drain inlets to make sure no one is at risk. I leave the Council next month after 12 years so will not be involved in funding discussions, but I read today that this may be a topic at the every other year legislature that convenes in February. You may want to follow the session. Most of the money we've received over the past 5 years came from federal relief from the pandemic and that is running out soon. So, state resources are really the best option as the city has no authority to generate additional revenue to address the issue.

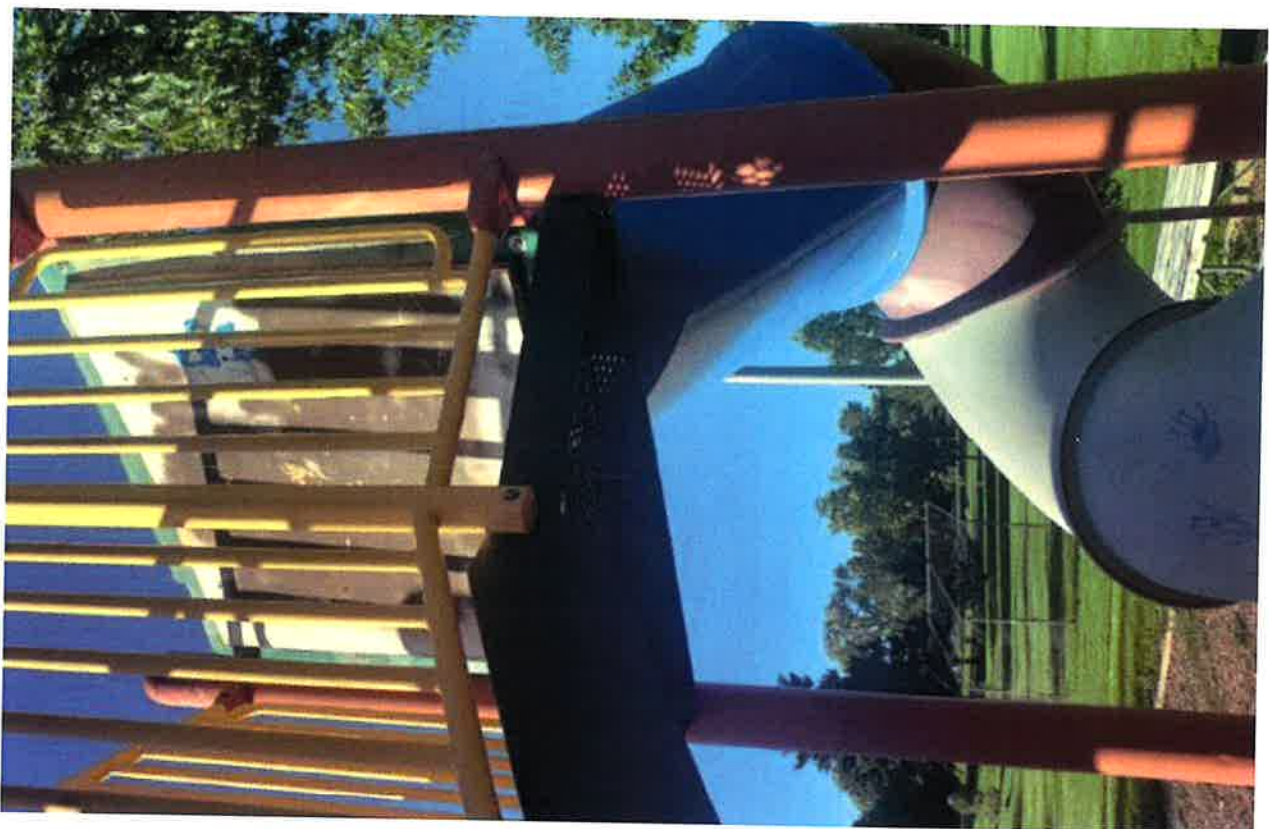
