I am once again pleading with you all to not criminalize those who are struggling to survive through the housing crisis pr chronic homelessness! These ordinances that could lead to a fine or arrest do nothing to solve the lack of affordable housing and do nothing to provide safe shelter. Many people struggling to exist without shelter/housing have no where to go. The Washoe County shelter census dashboard very clearly shows that all shelter options at Cares Campus and Our Place Women + Family shelter at capacity or near capacity on a daily basis and has been that way since it opened. It was reported over a year ago by County staff on record that there remains a 30+ long wait list for families looking for emergency shelter. The Women's beds are also nonexistent regularly. The men on average

show about 12 open beds daily but we know that many more are living without shelter currently so even if they were encouraged to go inside there would not be enough space for everyone. So if we can not supply enough shelter for the growing unhoused population than how in your right mind can we fine or arrest them for sitting, resting, eating or trying to stay warm and alive with no where to go??? Literally, where do they go? This is cruel and only perpetuates harm, trauma and discourages people from getting to the next step off the streets and into shelter or housing. Many cannot afford the fine so then what? Does an unpaid fine lead to a warrant which leads to an arrest which then creates yet another barrier to getting a job or renting a home? Why can't somebody sit or rest in public? How is that a public safety issue??? We have other ordinances already in place that prohibit violence or disturbing the peace or littering to name a few...why would we need to restrict people's mere existence? The resources wasted on implementing these type of inhumane ordinances, the policing of them, the court time, holding a person in jail etc is supremely wasteful all the while doing nothing to create life affirming pathways to housing healthcare rehabilitation or anything that we could and should be doing with this time and money instead. Instead of sending resources over to policing or private security companies please consider hiring mental health workers to do outreach in the community as first responders to non-violent calls to service. Building trusting relationships through care models rather than punishment is proven more effective in positive outcomes for helping people off the streets. Use resources to implement holistic life affirming services rather than punitive ones that only push people down further. You have an opportunity today to vote down this cruel wasteful ordinance and I hope you do.

Hello! I have to honestly say I am quite disturbed by how bloodthirsty it seems Reno City Council is! Like, talking to any homeless people at all and it is very obvious that the Cares Campus has deep issues that would drive the people it is meant to serve away. I saw the Grant's Pass court case mentioned, and that was also disturbing because anyone paying attention knows the US Supreme Court is stripping rights away left and right. There are 10 empty houses for every homeless person in Washoe County, and studies that take an honest look at the housing situations around this planet have found that the fastest way to get people out of homelessness is, astonishingly!, to give them housing! Housing, medical support, and food, when these things are taken care of something I like

80% of them are able to reenter the workforce. And of course, many homeless people are deeply disabled, unable to work, and deserve to have housing provided for them. If these laws pass, an increase in the police budget will eventually follow, as more police are required to shepherd the growing homeless population around the city and haul them off to jail. The police budget is already too high in this city, so rather than giving more money to the people who inflict the most harm on our homeless neighbors we could spend that money housing them. I would suggest starting by revamping the voucher system, which requires people to jump through hurdles for years at a time to then get a voucher that nowhere will accept. Housing is a human right, it shouldn't be sold for profit, and the path the Reno City Council has been going down has only made the crisis worse. Please evaluate these law changes, and look inside yourself. There is no way you could vote on this law, knowing the harm similar laws have inflicted elsewhere, unless you are quite simply an evil person.

Dear Members of the Reno City Council, I am writing to express opposition to the proposed actions of agenda items E.1 through E.4 that would expand the criminalization of homelessness in our community. Decades of research in public health, medicine, and the social sciences demonstrate that such measures exacerbate the hardships of unhoused individuals while failing to address the root causes of homelessness. Although the proposed changes under Title 8, Chapter 8.12, are framed as efforts to simplify and clarify existing laws, they will ultimately implement broader, more encompassing restrictions on essential human activities in public spaces. By expanding these rules, the ordinance creates a more punitive framework that will push unsheltered individuals into increasingly

isolated and dangerous conditions, as well as limit access to vital resources and support systems. What the ordinance will not do is address Reno's homelessness situation. I agree that Reno's policies are unclear, redundant, and ill-defined. But the proposed ordinance in this agenda is not a solution. Nevadans who are unsheltered or struggling have a right to exist in public spaces. There is no clearer example of excessive punishment than imposing penalties on individuals for the very human need to sit, lie down, and sleep. Homelessness cannot be solved through arrests or fines or jail time. You cannot punish people into having a place to live. Instead, I urge the Council to amend language in existing ordinances to focus on evidence-based approaches that address systemic drivers of homelessness. Additionally, I encourage the Council to direct resources toward proven strategies, such as increasing access to affordable housing, expanding mental health and addiction services, and supporting employment and training programs. Lastly, I encourage Council members to engage directly with unhoused individuals and advocacy groups in our community to better understand their experiences and needs. I remain hopeful that Reno can come together to address the complex challenges of homelessness affecting our most vulnerable. This responsibility is shared by each and every one of us. It is possible to balance the issues facing Reno with the humanity and rights of unsheltered citizens. And it is possible to write and implement good, clear policy without enforcing a punitive framework against those with no place to lay their heads. We must work together to build a community where all of Reno's residents, regardless of housing status, are treated with dignity. Thank you for your time and consideration.
