I'm opposing consent item B.25 and ask that it be taken out of order.

Jewish Nevada is an organization that openly supports an apartheid state in the process of genocide and ethnic cleansing. Our tax dollars should not be supporting them. We support Jewish people, but we do NOT support Israel. Judaism does not equal Zionism, therefore Israel does not equal Jewish People. Palestinians are our community members too, we should support them fully especially during these trying times where they are being murdered by the thousands.

We demand the Reno City Council to recognize and acknowledge Israel's ongoing genocide of Palestinians and to call for a ceasefire.

Instead of helping fund a genocide and the continued hatred against Palestinians, we ask that the funds be used for a warming center for houseless folks. This past year, 135 houseless people died on the streets due to exposure, and yet some claim that houselessness has been cut in half in our city. We could also use the funds towards education, free or low cost healthcare for children, N95 respirator masks, help with student loan debts, etc.

My wife is a member of a Sierra Nevada Masters, who expect to use the new Moana pool.

I am aware of the current design of the locker rooms at the new Moana pool, and I request that you significantly increase the floor area, lockers, and bench seating space in the private changing area of this facility. This could be done by installing a wall to make the current design of an open public viewable locker area part of the private locker room area.

I understand Sierra Nevada Community Aquatics has attempted to initiate such an improvement with City personnel by voicing user groups' concerns regarding the insufficient private changing areas of both locker rooms. Based on expected usage, these features at Moana are much worse than any other aquatic facility in the region, especially when compared to Carson Aquatic Facility (which is more than five times better than Moana in this regard).

I request that you authorize significant improvements to these locker rooms now, before the project is completed. I understand this may delay completion of the facility and come at a higher cost. I am writing from Ward 1 to urge members to vote NO on motion B.25, which invests 3 thousand dollars of discretionary funds into Jewish Nevada, an entity that supports the genocidal apartheid state of Israel.</p> <p>In 2023, over 130 unhoused community members passed away despite claims that houselessness and displacement have decreased by half within the community. As a community member who has been houseless in the past, I believe it is questionable of our city council to invest discretionary funds into an organization that supports the genocide of Palestinians. Moreover, I'd like to hold the city council accountable for its questionable decision to "invest" in Jewish life here in Nevada at this moment when there has been ample opportunity to do so in the past.</p> <p>I support Jewish life within Nevada. However, I do not support this performative and dangerous gesture that perpetuates Zionism and white supremacy, undermines Jewish values, and threatens the well-being of all Palestinians, whether in Gaza, the West Bank, or in the diaspora. Jewish organizations across the nation have demonstrated their profound opposition to Israel's genocide in Palestine. Your constituents, Jewish and non-Jewish alike, have organized and demonstrated their opposition to the apartheid state, albeit you continue to disregard their concerns with this motion. Motion B. 25 should not be up for discussion!</p> <p>In the past 103 days, over 70% of homes in Gaza are now rubble, and 1% of the Gazan population has been killed. That is over 23,000 people. This doesn't include individuals stuck under rubble or the over 60,000 Palestinians injured since October 7th. Including Israel's name in this donation is violent and immoral. I would like to see money directed towards helping Reno's most vulnerable population,</p>

the unhoused, as well as Palestinian community members. We need affordable housing, access to equitable healthcare, and access to low-cost education, specifically for our low-income communities.


To whom this concerns;

I am writing to encourage Reno to install much needed EV charging stations.

I am a Truckee resident and Reno property owner with an EV who comes to Reno weekly and would appreciate having a charging station available. Truckee and Reno residents are inextricably connected, Reno residents come to Truckee to recreate, Truckee residents come to Reno for shopping, entertainment and all that the Biggest Little City offers. My son goes to UNR, I have friends and relatives who live in Reno, I bought my EV car in Reno. This situation is discouraging as I personally try to do my part to help reduce greenhouse gases. There are many more EV cars today than just Tesla's, which are the only chargers that can be found in the city. Reno does not offer charging as our Country is trying to move beyond gas powered vehicles. Yes, Sparks has a charging station that is almost always full, which indicates there is demand. Having an interstate highway run through the city supports the need for more options. Many folks from the Sacramento & SF Bay Area, whom Reno works to attract drive EV's and are discouraged by the lack of support for charging (yes, we talk while waiting in line to charge our cars). I have been so impressed with the revitalization in the city, downtown, midtown and beyond with a large housing expansion, but yet you are leaving out a vital component going into the future. I urge you to be forward looking and support the increase of EV's. I can think of many areas that would be beneficial for charging stations: Gold Run area (I-80) before heading up the hill to Truckee, Meadowood mall (580), Summit mall (580), perhaps a few universal high speed chargers at the Casinos, to name just a few.

Dear Parks and Recreation Director,

I am excited that Reno will soon have a new 50 meter pool and I'm grateful that the city has moved forward with this project.

Issue

As I understand the design at the new Moana pool, the locker rooms appear insufficiently large enough to accommodate the number of aquatic users expected.

Solution

I support the proposal to enclose the public changing spaces near the front desk and make those areas part of the locker rooms. By doing so, the City will significantly increase locker room space, locker and bench capacity and functionality.

Recommendation

I recommend that you undertake these improvements now before the project is completed and while I understand this may delay completion of the facility and come at a higher cost, the functionality will be improved for the long-term.

My Background and Basis for Recommendation

I have been involved in competitive swimming for nearly 54 years. I began swimming in the fall of 1970 at Arden Hills in Sacramento - where I grew to know Debbie Meyer, Mike Burton, Mark Spitz, Jeff Float and the other great Olympians my coach and mentor, Sherm Chavoor, produced.

After achieving All American status at Jesuit High School, I walked on to the swim team at the University of California, Berkeley (Cal). While I never made the traveling team, I swam for two seasons under world renown coach, Nort Thornton and shared the pool with Olympians Matt Biondi, Mary T. Meagher, and Dave Wilson among others.

Since returning to the pool as a Masters Swimmer in 1992, I have recorded 27 United States Masters Top-Ten times.

I am fortunate to have swum in over 100 pool facilities throughout North America. Some were memorable because of their beauty - others because of their functionality.

I can say unequivocally, functionality is paramount to an excellent swim center. Excellent pool facilities are those that are simple with easily accessible, large locker rooms where there's space for many people and their gear.

I strongly recommend that you emulate - as nearly as possible - those highly functional pool facilities by enlarging the locker rooms.

This letter is being written to express support for Agenda Item B.18 which is for the acceptance of a USDA Forest Service grant to plant trees along Airway Drive in Reno.

As you may know, Reno is the fastest warming city in the country, partially due to the urban heat island effect. An urban heat island is an area within a city that experiences higher temperatures due to buildings or roads absorbing and re-emitting the sun's heat more than a natural landscape would. Urban heat islands also have a negative effect on air quality and increase ozone pollution in our region. With the support of the City of Reno, AQMD is a participant in the Environmental Protection Agency's Ozone Advance program which encourages local governments to take proactive steps to improve air quality as it relates to ozone pollution. One strategy identified by AQMD is to decrease the urban heat island in our area by increasing the urban tree canopy coverage.

P.S.- The above email expresses, in a nutshell, the deficiencies in the locker room design of the Moana Springs facility. Without being overly pessimistic about the likelihood of a plan revision, in my 19 year career with the City of Reno I have seen facility plans pushed through that did not take the input of the end user into consideration.

Prior to my time with the city I was a builder with over a decade of residential and commercial experience. Ultimately an unwillingness to consider the voices of the people who use these buildings day after day, year after year, is a disservice to those who are impacted and will cost more in the long run.

Once Moana Springs is built it will not be revised for decades. It would be a shame to not pause and truly appreciate what Sierra Nevada Community Aquatics and the various community swim teams have to say on the matter. They are your subject matter experts who have years of experience and have seen many aquatic facilities over the years- they know what works.

I myself am a member of the aquatics community in this town. I have two kids who swim four nights a week at the overly impacted NW Pool on Apollo. Moana Springs is way overdue as the swimming community has been terribly neglected for years. 
To whom this concerns;

Truckee and Reno residents are inextricably connected, Reno residents come to Truckee to recreate, Truckee residents come to Reno for shopping, entertainment and all that the Biggest Little City offers. My son goes to UNR, I have friends and relatives who live in Reno, I bought my EV car in Reno. This situation is discouraging as I personally try to do my part to help reduce greenhouse gases. There are many more EV cars today than just Tesla's, which are the only chargers that can be found in the city. Reno does not offer charging as our Country is trying to move beyond gas powered vehicles. Yes, Sparks has a charging station that is almost always full, which indicates there is demand. Having an interstate highway run through the city supports the need for more options. Many folks from the Sacramento & SF Bay Area, whom Reno works to attract drive EV's and are discouraged by the lack of support for charging (yes, we talk while waiting in line to charge our cars). The Northern Nevada Public Health, Air Quality Management Division (AQMD) has the responsibility to maintain federal air quality standards in Washoe County, Nevada which includes the City of Reno. This letter is being written to express support for Agenda Item B.18 which is for the acceptance of a USDA Forest Service grant to plant trees along Airway Drive in Reno.

As you may know, Reno is the fastest warming city in the country, partially due to the urban heat island effect. An urban heat island is an area within a city that experiences higher temperatures due to buildings or roads absorbing and re-emitting the sun's heat more than a natural landscape would. Urban heat islands also have a negative effect on air quality and increase ozone pollution in our region. With the support of the City of Reno, AQMD is a participant in the Environmental Protection Agency's Ozone Advance program which encourages local governments to take proactive steps to improve air quality as it relates to ozone pollution. One strategy identified by AQMD is to decrease the urban heat island in our area by increasing the urban tree canopy coverage.

AQMD appreciates the efforts of the City of Reno to mitigate the urban heat island effect and implement Ozone Advance strategies such as tree planting. AQMD requests that the Reno City Council accept Agenda Item B.18 and move forward with the project as planned.

I am excited that Reno will soon have a new 50 meter pool and I'm grateful that the city has moved forward with this project.

Issue

As I understand the design at the new Moana pool, the locker rooms appear insufficiently large enough to accommodate the number of aquatic users expected.

Solution

I support the proposal to enclose the public changing spaces near the front desk and make those areas part of the locker rooms. By doing so, the City will significantly increase locker room space, locker and bench capacity and functionality.

Recommendation

I recommend that you undertake these improvements now before the project is completed and while I understand this may delay completion of the facility and come at a higher cost, the functionality will be improved for the long-term.

My Background and Basis for Recommendation

I have been involved in competitive swimming for nearly 54 years. I began swimming in the fall of 1970 at Arden Hills in Sacramento - where I grew to know Debbie Meyer, Mike Burton, Mark Spitz, Jeff Float and the other great Olympians my coach and mentor, Sherm Chavoor, produced.

After achieving All American status at Jesuit High School, I walked on to the swim team at the University of California, Berkeley (Cal). While I never made the traveling team, I swam for two seasons under world renown coach, Nort Thornton and shared the pool with Olympians Matt Biondi, Mary T. Meagher, and Dave Wilson among others.

Since returning to the pool as a Masters Swimmer in 1992, I have recorded 27 United States Masters Top-Ten times.

I am fortunate to have swum in over 100 pool facilities throughout North America. Some were memorable because of their beauty - others because of their functionality.

I can say unequivocally, functionality is paramount to an excellent swim center. Excellent pool facilities are those that are simple with easily accessible, large locker rooms where there's space for many people and their gear.

I strongly recommend that you emulate - as nearly as possible - those highly functional pool facilities by enlarging the locker rooms.

This could be done by installing a wall to make the current design of an open public viewable locker area part of the private locker room area.

I understand Sierra Nevada Community Aquatics has attempted to initiate such an improvement with City personnel by voicing user groups' concerns regarding the insufficient private changing areas of both locker rooms. Based on expected usage, these features at Moana are much worse than any other aquatic facility in the region, especially when compared to Carson Aquatic Facility (which is more than five times better than Moana in this regard).
