

**AMENDED CONTRACT BETWEEN
CITY OF RENO
AND
UNIVERSAL PROTECTION SERVICE, LLC
dba ALLIED UNIVERSAL SECURITY SERVICES**

This Amended Contract (“Amended Contract”) is made and entered into by and between the City of Reno, a municipal corporation (“City”), and Universal Protection Service, LLC dba Allied Universal Security Services, an American Owned company authorized to do business in the State of Nevada (“Contractor”), on the 14th day of June, 2023, and is entered into based upon the following:

WHEREAS, on October 4th, 2021, City and Contractor entered into a the Contract for Security Services; and

WHEREAS, on December 7th, 2022, the parties amended the October 4th, 2021 Contract to add Security Services for the City Corporation Yard; and

WHEREAS, the parties desire to amend the Contract to add security positions, increase the rate charged for said positions and extend the term of the December 7th, 2022, Amendment as to the City Corporation Yard to September 30th, 2025; and, the Contractor desires to provide the additional security positions at said rates and extend the term of the December 7th, 2022 Amendment.

NOW, THEREFORE, the parties mutually agree to amend the Contract as follows:

1. Attachment A reflects the additional security positions, increased rates for the services, and the extension of the Security Services for the City Corporation Yard through September 30th, 2025. Attachment A is incorporated herein by this reference effective July 1, 2023 through September 30th 2025.

2. The term of the December 7th, 2022 Amendment is extended through September 30th, 2025 per Attachment A.

3. The not-to-exceed amount for the additional security positions, increased rates and extension of the Security Services for the Corporation Yard per Attachment A is the sum of \$532,861.68.

All other provisions of the October 4th, 2021 Contract remain in effect.
