

**AMENDED CONTRACT BETWEEN
CITY OF RENO
AND
UNIVERSAL PROTECTION SERVICE, LLC
dba ALLIED UNIVERSAL SECURITY SERVICES**

This Amended Contract ("Amended Contract") is made and entered into by and between the City of Reno, a municipal corporation ("City"), and Universal Protection Service, LLC dba Allied Universal Security Services, an American Owned company authorized to do business in the State of Nevada ("Contractor"), and is entered into based upon the following:

WHEREAS, on October 4th, 2021, City and Contractor entered into the Contract for Security Services; and

WHEREAS, on December 7th, 2022, the parties amended the October 4th, 2021, Contract to add Security Services for the City Corporation Yard; and

WHEREAS, on June 14, 2023, the parties amended the Contract to add additional Security Services among other matters; and

WHEREAS, the parties desire to increase the contract amount to cover the full cost of security for dispatch which was added in the June 14, 2023 amendment.

NOW, THEREFORE, the parties mutually agree as follows:

1. To increase the contract amount by the sum of \$251,589.00 to cover the full cost of security for Clean and Safe Patrol for 12 months (Attachment A)

All prior contracts and amendments referred to herein are in full force and effect.

This amendment is effective when approved by the City Council.
