While I commend the effort to streamline housing construction processes and create more opportunities for affordable housing, I would like to express a pressing concern regarding the broader context of our housing landscape.</p> <p>First and foremost, I wholeheartedly support the recommendations to make housing construction less cumbersome, as outlined in the proposed updates. The notion of offering density bonuses for affordable housing projects and allowing projects meeting AMI's in the 61%-120% range to benefit from these incentives is indeed a step in the right direction. Furthermore, expediting the building permit process for affordable housing projects is a practical move that can help address the pressing need for more affordable housing options.</p> <p>However, it's crucial that we don't lose sight of the bigger picture. While creating incentives for housing construction is vital, the true priority should be addressing the funding and allocation of resources to build housing that is genuinely needed by our community. My concern stems from the observation that we may be inadvertently overemphasizing the construction of one specific housing type, namely "affordable housing," without considering the diverse needs of our residents.</p> <p>We run the risk of saturating our housing market with luxury accommodations while neglecting the pressing demand for middle-income housing options. If we continue down this path, we may soon find ourselves in a situation where we have an abundance of vacant high-end housing units and a scarcity of housing that meets the needs and financial capabilities of a broader demographic.</p> <p>Therefore, I urge the City Council to prioritize a balanced approach to housing development. We must allocate resources and incentives not only for affordable housing but also for housing that serves the middle-income segment of our community. A diverse range of housing options, including duplexes, triplexes, and fourplexes in various zoning districts, can contribute to a more inclusive and sustainable housing market.</p> <p>In conclusion, while I support the proposed updates to the Zoning Code, I urge the City Council to maintain a vigilant focus on the allocation of resources and the diversity of housing options. Let us work together to create a city where everyone, regardless of their income level, can find suitable housing. Thank you for your</p>

attention to this matter, and I look forward to a future where our housing policies reflect the needs of our entire community.
