5 Planning Commission Training Series: American Planning Association (APA) Video presentation on Staff Reports and discussion

Jason Garcia-LoBue, Planning Manager, presented a video provided by the American Planning Association.

Chair Velto asked if staff has ever considered including potential conditions that are responsive to either things that the applicant is asking for or things any opposition is arguing.

Mr. Garcia-LoBue explained that when staff is meeting with applicants or concerned citizens they try to vet out issues and concerns beforehand and have mitigations or conditions of approval drafted in the staff report.

- 6.1 Staff Report (For Possible Action - Recommendation to City Council):
Case No. **LDC23-00023 (455 Crampton Street Master Plan and Zoning Map Amendments)** – A request has been made for: 1) a Master Plan amendment from Mixed Neighborhood/ Wells Avenue Neighborhood Planning Area/ Wells Avenue Mixed-Use (MX/WANP/WAMU) to Suburban Mixed-Use/Wells Avenue Neighborhood Planning Area/ Wells Avenue Mixed-Use (SMU/WANP/WAMU), and; 2) a zoning map amendment from Multi-Family Residential – 14 units per acre/ Wells Avenue Neighborhood Plan (MF-14/WANP) to General Commercial/ Wells Avenue Neighborhood Plan (GC/WANP). The ±0.16 acre site is located north of Crampton Street ±170 feet east of its intersection with Wells Avenue. **[Ward 3]**

Jeffrey Loftin, applicant representative, gave an overview of the project.

Grace Mackedon, Senior Management Analyst, gave an overview of the staff report.

Disclosures: visited the site, read and received emails, met with applicant representative

Public Comment: Correspondence was received and distributed to the Commission before tonight's meeting. No voicemails and no request to speak forms were received.

Questions:

Commissioner Villanueva asked why General Commissioner (GC) is being requested rather than Neighborhood Commercial (NC).

Ms. Mackedon explained that GC is more consistent with the surrounding area. The Wells Avenue Neighborhood Plan is intentional to have higher intensity zones closer to Wells Avenue and then taper out to the MF-14 area. She also explained there are other processes in place to ensure staff can analyze future potential projects. Any future development adjacent to residential will still need to go through a discretionary review.

It was moved by Peter Gower, seconded by J.D. Drakulich, to adopt the Master Plan amendment by resolution and recommend that City Council approve the Master Plan and zoning map amendments, subject to conformance review by the Regional Planning Commission. Motion Pass.
