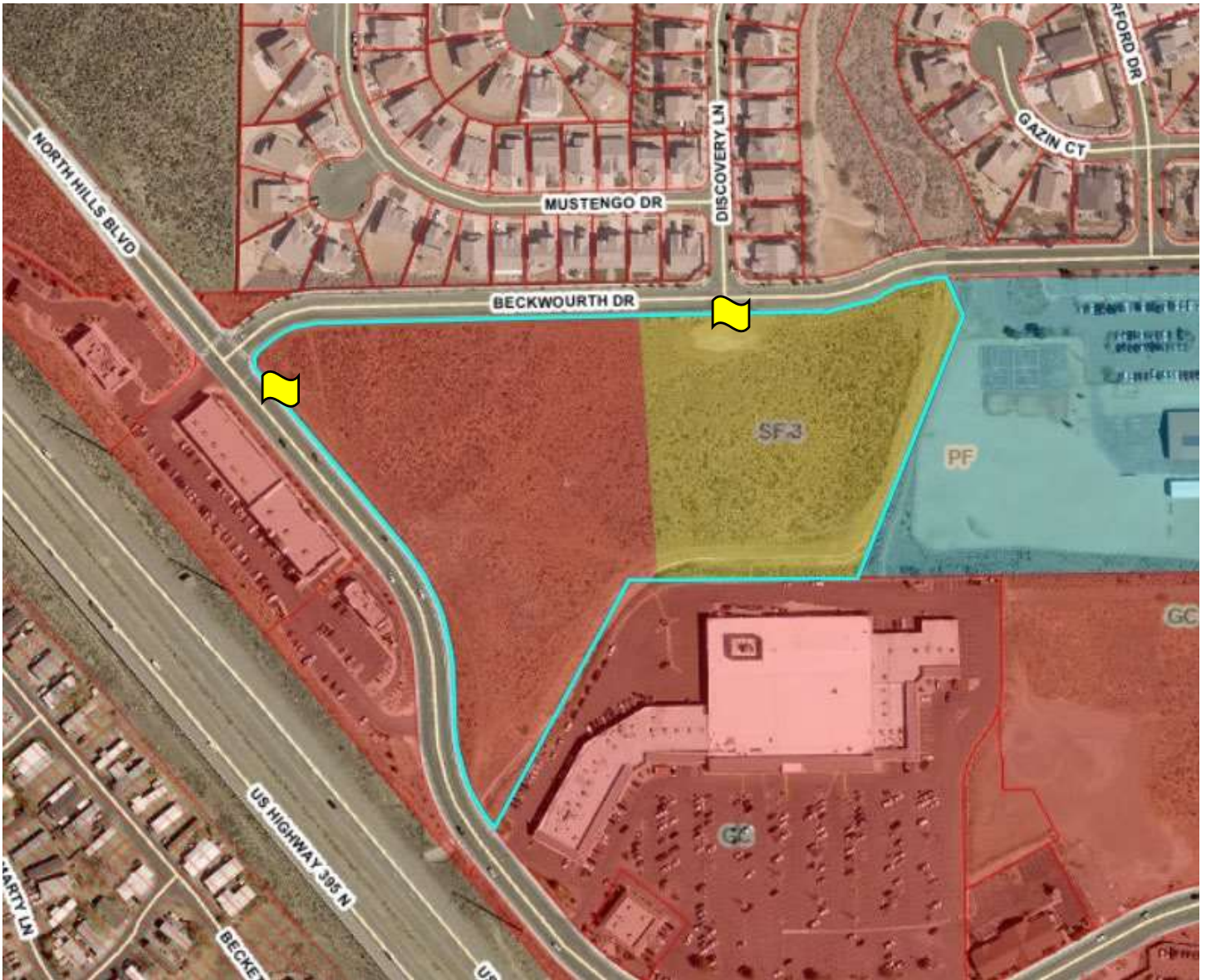



# MUP24-00010 750' Map

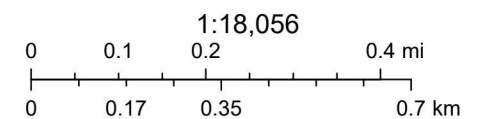
