

**RESOLUTION DONATING COUNCIL DISCRETIONARY FUNDS TO  
TRIBAL MINDS INCORPORATED IN SUPPORT OF THEIR MISSION  
TO SERVE INDIGENOUS COMMUNITIES IN NEVADA AND WORK TO  
ADVANCE THE WELL-BEING OF INDIAN COUNTRY THROUGH  
COMMUNITY DEVELOPMENT AND INDIGENOUS WELLNESS  
PROJECTS IN THE AMOUNT OF \$600. (GENERAL FUND)**

**WHEREAS**, the City of Reno may donate funds in accordance with NRS 268.028(01), entitled "Expenditure of public money; grant of public money and donation of certain property to certain nonprofit organizations or governmental entities" when such expenditure provides a substantial benefit to the inhabitants of the City; and,

**WHEREAS**, the Reno City Council recognizes the importance of Tribal Minds Incorporated by supporting local non-profit organizations acknowledging the importance of serving the Indigenous communities and helping community development and Indigenous wellness; and,

**WHEREAS**, Tribal Minds Incorporated is a registered 501(c)(3) nonprofit organization that are determined to liberate future generations from the scourge of poverty, disillusionment, and inequities of humanities found in 2020; and,

**WHEREAS**, Tribal Minds Incorporated operated under three essential values to help them complete their mission health communication, community rooted, and vision driven; and,

**WHEREAS**, Tribal Minds Incorporated has shown their dedication by creating a voice for remote Indian reservations that often get overlooked and are underfunded by allowing them to receive opportunities to advance from those disparities; and

**NOW, THEREFORE BE IT RESOLVED** that the City of Reno approves the Council donation from Councilmember Miguel Martinez in the sum of Six Hundred Dollars (\$600) to Tribal Minds Incorporated in support of their mission to serve Indigenous communities in Nevada and work to advance the well-being of Indian Country through community development and Indigenous wellness projects; and,

**BE IT FURTHER RESOLVED**, that should the above donation or any portion thereof not be used for the purpose as set forth in this Resolution, any unused funds shall be returned to the City of Reno.
