I urge the council to give notice to Waste Management of the termination of the contract. There are many issues with Waste Management. The company does not know the meaning of 'customer service'. We face long hold times when calling with questions and problems. Their drivers no longer care whether or not they drop trash in the street. Three of my auxiliary garbage cans have been "eaten" by the truck - and I have been unable to reach anyone to request compensation for the loss. If they miss a pick-up, a return trip is always promised but never occurs. They use machine-generated fuzzy photos of supposed "unauthorized" items to generate fines and penalties - and there is no recourse! My garbage bill changes every quarter - for no apparent reason. These are some of the

issues that need to be discussed before renewing the contract in 2029.
