Previous Council Action:

There is no recent Council action relevant to this item.

Background:

The Fiscal Year 2023 CPD Microgrant Program funds are used to develop law enforcement's capacity to implement community policing strategies. This award was made under the Officer Recruitment, Retention, and Workforce Diversification opportunity.

Discussion:

RPD received notice of this grant award on November 2, 2023. The technical award period is October 1, 2023, through September 30, 2024. Practically, the period for disbursing funds will be the date of the award acceptance through September 30, 2024. This grant will fund efforts to secure a well-qualified workforce that is reflective of its community. It will fund increased community outreach and efforts to identify and develop potential applicants to become successful RPD officers. It will fund travel and overtime for sworn personnel engaged in recruitment, the services of a professional recruitment firm, supplies, and temporary administrative support.

Financial Implications:

This grant award does not require a match.

Legal Implications:

Legal review completed for compliance with City procedures and Nevada Law. The City, by accepting this grant, agrees to comply with the terms of the grant application and award documents, including all reporting requirements, provide information for evaluation to the granting organization, and provide progress and financial reports on program activities, which will be completed by police department personnel. Failure to adhere to the grant requirements could affect future funding.
