I am a home owner who is directly affected by the expansion of Life Church. While I am not against the proposal as a whole, I can say I have legitimate concerns and I hope, like my neighbors also do, Life Church takes them seriously to minimize discomfort and long lasting negative impacts on community members and neighbors. My main concern will be the extra lighting necessary for the parking lot area to the east. Height and quantity, type and duration could have a very long lasting damages if not considered properly. As a home owner who has a two story house it becomes even more problematic with view impacts and general privacy concerns. My wife and I bought this home to raise our children in because of the quiet neighborhood, the beautiful views both in the day and the evening. The lights that are coming from Damonte Ranch High School already has around the clock light pollution, adding this could double it and have it shining through our windows all-night every night. Secondly, and a public health matter to consider is, the traffic situation in both the everyday situation and in the event of an emergency. Currently when the high school gets out it takes 40 mins to clear all the traffic. Since Rio Wrangler only runs North/South adding the elementary school, which gets out at roughly an

hour later, another 40 minutes off traffic will occur. Also during construction there will be that added traffic. Now lets consider adding in a wildfire emergency and you account for all the current home owners and the expansion of another 80 homes that are being proposed and you have recipe for disaster. There are only a couple of ways out of this subdivision. My third concern is the construction phase disruption. Now I know this is temporary but I hope a precautions are taken to minimize the dust, hours of operation of both personnel and generators, equipment and trucks as well as night time activities and security. Please understand there have been many good things about living next to a church and schools, both have done many great things for the community and other than some minor inconveniences in the past, I have been happy to have them as neighbors. I just ask for proper over site and restrictions to help mitigate, or even change, negative impacts be put in place and enforced if this project moves forward. Thank you for your consideration. 1. Traffic:

A. Drop off and pick up traffic should be kept out of neighboring streets, i.e. Desert Way, Gold Mine Drive, and Mule Circle.

B. Traffic control guards should be at the intersections of McCauley, Desert Way, and Rio Wrangler to assure traffic flows steadily, especially in case of emergency. We currently deal with long waits due to Damonte Ranch High School traffic.

2. So that the "quality of life" that we have come to greatly appreciate can continue:

A: Loud outdoor activities such as concerts and sports should be limited to the Rio Wrangler side of the building and adhere to reasonable hours. Of course, 7pm every night would be ideal so that we could continue to enjoy quiet

evening relaxation. We already have to close up our house when summer concerts have been too loud to hear our music or tv.

B: Parking lot lighting should conform to area "night sky" brightness limitations and should not shine into our homes.

C. The parking area behind our homes should be monitored, and possibly gated overnight, to discourage it's use for unscheduled, possibly disturbing, gatherings.

D. Buildings should be sited so as to not obscure the views we moved here for. I wake up every morning and look out my window and over the wall with thanksgiving for all the beauty of the mountains that I see and appreciate. I consider it very important for my mental health.
