To Whom It May Concern:

As a researcher, private investigator and constituent, I have a question as to when, why, and why not that the Reno Police Department (RPD) ceased enforcement of parking violations. The cessation is especially troublesome as parking matters contribute to disorder and urban blight. In my dealings with and research into Parking Enforcement, it has been my experience that the agency cannot manage the volume of parking complaints. I recently lodged a public records request with the City of Reno, another request through Reno Direct, and a direct email to RPD at [askrd@reno.gov](mailto:askrd@reno.gov). The substance of the requests was when RPD eliminated parking enforcement from their purview. After a few weeks, the only response thus far is from public records referring me directly to parking enforcement outside the public records request system. With the city's expansion, RPD should resume this duty, proactively enforce parking, and respond to parking complaints directly from Reno Direct. Lastly, perhaps the city should reconsider disbanding the Parking Enforcement unit, reassigning the employees, and placing parking regulation solely under the auspices of the RPD—as a matter of more efficient and cost-effective use of city resources.



# Mental Health/ Mental Health Rehabilitation Centers

**INTRO-** Hello ladies and gentlemen of the council, my name is Ximena Rios. I'm a senior at Hug High School and I'm here today to talk about the importance of mental health and the need for more mental health rehabilitation centers in our city. Mental health is something that's important and it's something a lot of people deal and struggle with on a day-to-day basis. I feel it is crucial that Mental health be taken care of and prioritized just as much as one's physical health.

- This specific topic hits close to me and I wanted to bring it up because I, just like many other people, have dealt with my own mental health being low and it affected not only how I felt about my life, but also my emotions and feelings too. It made me lose motivation towards school and just day-to-day activities. So, I just want to make it more of a priority within our city to normalize asking for help when it is needed.

**PROBLEM-** Associated with mental health and rehabilitation centers it has come to my attention that in December of 2021, the West Hills Behavioral Health Hospital was shut down, leaving the people of Reno with one less place to receive mental health treatment. I'd like to talk about the importance of it and why we as people should have multiple places to provide us with proper and professional help when needed.

Mental health is a critical aspect of our well-being that affects the way we act, think, and feel, and it is often stigmatized and overlooked. According to the world Health Organization, approximately 1 in 4 people worldwide will experience a mental health issue at some point in their life. While mental health is overlooked it leads to the suffering of individuals who are in need of assistance Tragically, suicide is a major concern in relation to mental health. Every year roughly 800,000 people die by suicide, leading it the second leading cause of death of people aged 15-29. Mental health challenges are hard to deal with, and you often feel alone and like you have no support. This is where rehabilitation centers would play the affected role of providing these individuals struggling with their mental health,

with a safe environment and the support and treatment they need to get better. The need for more centers is important because they provide specialized care to help individuals regain their mental well-being and improve their overall quality of life. So, if we have one less of these centers here in Reno, I feel there will be tons of people not getting the help they need when they need it. This would leave individuals to continue feeling lost, scared, and hopeless about their life, because they don't have the resources they need. Individuals needing support should have a safe place to go to where they can openly talk about the things they're struggling with and feel understood rather than judged. They should be able to know that they will have access to centers that will help them get to where they need to be.

**SOLUTION** By focusing on one's mental health as much as their physical health we can promote resilience, improve relationships, and enhance productivity of people's lives. With the statistics of suicide rates that only shows how much more important promoting and educating about mental health should be. As a solution I feel we should have more rehabilitation centers here in Reno to offer our people who are in need, a place to go to where they will receive mental health treatment. These centers should have professionals that can address various aspects of mental health such as therapy for coping skills, medication management for psychiatric conditions, and emotional support. With that being said, if you or someone you know is struggling with mental health, don't be afraid to reach out to family, friends, teachers or professionals for support. Thank you for your time.







Nevada Small Business Development Center
