**Subject:** Ordinance Introduction - Bill No. \_\_\_\_\_ (For Possible Action): Ordinance to repeal Title 8, Chapter 8.12 “Offenses Against Public Peace,” Section 8.12.012 of the Reno Municipal Code entitled “Prohibition Against Sitting or Lying in Doorways; Penalty,” and Title 8, Chapter 8.12 “Offenses Against Public Peace,” Section 8.12.015 of the Reno Municipal Code entitled “Sitting or Lying Down on Public Sidewalks in the Downtown Reno Regional Center” and Title 8, Chapter 8.12 “Offenses Against Public Peace,” Section 8.12.030 of the Reno Municipal Code entitled “Camping on Public Property in the Truckee River Corridor”; together with other matters properly relating thereto.

**Summary:**

Staff is recommending an ordinance to repeal portions of the Reno Municipal Code (RMC), as listed in the staff report title. These portions of the RMC are being replaced by the updated Title 8, Chapter 8.12 “Offenses Against Public Peace,” Section 8.12.011 entitled “Sitting, lying, sleeping or camping on a public place including but not limited to sidewalks, streets, alleys, sensitive areas or within doorways prohibited.” Leaving the old laws on the books would create redundancy and confusion for the general public.

**Previous Council Action:**

There is no recent Council action relevant to this item.

**Discussion:**

The proposed ordinance pertains to repealing Reno Municipal Codes in Title 8, Chapter 8.12 “Offenses Against Public Peace,” Sections 8.12.012 entitled “Prohibition Against Sitting or Lying in Doorways; Penalty,” 8.12.015 entitled “Sitting or Lying Down on Public Sidewalks in the Downtown Reno Regional Center” and 8.12.030 “Camping on Public Property in the Truckee River Corridor” due to the fact they are being replaced by a new ordinance in Title 8, Chapter 8.12 “Offenses Against Public Peace,” Section 8.12.011 entitled “Sitting, lying, sleeping or camping on a public place including but not limited to sidewalks, streets, alleys, sensitive areas or within doorways prohibited.” The new law addresses all the same issues in one concise ordinance. The new law still bans sitting in doorways, sitting or lying on public sidewalks and camping along the Truckee River. Upon passage of the new law these laws become redundant in the Reno Municipal Code. Staff is recommending repeal of these ordinances to better assist the general public in understanding what is a violation of code and to eliminate any potential conflicts in the law.
