I am writing to SUPPORT the adoption of a moratorium and the initiation of a text amendment for data centers as proposed in agenda item D.2. I encourage the City Council to consider the impacts of data centers on our local economy and environment. Economically, it is critical that we prevent out-of-state companies from building and housing data centers in Reno and, instead, encourage local businesses to build centers here. Local companies are more likely to hire Reno native workers full-time and as contractors and are more likely to care about the environmental impact of the centers where they live. Additionally, the Council should consider amending property tax laws that allow data centers a 75% tax abatement if they hire 10 Reno natives over the first 5 years of operations. Hiring only 10

Reno locals is not enough to justify the cost of losing 75% of tax revenue and allowing data centers to only pay 25% of taxes owed. As for environmental considerations, we must ensure that data centers are regulated to be as GREEN and sustainable as possible. Firstly, we cannot allow data centers to rely on fossil fuels but instead encourage the use of renewable solar energy or geothermal energy, which are both good fits for our area and natural resources. We should also call on data centers to install their own energy sources instead of pulling electricity from the existing grid, which will increase costs for Reno locals. Data centers should also avoid water-cooling methods (which are banned in Las Vegas), as Reno is a water-scarce environment, and these methods will only strain water conservation and negatively impact local plants, animals, and people. Lastly, we should ensure noise abatement procedures are put in place to mitigate noise pollution and also implement very strict cradle-to-grave requirements for data centers to handle and recycle their e-waste.

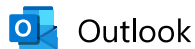

I am writing to SUPPORT the adoption of a moratorium on data centers as proposed in agenda item D.2. As a professional environmental consultant, I want to encourage the City Council to consider the environmental impacts of data centers before allowing more to be built. There are important things to factor into allowing data centers to consume our resources. For example, Reno is a drought-prone area but we can generate solar power extremely well given our sunny locale. Data centers therefore should not be allowed to use any form of evaporative cooling, which loses water to the atmosphere and which has been banned in Las Vegas. Instead, more energy-intensive and no-water options should be considered for the data centers that come to Reno since their energy consumption can be

supplemented with solar power. Data centers need to bring their own energy solutions when applying for approval in Reno. This energy should be GREEN in the form of geothermal or solar power to help ease their impact on local power grids. There should also be very strict cradle-to-grave responsibility placed on the data center operators for handling and recycling e-waste. Noise abatement will be essential for minimizing the data center's impact on local communities. Their near-constant need for cooling produces noise in the form of fans and other pumps. Finally, the city council members should be wary of developers equating a large number of plants on site with sustainability. In many cases, especially in north valleys, more TREES will do nothing but expedite the desertification of the area and require MORE water to be consumed by the project. The trees will steal nutrients and water from the native grasses, ultimately pushing the sagebrush out of the area and leaving the soil sandy and inhospitable. There is no guidance from the state on data centers, and I don't think any will come. We need to get ahead of these important issues before we have a disaster on our hands, and the council's pursuit of answers will be a massive step in the right direction.

I am writing in support of a text amendment involving data centers with respect to Commissioner Becerras's Data Center Moratorium. Data centers are an extremely complex issue that the city of Reno is not yet ready to take on without first looking long term into their economics (or lack thereof) and harmful impacts to our natural environment including tapping into one of our valuable nonrenewable resources, water. I am not opposed to data centers in any way, shape, or form. I am however, opposed to inviting these data centers into our precious city unregulated without bringing proper jobs to citizens and often receiving up to 75% tax abatements that do not assist in providing to our local economy. I have seen what has happened to our state in places like Vegas where we have had to

I am writing to urge the Reno City Council to put a moratorium on data center development until the City can fully assess the economic impacts and assure the public that there is a net economic benefit. Having read the Staff Report for item D.2, It's clear to me that deeper analysis is required. Data centers do not provide a significant number of new jobs once the construction phase is completed. So any growth in jobs is temporary. Data centers require a huge amount of electricity. According to NVE's CEO during an interview on Nevada Newsmakers, the electricity demand "...could double, triple, even quadruple the size of the total electric grid in Northern Nevada". The electricity grid is already so strained that Nevada needs two new gas peaker plants, according to the current Integrated Resources

Plan. An expansion of data centers in Nevada will increase electricity demand, which will increase the need for infrastructure, which is paid for by electricity rate payers. So the net benefit so far is negative with very few jobs and higher electricity rates. Theoretically, there could be increased revenue for the state and local governments. But I understand there will be a 75% property tax abatement and greatly reduced sales tax. This defies logic, especially at a time when the City is struggling with lower than projected revenues and inflation is driving up costs. Subsidizing ownership of data centers through tax breaks amounts to corporate welfare. This is a misuse of public funds and public trust. Lastly, The Reno City Council voted unanimously in favor of adopting their Sustainability and Climate Action Plan in 2019. What impact will data centers have on the City's ability to meet the sustainability goals outlined in that plan? The City is already falling short of those goals. An influx of data centers will only exacerbate this trend. This voter is not at all convinced that data centers are good for Reno. I urge you to take the time to fully assess the impacts of data centers and find a way to make this a win-win situation

I am writing to SUPPORT the initiation of a text amendment for data centers as proposed in agenda item D.2. I want the City Council to consider the environmental impacts of data centers before allowing more to be built, and I think that there are important things to factor in before allowing data centers to consume our resources. My main concerns are water usage, fire prevention, energy usage, and impact on our high desert. Reno is a drought-prone Area, and I am concerned about the potential for devastating fires such as those seen last summer in south Reno. While those fires were stopped before they hit the dense population within the McCarran circle, the recent Los Angeles fires show that city centers and suburban areas are not necessarily safe from wildfires. I fear that if we allow data

centers to use our water sources, we won't have enough to put out future wildfires. Data centers therefore should not be allowed to use any form of evaporative cooling, which loses water to the atmosphere and which has been banned in Las Vegas. They should commit that all of their energy be in the form of green sources, solar or geothermal. There should also be very strict cradle-to-grave responsibility placed on the data center operators for handling and recycling e-waste.
