### **Summary:**

There are nine (9) vacancies for a Ward 5 Neighborhood Advisory Board (NAB) member and two (2) vacancies for Alternate Members on the Ward 5 NAB. The Clerk's Office received applications from: Gary Cecil (Reappointment), Bryce Chisholm (Reappointment), Warren Lyons, Scott Rahbeck, Elton "Mac" Rossi, and Allen Setterquist.

Gary Cecil and Bryce Chisholm's appointments expired on September 30, 2023. Both Mr. Cecil and Mr. Chisholm are interested in and eligible for reappointment.

The term for appointment for all positions will be from April 1, 2024, through March 31, 2026.

### **Background:**

As indicated in City of Reno Resolution No. 8342, adopted on April 12, 2017, city residency is not required to be a NAB member. Membership terms are two years in duration and members shall not serve more than two terms.

Section 8 states Council may waive term limits in specific instances where membership qualifications are desired or no qualified person has applied for appointment.
