Jewish Nevada is an organization that has openly supported a government that has instituted a regime of ethnic cleansing, military occupation, and apartheid described by many South African survivors of apartheid as being even worse than what was put in place in South Africa. As you all discuss whether to send even more money their way, the country that Jewish Nevada "stands with" is carrying out a genocidal ethnic cleansing that has left tens of thousands of human beings (and many relatives of Reno residents) dead or severely injured or disabled and almost two million people displaced and starving, forced to live in tents on the street at the height of winter. As far as I can tell, Jewish Nevada has not made any statements condemning this or the multitude of Israeli officials and companies that have already begun talking about building homes and establishing settlements in Gaza that are illegal according to international, American, and sometimes even Israeli law. Israeli officials have clearly stated for decades that Palestinians are a "demographic threat" and voting to fund an organization that defends and supports the actions of this government is deeply dehumanizing to not only Palestinians, but all of us who have experienced colonial violence in our recent family histories. Just as people who look the other way and fund companies that supported apartheid South Africa or companies that today support these kinds of horrific

policies should be condemned, so too should people who fund organizations that support the genocidal apartheid state of Israel as it exists today.

In the future, when people look back at this stage of history, they will remember those among us who stood by and supported this horrific violence with contempt. Would you like that to be your legacy? Or would you like to be among those city councils that have done the bare minimum and called for an immediate ceasefire?

While I support the jewish community and the american jewish diaspora, I am completely against the use of taxpayer funds to support Israel and their ongoing genocide against the Palestinian people. I see absolutely no reason why the City of Reno is explicitly giving money to support the cause of an ongoing genocide in another continent, which has little to no business with our city. Israel is a deeply racist apartheid state which exists exclusively through the theft of Palestinian land and resources. Over 23,000 Palestinians have died and hundreds of thousands more have been forcibly displaced, starved, and dispossessed in the last two months. There is no reason we should be supporting this extreme, ongoing violation of human rights. If you want to support the jewish cause in the United States, please consider donating to anti-zionist jewish organizations instead (I promise they exist if you take 5 seconds to google them).
