Dear planners,

Another three quality of life issues that kinda get addressed, but please take a moment to listen to the sound in the valley and look at the night views while in the valley. The water for the well to the original section is on your land and we absolutely do want to change to tmwa.

Go sit in quiet near blackbird and sandpiper on a good acoustic night, like one last week. You can hear conversations blocks away. I have heard kids at the skate park. Not the words, but the general back and forth, the wheels on concrete. The laughs, the busses.

We have already heard the sound effects of fencing both sides of village pkwy. It is a concentrated volume of sound from normal traffic. The amount of traffic is fine. That's really why you bought so far out now, wasn't it.

Back to the lights. Now that there is a large volume of lights, and the fact they are a higher elevation has created a weird glow at times.

So now you are back by blackbird. Can you find the way to reno? Look to the peavine antennas, then down and left a bit. Yes, that bright glow is reno. So don't let Redrock make it worse please.

Well it is 432 am and I get to take a neighbor over to Spanish Springs to the dentist in a few hours. Do I begrudge that? No. Cold springs is too far out for that. Stead and lemmon are close enough. I have reached out to all the local high schools, principals, youth organizations, etc. I have given flyers to all the schools, and I have asked you and the other 2 members to assist me in recruiting your friends. Despite all these efforts, I am still sitting at 3 members.

Now, to address your statements on our level of "care" for youth. I recommend looking into the city's youth department and seeing all the amazing programs we run for our local youth. My entire job, which I do as an Americorp volunteer, is working with youth in our Sierra Kids program. In my department, our entire focus every hour of every day is on the local youth in the Washoe County School District. I work tirelessly to design and orchestrate fun and educational programs for Sierra Kids, especially underserved children. It's insulting to tell me that I don't care about local youth. That is what I do day in and day out.

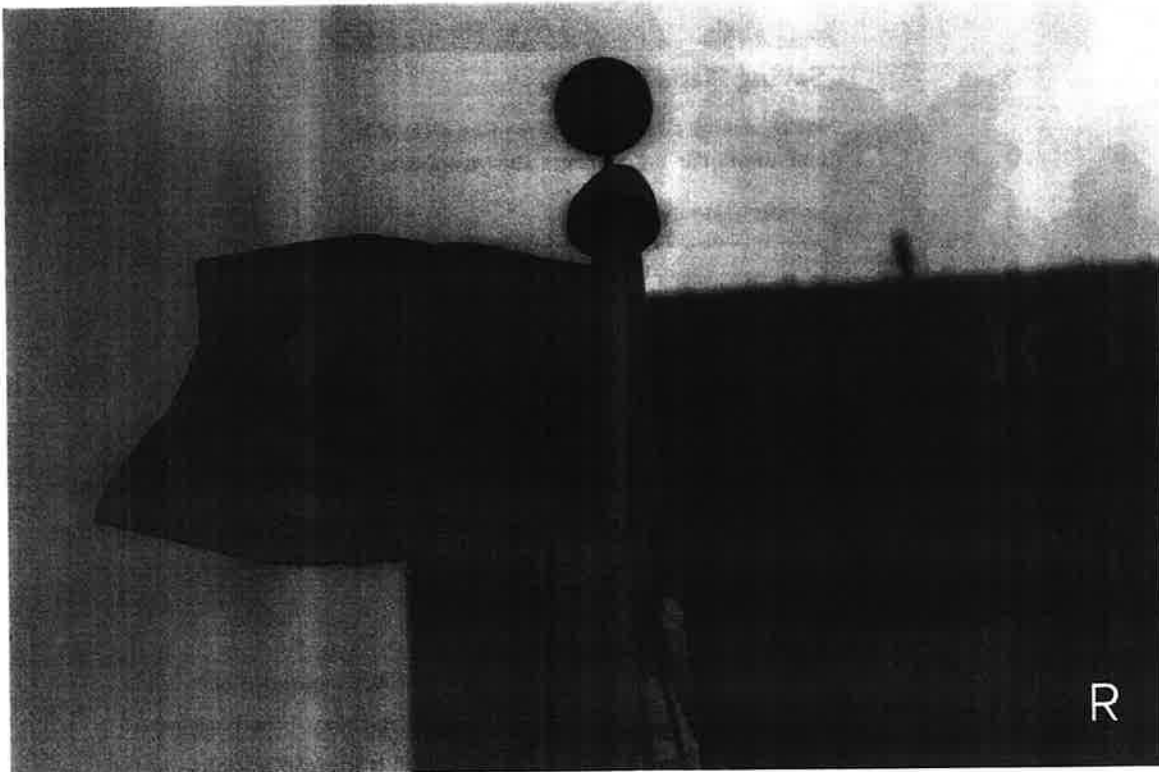

I reached out again to Councilman Reese in June of 2021 – then a sophomore – and was referred to city staff who referred me to another city staff. This process took until September.

In September, I met virtually with the city staff member I was referred to. The interview went great; the staff was kind, considerate, and answered all my questions. He went on to tell me that it would be beneficial for me to recruit members myself. However, no forward progress was made in getting the council restarted.

After my attempts at recruiting, I reached out again in February 2022. I stated that I was beginning to lose faith that the city cares about youth, and I inquired about the barriers to continuing the YCC. Council member Reese said, “we are back on track and it looks like YCC will be restarted soon.”

Immediately after that, I received a snarky email from the city staff, where the staff member was unhinged and angry. He stated “if you send me applications from 6 of your friends, I’d be happy to start YCC ASAP. Until then, my hands are tied.”

Seriously? A city staff member is placing the burden of recruiting on a high school student in a competitive medical academy?


It is now October 2022. I am a junior in high school, and it has been almost two years since I applied. While many boards and commissions have continued to meet uninterrupted, the YCC has come to a complete halt.

## Timeline of events

12/7/2020 applied online for the Youth City Council (confirmation received) FRESHMAN AT AACT

2/25/2021: Wrote an email to Councilman Reese inquiring about the YCC. Councilman Reese responded that the YCC had not met for a year but to submit a resume and letter of interest and he would “see if we can get moving.” (These items had already been submitted through the online portal)

6/15/2021: Emailed Councilman Reese again after updating information through the online portal since I was now a sophomore at AACT. I asked for help understanding the process for nomination and if meetings were taking place yet. Councilman Reese connected me to Kathy Kelly-Ballinger who said she would start working on the YCC applications.

6/15/2021 submitted application again (confirmation received)

8/27/2021: I again emailed Ms. Kelly-Ballinger and Councilman Reese to inquire about the status.

8/30/2021: Ms. Kelly-Ballinger responded that a new employee would be starting 8/31/2021 and would be working on getting YCC up and running again soon. She stated, “we will be in touch soon, I promise.”

9/13/2021: Ms. Kelly-Ballinger reached out to let me know that Brendan Andre would be in touch soon and provided contact information.

I am not sure of the date, but Brendan did reach out to me and we had a phone interview for a YCC position.

11/22/2021: I reached out again to Brendan, cc’ing Councilman Reese, to follow up on the status of my application

11/23/2021: Brendan responded to say that he only had 3 members (including me) and needed to have 9 members. He stated that he needed help with recruiting and would “look to get this up and running after Thanksgiving.”

12/1/21: I reached out to Brendan requesting flyers.

2/16/22?: I reached out to Brendan and expressed my frustration that this process has taken so long and still nothing was happening. I expressed that it felt like the City of Reno did not really care about youth.

2/16/22: I received a truly disrespectful, unprofessional, and frankly horrific response from a City employee to a 15 year old high school sophomore (attachments). I cc’d both Councilman Reese and Mayor Schieve but no one reached out to even apologize for this staff member’s behavior.

10/3/2022: I published an op-ed in *This is Reno* (attached).

This is dangerous for the humans and it's dangerous for the horses. As an example, I was backing out of my garage one evening, and as I was swinging around to the street, there were 3 horses standing there. They are almost invisible and I came very close to hitting one. Our streets and yards are covered in horse droppings. This isn't pretty and it isn't hygienic. There is a small county park in our neighborhood (Bailey Creek Park). The horses either jump the fence or people are letting them in. I've seen up to 15 horses inside the park, and once they're in, they can't get out unless they jump the fence. They cover the grass in their droppings, it is very bad. There is less than a yard between the droppings, and the entire park is covered. It takes 2 park workers an entire day to clean it up. This is a terrible waste of time and money. The problem is only going to get worse. I respectfully ask that you please provide the funds to finish the fence. We really need this.
