

**RESOLUTION DONATING COUNCIL DISCRETIONARY FUNDS TO
SIERRA NEVADA JOURNEYS, GIRLS IN STEM, IN SUPPORT OF
THEIR MISSION TO DELIVER SCIENCE-BASED EDUCATION
PROGRAMS TO DEVELOP CRITICAL THINKING SKILLS TO
STUDENTS IN WARD 3 IN THE AMOUNT OF \$3,500 (GENERAL FUND)**

WHEREAS, the City of Reno may donate funds in accordance with NRS 268.028(01), entitled “Expenditure of public money; grant of public money and donation of certain property to certain nonprofit organizations or governmental entities” when such expenditure provides a substantial benefit to the inhabitants of the City; and,

WHEREAS, Sierra Nevada Journeys, a 501 (c) (3) nonprofit organization dedicated to delivering science-based education programs to develop critical thinking skills and inspire natural resource stewardship; and,

WHEREAS, Sierra Nevada Journeys operates with the vision to transform lives by building curiosity, confidence, and connections to nature, especially for student who are traditionally underserved; and,

WHEREAS, Sierra Nevada Journeys believe that outdoor science education is not just a luxury, which is why 72% of the students served come from low-income families and 70% are students of color; and,

WHEREAS, Sierra Nevada Journeys offers specialty camps such as Girls in STEM designed for girls, including transgender, genderqueer and nonbinary students from Nevada; and,

WHEREAS, Sierra Nevada Journeys, Girls in STEM is designed for students from low-income families and will use the funds provided to help support students from Ward 3 within the City of Reno; and,

WHEREAS, this donation will help fund registrations, accommodations, meals, and programming for Ward 3 students in the program; and,

NOW, THEREFORE BE IT RESOLVED that the City of Reno approves the Council donation from Councilmember Martinez in the sum of Four Thousand Five Hundred Dollars (\$4,500) to Sierra Nevada Journeys, Girls in STEM; and,

BE IT FURTHER RESOLVED, that should the above donation or any portion thereof not be used for the purpose as set forth in this Resolution, any unused funds shall be returned to the City of Reno.
