**RESOLUTION TO AUGMENT THE BUDGET OF THE CITY OF RENO,  
REDEVELOPMENT AGENCY #1 FOR THE 2024/2025 FISCAL YEAR;  
AND APPROVAL OF BUDGET REVISIONS FOR THE PERIOD OF  
JULY 1, 2024 THROUGH DECEMBER 31, 2024.**

**WHEREAS**, the resources of certain funds of the City of Reno, Redevelopment Agency #1, County of Washoe, State of Nevada, were budgeted to be the following on July 1, 2024:

RDA #1 General Fund	\$3,094,346
RDA #1 Debt Service Fund	\$5,914,851

**WHEREAS**, the resources of certain funds are now determined to be as follows:

RDA #1 Debt Service Fund	\$6,998,678

**WHEREAS**, said resources are as follows:

**WHEREAS**, there is a need to apply these excess proceeds in the above funds; and

**NOW THEREFORE, BE IT RESOLVED THAT:**

- Section 1: The Redevelopment Agency Board of the City of Reno, Redevelopment Agency #1 shall augment its 2024/2025 budget by appropriating \$69,755 in the RDA #1 General Fund, thereby increasing its appropriations from \$3,094,346 to \$3,164,101 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
  
- Section 2: The Redevelopment Agency Board of the City of Reno, Redevelopment Agency #1 shall augment its 2024/2025 budget by appropriating \$1,083,827 in the RDA #1 Debt Service Fund, thereby increasing its appropriations from \$5,914,851 to \$6,998,678 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
  
- Section 3: That staff is hereby directed to file said augmentations with the Department of Taxation, State of Nevada.
