**RESOLUTION TO AUGMENT THE BUDGET OF THE CITY OF RENO,  
NEVADA FOR THE 2023/2024 FISCAL YEAR; AND APPROVAL OF  
BUDGET REVISIONS FOR THE PERIOD OF JULY 1, 2023  
THROUGH SEPTEMBER 30, 2023.**

**NOW THEREFORE, BE IT RESOLVED THAT:**

Section 1: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$12,364,832 in the General Fund, thereby increasing its appropriations from \$336,722,394 to \$349,087,226 a detailed schedule is attached to this Resolution and by reference is made a part hereof.

Section 2: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$1,614,384 in the HUD and State Housing Funds, thereby

increasing its appropriations from \$5,884,018 to \$7,498,402 a detailed schedule is attached to this Resolution and by reference is made a part hereof.

- Section 3: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$831,965 in the Community Assistance Fund, thereby increasing its appropriations from \$3,473,000 to \$4,304,965 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 4: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$456,733 in the Street Fund, thereby increasing its appropriations from \$67,740,079 to \$68,196,812 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 5: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$4,697,684 in the Performance Deposit Fund, thereby increasing its appropriations from \$1,050,000 to \$5,747,684 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 6: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$1,266 in the Drainage Facility Impact Fee Fund, thereby increasing its appropriations from \$500,000 to \$501,266 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 7: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$40,694 in the Stabilization Fund, thereby increasing its appropriations from \$2,980,488 to \$3,021,182 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 8: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$1,517,383 in the Court Special Revenue Funds, thereby increasing its appropriations from \$251,000 to \$1,768,383 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 9: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$1,262,419 in the Drug Forfeiture Fund, thereby increasing its appropriations from \$265,474 to \$1,527,893 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 10: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$425,150 in the Opioid Recoveries Fund, thereby increasing its appropriations from \$0 to \$425,150 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 11: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$8,074 in the Debt Service Fund, thereby increasing its appropriations from \$5,955,816 to \$5,963,890 a detailed schedule is attached to

this Resolution and by reference is made a part hereof.

- Section 12: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$22,930 in the Cabela's Sales Tax Bond Fund, thereby increasing its appropriations from (\$14,151,452) to (\$14,128,522) a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 13: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$67,353 in the Railroad Debt Fund, thereby increasing its appropriations from \$46,363,018 to \$46,430,371 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 14: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$209,952 in the SAD Debt Service Funds, thereby increasing its appropriations from \$2,436,618 to \$2,646,570 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 15: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$18,451,545 in the General Capital Project Fund, thereby increasing its appropriations from \$95,036,327 to \$113,487,872 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 16: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$2,637,891 in the Room Surcharge Capital Project Fund, thereby increasing its appropriations from \$1,045,571 to \$3,683,462 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 17: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$7,734 in the Event Center Capital Project Fund, thereby increasing its appropriations from \$511,775 to \$519,509 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 18: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$26,862 in the Bond Capital Project Fund, thereby increasing its appropriations from \$0 to \$26,862 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 19: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$1,516,226 in the Park District Capital Project Fund, thereby increasing its appropriations from \$14,211,803 to \$15,728,029 a detailed schedule is attached to this Resolution and by reference is made a part hereof.
- Section 20: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$186,999 in the Capital Tax Fund, thereby increasing its appropriations from \$1,822,449 to \$2,009,448 a detailed schedule is attached to this Resolution and by reference is made a part hereof.

Section 21: The City Council of the City of Reno, Nevada shall augment its 2023/2024 budget by appropriating \$27,790 in the Street Bond Fund, thereby increasing its appropriations from \$0 to \$27,790 a detailed schedule is attached to this Resolution and by reference is made a part hereof.

Section 22: That staff is hereby directed to file said augmentations with the Department of Taxation, State of Nevada.
