Reno City Council, City Manager and Parks and Recreation Director,

I am writing to express serious concerns about the currently proposed locker rooms at the new Moana Springs Pool. These concerns are rooted both in my experience of being a lifelong swimmer in northern Nevada, but also as professional experience being an active organizer and official for swim meets.

As a lifelong swimmer I have represented Reno at swim meets throughout Nevada, California, Washington, Texas, and Florida. I have seen close to 100 pools and their locker rooms. From personal experience I would be horrified if I were asked to change in the proposed locker rooms. It is wholly inappropriate for a designated changing area having open view lines to a front lobby, Lifeguard stations, and the pool deck in general as it is currently laid out on the construction drawings. Changing into and out of swimsuits, especially at large/competitive meets that require skin-tight swim suits is no trivial task. I, personally, have spent upwards of a half an hour changing into so-called 'tech suits' at these meets - the entire time with my buttocks and genitals in full view of anyone or everyone with sightlines into the locker rooms. For females it is much more time-intensive and exposing. The time that it takes and the exposure it requires to put these types of suits on requires privacy in gender assigned changing/locker rooms.

Beyond my personal reservations as a lifelong swimmer looking at these plans, I have professional objections to these proposed plans because I believe that these plans stand against rules and regulations of the two organizations that already have plans to host large swim meets in this location. As background, I have 10 years' experience as the Meet Director for the University of Nevada-Reno Women's swim team, Three Years' experience as the head scorer for the NIAA northern High School swimming, and have been running swim meets in similar regards for Reno Aquatic Club for over a decade. In order to run swim meets in this fashion I have had to read the rules and regulations to create safe spaces for these meets to take place. Both USA Swimming and the NIAA both have language relating to privacy around locker rooms that I want to bring to your attention.

The first rule that I want to bring to your attention is USA Swimming's strict rule against deck changing. The intent of this rule is to keep swimmers from changing in public spaces and not in view of the public, other athletes of the opposing gender, or in any other fashion where an athlete's short or long term privacy is violated. The current layout of the locker rooms, which is the standard place that athletes use as changing rooms, requires athletes to be changing with direct lines of sight into the lobby, Lifeguard front office, as well as in front of windows out onto the pool deck. Additionally there is no privacy barrier between the designated male and female locker spaces. As a result the argument can be made that there is no feasible place available for athletes to not "deck change" and as a result USA Swimming may bar this pool from hosting any swim meets, along with the possibility that an argument being made that no athletic activities (including daily swim practice) may not be allowed to take place at this pool. Similarly language from the USA swimming Safe Sport Handbook (included as an attachment) that tends to agree with the above conclusion is as follows:

- There are guidelines to "Maintain personal privacy as well as reduce the risk of misconduct in locker rooms and changing areas"
- "We discourage parents from entering locker rooms and changing areas unless it is truly necessary. In those instances, it should only be a same-sex parent."
 - This language reinforces that changing areas need to be private and gender separate.

Another point of concern with the current layout of the locker rooms is that there is the possibility of currently planned or even future installation of security cameras that may partially or wholly see these changing areas. It is really common for lobbies of athletic venues to have some sort of security cameras to ensure safety of the public as well as the people that staff the venue. These locker rooms as currently proposed have no wall creating a barrier between the areas that are commonly video recorded and where the locker rooms are. Per USA swimming Article 305.3 "Use of audio or visual recording devices are not allowed in changing areas, restrooms, or locker rooms".

One of many rules that could come into question of these locker rooms from the NIAA (the Nevada high school athletics association) is the requirement that "locker rooms are secure" - NIAA Silver rules for hosting an athletic event. The locker rooms as proposed are anything but secure by virtue that they are completely open to the public. There are no walls - let alone doors - preventing the public at large to simply walk into the changing areas and be nuisances or worse to athletes, many of whom are underage.

In my professional opinion as someone who routinely organizes and hosts swim meets, the Moana Springs facilities' locker rooms are an extreme privacy concern. These privacy concerns are likely to leave the pool and the City as a whole at risk of financial loss if major organizations, such as USA Swimming or the NIAA, decide it is against their best interests to host events or even daily activities at this pool. The worst case scenario is leaving the pool and the City at risk of lawsuits for not providing adequate privacy to athletes (including underage ones) to change into and out of swimsuits.

I do want to make clear that these concerns and suggestions are my own. I have not talked to employers at the University, the NIAA, or to USA swimming about my concerns about these plans and as such none of them have endorsed any of my beliefs stated above.

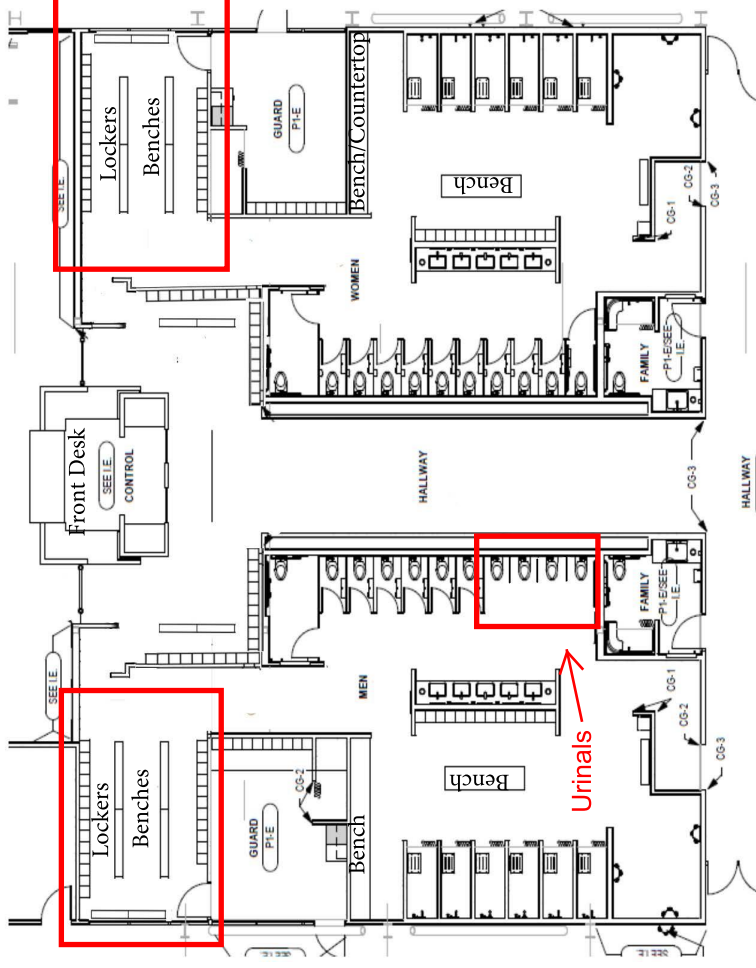

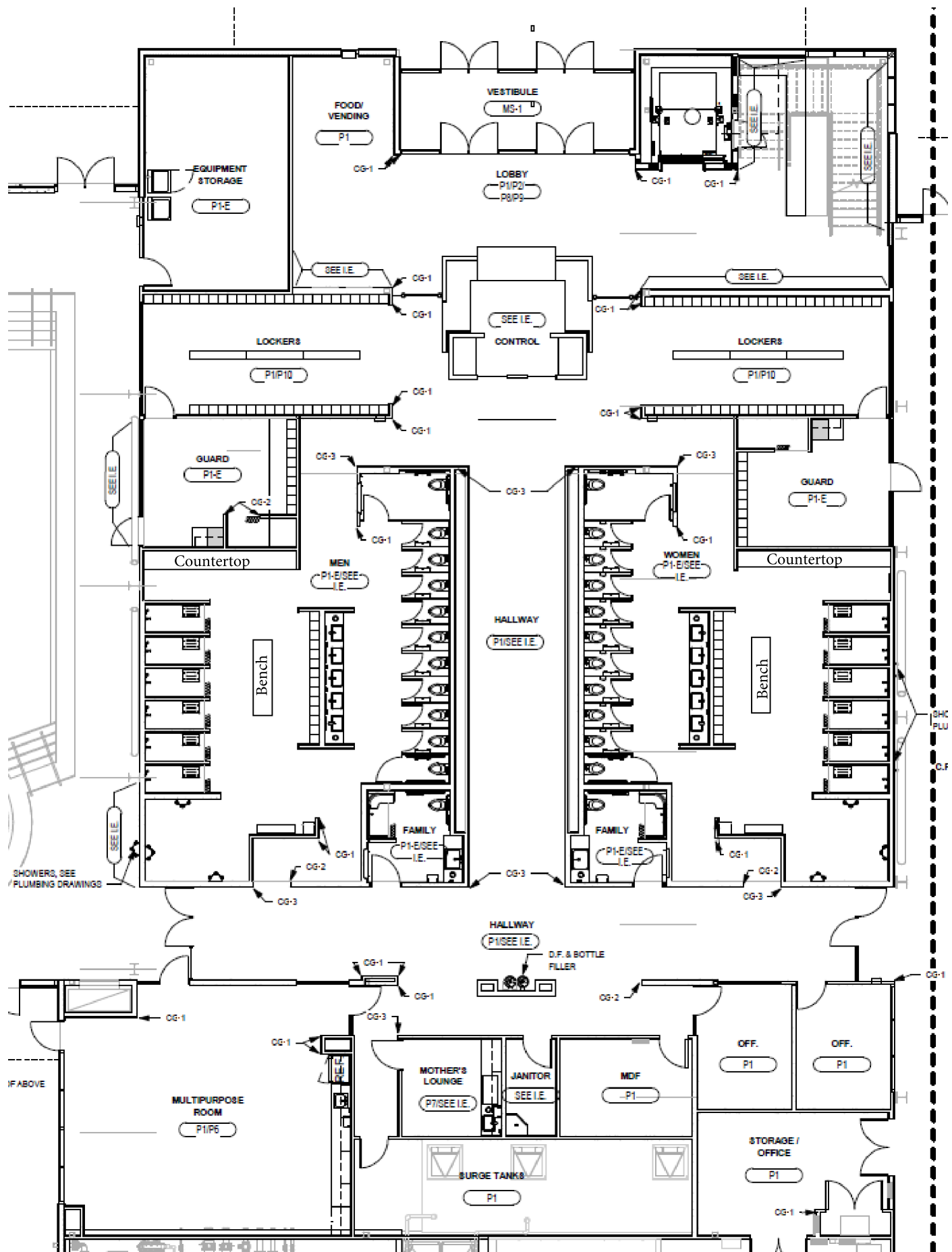

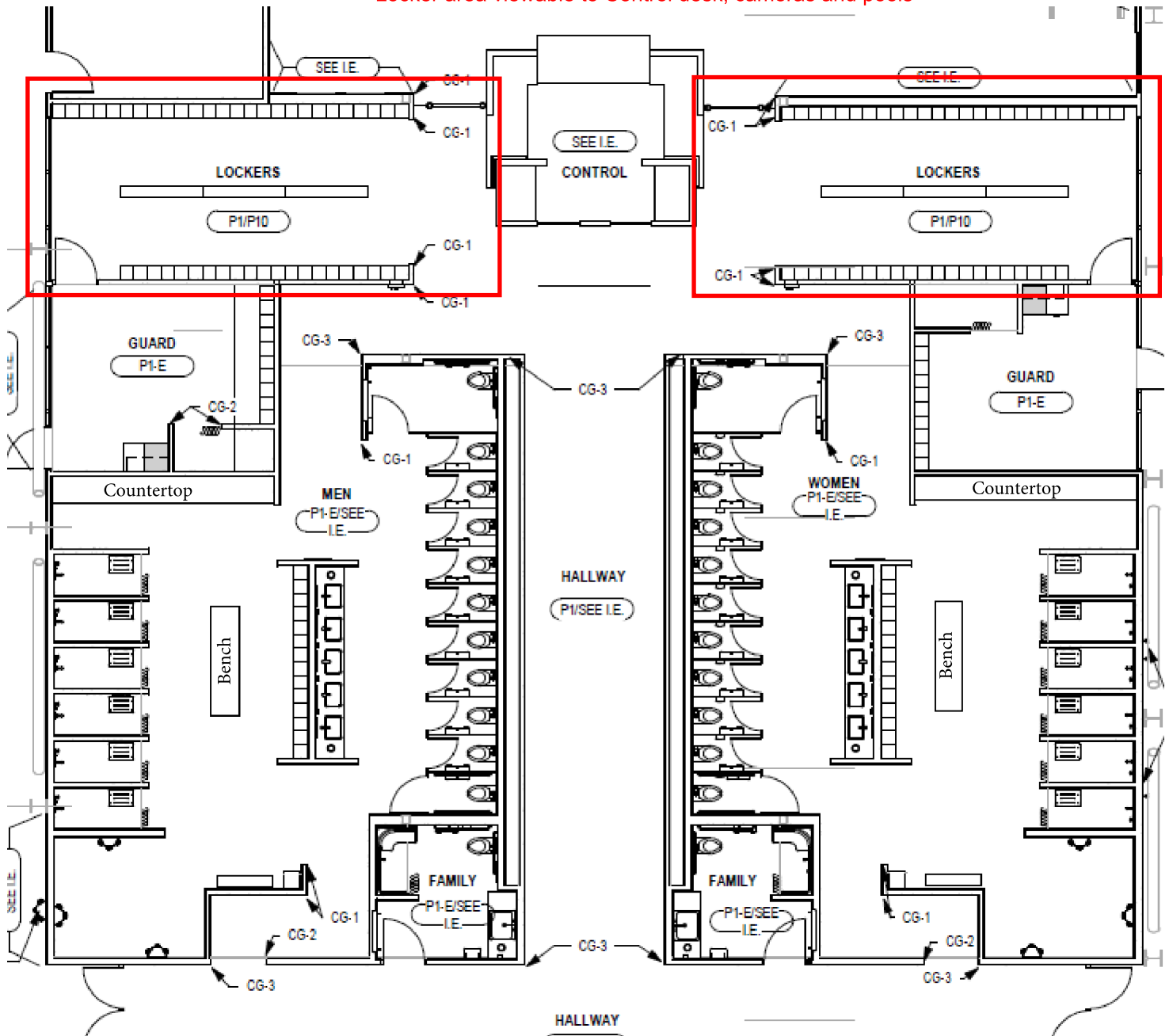

Central building core and locker room areas as designed and under construction



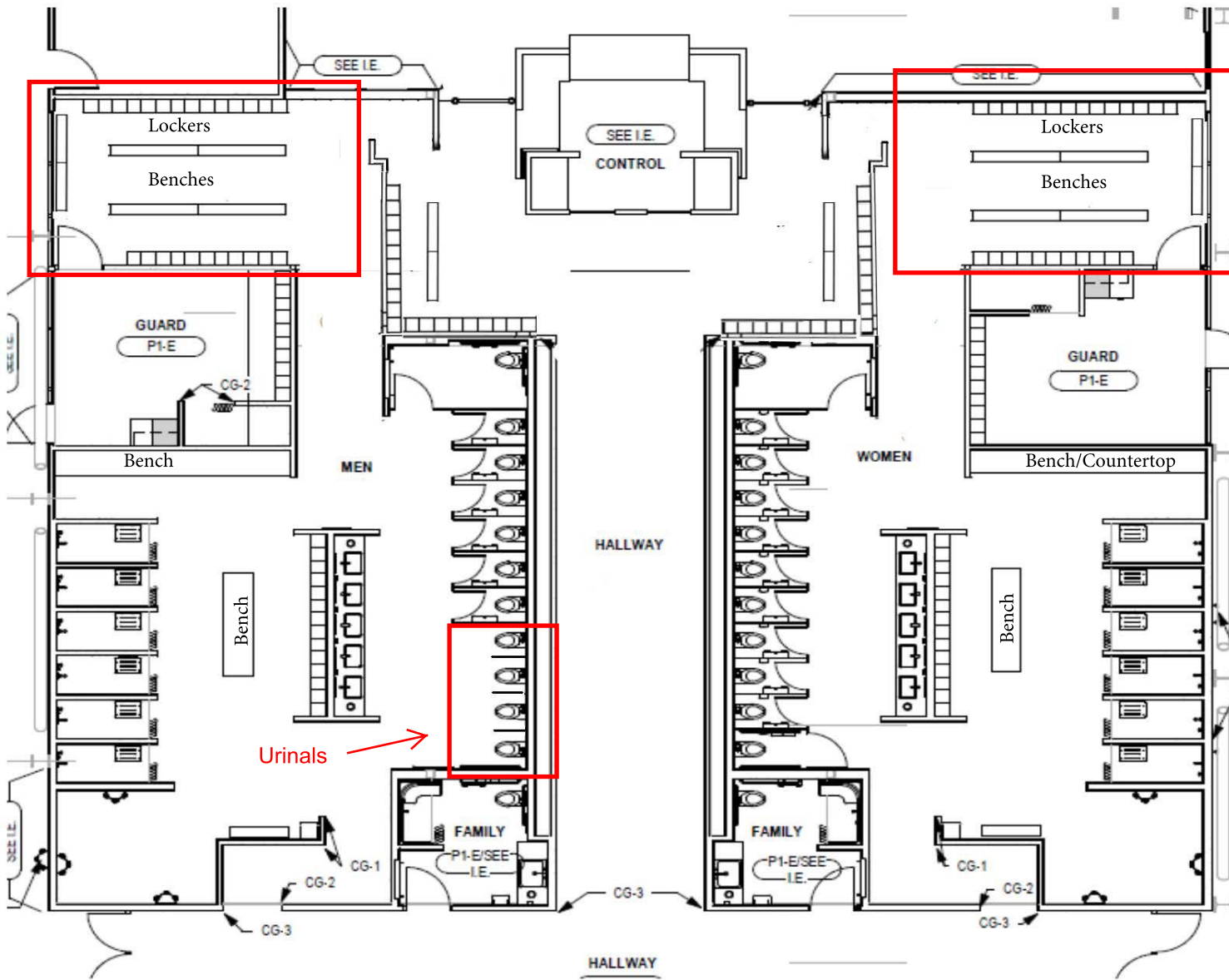
Moana Springs - Locker room area as designed with "viewable" locker area

The Stormwater Utility Fee is ill-conceived, as it is designed to generate revenues for the City to replace several downtown bridges -- bridges which are the responsibility of the Regional Transportation Commission and are already funded via Road taxes.

Further, a fee of this magnitude should have been properly noticed to residents. Some business owners received postcard notifications, while residents did not. Yet residents will be paying the fee. It would be appropriate for the City to vote down the fee at this meeting, then reschedule the item for a future meeting AFTER the City has appropriately and TRANSPARENTLY notified the affected residents (i.e., all property owners, not just commercial property owners).

A delay in adopting the ordinance creating the fee will also give the City time to properly determine the costs which the fee is to cover, i.e., exclude costs which are already covered by the RTC. This would allow an appropriate and realistic fee to be established.

There are also equity issues with respect to how the fee for a particular parcel of land is assessed the fee. There currently does not appear to be a mechanism to adjust the fee for the amount of pervious land on a parcel to which stormwater can be directed, such that it doesn't flow into the stormwater system. As it currently is proposed, a high school will pay the same fee as a similarly-sized Wal-Mart -- nearly all the Wal-Mart stormwater will be funneled into to the stormwater system, whereas the high school's stormwater will be absorbed in its athletic fields and other pervious land. This issue applies to residential properties as well. These inequities need to be resolved before the fee is implemented; otherwise, the revenue generated by the fee will get eaten up in legal fees defending an ill-conceived and poorly designed plan. That is poor management of the residents' and business' money.
