**Summary:**

On November 27, 2023, the Reno Arts and Culture Commission (RACC) reviewed the Grant Committee of the RACC's ranking and scoring of 25 Arts and Culture Project Grant applications for 2024. The RACC recommended funding of 18 Arts and Culture Project Grants based on scoring in the amount of \$98,358. Staff recommends Council adoption of a Resolution and approval of the agreements to allocate \$98,358 to 18 nonprofit arts and culture organizations for purposes described below.

**Background:**

The Grants Committee of the RACC met on November 2, 2023, to score and rank 25 Arts and Culture Project Grant applications. Projects, community festivals, special performances, exhibitions, and other events may benefit all area residents but must be of definable benefit to Reno residents. A performance, exhibit, or other activity must take place within Reno's city limits. If a project involves activities in a variety of areas, the portion taking place in Reno, or of primary benefit to Reno residents, will be the portion eligible for consideration. A 1:1 cash match of requested grant funds is required.

Each organization will sign an individual agreement and an affirmation of nonprofit status for the project. Copies of the standard agreements are attached. The University of Nevada, Reno's agreement includes slightly different language in a few sections to address their status as a State Agency and to disallow expenses such as staff salaries and facility charges. The City Attorney's Office has approved the agreements and affirmation.

#### **Discussion:**

This is an annual grants program undertaken by the RACC on behalf of the City. On November 27, 2023, the RACC reviewed the recommendation of the Grants Committee which had reviewed 25 grant applications. The 7 grants that scored below 70% were not recommended for funding.

These Project Grants provide funding for organizations to produce programming with a focus on Arts Access and Youth. Three years ago, the RACC initiated diversity, equity, and inclusion (DEI) requirements into their grants to reach a larger constituent base by encouraging partnerships, innovative programming, and attracting new groups to apply. This initial push for DEI requirements was accompanied by workshops for grantees and applicants led by an outside facilitator to help organizations implement DEI initiatives into their programming. The RACC continued to add DEI requirements over the last few years and, this year, added requirements for accessibility.

#### **Financial Implications:**

The Arts and Culture Project Grants in the amount of \$98,358 are included in the FY23/24 budget. The entire amount comes from the Room Tax allocation to the RACC. Grant agreements state they are subject to final Council approval of the agreement and contain a Funding Out paragraph to provide additional financial flexibility to the City.

#### **Legal Implications:**

Legal review completed for compliance with City procedures and Nevada law.

#### **Recommendation:**
